Donations on behalf of Freddie's Wish are approved by the Trustees

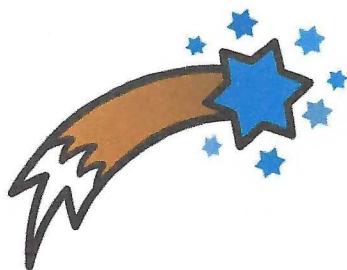
Our Aims

- **Preservation and protection of good health among parents and families experiencing child bereavement.**
- **To advance the saving of lives by educating the public about paediatric first aid and in turn enabling parents with the skills to potentially save their child's life.**
- **To advance the education of Healthcare professionals in relation to child bereavement and to offer support to families within Warwickshire.**

Public Benefit

The trustees have regard to the guidance issues by the Charity Commission on public benefit.

Main Activities and Their Impact

The charity has benefitted the public by delivering paediatric first aid courses to parents/carers training just over 300 people and providing training for 6 schools in first aid. Therefore, enabling the public to be educated to save their child's life should they need to.

We also continued to develop our bereavement counselling service, supporting parents who have lost a baby or child, supporting 13 parents through this year. In addition, our partnership with GriefChat has been testament to providing instant signposting to parent's moments after their loss when counselling wouldn't be suitable.

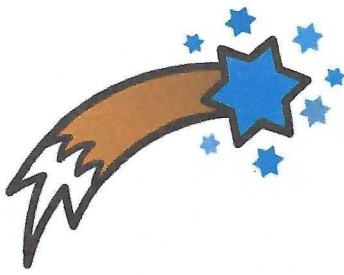
Our bereavement service as a whole has taken a huge strain off the NHS waiting lists for support and the mental health teams within the NHS too with all main hospitals across Coventry and Warwickshire signposting to our service. Unfortunately, the demand for this support and the lack of resources have demonstrated the need for this service to continue to be grown by the charity.

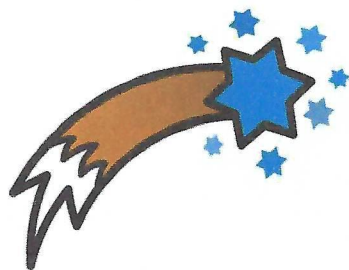
- 9 First Aid training courses were delivered online to parents/carers, training approximately 315 people
- A 40th Anniversary Grange Hill event was organised in London and raised just shy of £1,400.
- 150 people took part on our annual donut day on the 7th December, posting selfies promoting the charity.
- We received a donation from another local charity Hannah's House
- A grant was given to Remember Rufus to fund 5 Cuddle Cots.
- A grant was given to Our Jay Foundation to fund 5 Automated External Defibrillators.
- We were supported by some local businesses, including the baby barn who took part in the Wolf Run raising £500 for us.
- Charlotte was contacted by motherhood edit to write a piece about life after loss
- Charlotte was chosen to carry the queen's baton relay through Rugby for the Queen's Commonwealth Games
- 6 schools trained in first aid by MDD first aid thanks to a donation by Balsall Common Lions
- Sands United Kent organised a football game where we were a beneficiary
- We received an incredible donation of £12k from Rainsbrook Crematorium
- We received another wonderful donation of £2.5k from O'Briens Charitable Trust
- Charlotte stood down as a trustee, to work for the charity to aid its growth
- We took on our second bereavement counsellor, Kaye.
- We received our first legacy for an amazing £10k

Financial Review

During the year ended 05 May 2023 the Charity received £32,893 by way of donations, fundraising activities and first aid courses. The Charity spent £25,286 in pursuit of the Charity's objectives.

At 05 March 2023 £36,151 was held as unrestricted funds.

The Trustees consider that the reserves of the charity should be sufficient to meet the expected level of normal expenditure in the coming year.

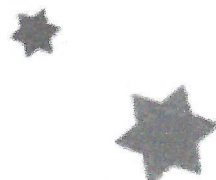
