REPORT OF THE TRUSTEES

The trustees present their annual report and financial statements for the year to 31st December, 2024.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing document is the Crick Community Sports Centre (CCSC) CIO Constitution adopted on 27th June, 2016 which became recognised by the Charity Commission when the Charitable Incorporated Organisation was registered on 10th August, 2016.

The Constitution defines the ongoing arrangements for Trustees to run CCSC CIO. Up to twelve Trustees can be directly elected. One other Trustee position can be nominated by Crick Parish Council. At each AGM, Trustees are elected under the Constitution of the CCSC. The recruitment and training of new trustees, if successfully elected, is conducted by existing trustees.

The Trustees held regular meetings during the year. The Trustees work entirely on a voluntary basis. There are no employees.

The objects of the CIO are the promotion of community participation in healthy recreation, in particular the provision of facilities for sport and fitness, including football, cricket, hockey, and tennis.

PUBLIC BENEFIT STATEMENT

All the Charity's activities are undertaken to further our charitable purpose for the benefit of the public. The trustees have had regard to the Charity Commission guidance on public benefit in section four of the Charities Act 2011. The main benefits which have arisen during the year from the organisations aims and activities are detailed in the following sections and in the financial review.

REVIEW OF DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS DURING THE PERIOD

Following the success of Crick Sports Field Association (CSFA) and Crick Parish Council in raising the funding to build a sports centre and Multi Use Games Area (MUGA), CCSC CIO was constituted to administer the running of them. On the 1st January, 2017 £6,466 of cash and £40,595 of other assets held by CSFA were donated to and gratefully received by CCSC.

Over the subsequent years to 31st December, 2024 the CIO has successfully operated the facilities and acted as the home ground of Crick Athletic Football Club (CAFC). The Senior team has been joined by a Ladies team and an ever-increasing number of Colts teams across all ages.

Activities on the grass have been greatly aided by those on the MUGA, for winter training and through the revenue it generates to support other activities. As well as the CAFC teams training on the MUGA, it is also used by Crick Athletic Walking Football, local 5-a-side teams, for parties and for tennis.

The facilities are not just used by the immediate community of Crick either. Regular bookings are made by the communities of Yelvertoft, Naseby and Long Buckby too.

The commercial success of the MUGA has enabled the CIO to invest in improving the facilities as a whole and to subsidise less commercial but nevertheless beneficial activities within the sports centre pavilion. The centre regularly hosted Pilates, Yoga and Well Being classes, and has been used as a training centre again this year. There has also been an increasing number of private party hires, opening the centre to a wider group of community users.

Further away from the centre, SWEAT continues to host several fitness classes ranging from circuits and cycling through to aerobics and Zumba.

During the period under review, the Trustees have continued to invest in and develop the facilities around the centre, including new ball nets on pitch 1 and most notably the installation of solar panels on the roof of the centre. Grant support was gratefully received from the NCF in respect of this, but we still spent a considerable amount of our reserves. The expenditure will save electricity costs throughout the year and generate some income in the summer months, providing a relatively short payback period and the opportunity to replenish reserves in the future. The MUGA continues to be subject to annual maintenance and repairs have been made as necessary to prolong the life of a major asset. Joint projects have included the continuation of a 6-year Pitch Improvement Programme with Crick Athletic Football Club, the Football Foundation and Northants County FA. Each year herbicide and fertiliser are applied, the pitches scarified, over seeded, vertidraind and dressed with sand.

PLANS FOR FUTURE YEARS

The trustees continue to apply the income of the CIO to benefit as many inhabitants of Crick and its surrounding communities as possible. The incoming funds, except for capital grants, are unrestricted in their use by the CIO and the Trustees consider that current funds are sufficient to meet its ongoing obligations.

Where capital grants are available, the resulting grant award often has conditions attached to it as to how the monies can be spent. The CIO regards these grants as restricted funds until the monies have been spent and the grant conditions satisfied.

We have a long list of improvement projects we would like to undertake but these must be prioritised in terms of the benefit to the community, in conjunction with the sports centre users' plans and the costs of funding where grants are not available. In the short-term, we plan to give the pavilion a little more attention with some general maintenance and renewed appliances. In the longer term, we are investigating the opportunity of adding bowling facilities to the site.

We are constantly improving the quality of our grounds and pitches and trying to extend the use of the facilities over the summer months. Now the cricket club has facilities to host matches we hope to see its continued growth and development, and increased use of their artificial cricket strip, new extension and patio area.

The long-term Pitch Improvement Programme and the mid-term access track project will continue but we also hope to improve the car park areas over the coming year and further protect the site from vandalism and inappropriate access.

FINANCIAL RESULTS FOR THE YEAR

The CIO successfully operated the facilities and generated £23,729 (2023: £23,823) of income, received further donations and grants of £21,577 (2023: £9,470) and benefitted from £2,138 (2023: £4,343) of money derived from fund raising, sponsorship activities and sundry income.

The running costs of the CIO amounted to £26,537 (2023: £33,152) and after accounting for asset purchases of £32,093 (2023: £3,661), the net payment of £11,186 (2023: net receipt of £823) has been deducted from reserves for future investment in the facilities. As at the year end, the cash assets of the CIO were £23,830 (2023: £35,016) and the other assets held by the charity amounted to £179,455 (2023: £147,362).

POLICY ON RESERVES

The Trustees consider that the unrestricted cash fund of £23,830 at 31st December, 2024 (2023: £35,016) is sufficient to sustain its operations should income generating activities be curtailed unexpectedly over the forthcoming year.

A key element of the successful operation of the CIO is for the MUGA to be able to continue to generate revenue. The Trustees therefore ensure that they have sufficient reserves available to meet any emergency repair costs. These notional funds remain unrestricted but as at the 31st December, 2024 they amounted to £21,000 (2023: £21,000).

TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The law applicable to charities in England & Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period.

In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP 2019 (FRS 102);
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

Each year herbicide and fertiliser are applied, the pitches scarified, over seeded, vertidraind and dressed with sand. Further work on the track from the main car park has improved the access for all visitors to the Jubilee and Millenium Woods and also provides additional car parking for users of the Football pitches and Cricket Club. Additional security has been added to the track with a safety gate.

The running costs of the CIO amounted to £33,152 (2022: £32,074) and after accounting for asset purchases of £3,661 (2022: £6,705), the net receipt of £823 (2022: net payment of £196) has been added to reserves for future investment in the facilities. As at the year end, the cash assets of the CIO were £35,016 (2022: £34,193) and the other assets held by the charity amounted to £147,362 (2022: £143,701).

POLICY ON RESERVES

The Trustees consider that the unrestricted cash fund of £35,016 at 31st December, 2023 (2022: £34,193) is sufficient to sustain its operations should income generating activities be curtailed unexpectedly over the forthcoming year.

A key element of the successful operation of the CIO is for the MUGA to be able to continue to generate revenue. The Trustees therefore ensure that they have sufficient reserves available to meet any emergency repair costs. These notional funds remain unrestricted but as at the 31st December, 2023 they amounted to £21,000 (2022: £18,000).





The trustees present their annual report and financial statements for the year to 31st December, 2022.

The governing document is the Crick Community Sports Centre (CCSC) CIO Constitution adopted on 27th June, 2016 which became recognised by the Charity Commission when the Charitable Incorporated Organisation was registered on 10th August, 2016.

The Constitution defines the ongoing arrangements for Trustees to run CCSC CIO. Up to twelve Trustees can be directly elected. One other Trustee position can be nominated by Crick Parish Council. At each AGM, Trustees are elected under the Constitution of the CCSC. The recruitment and training of new trustees, if successfully elected, is conducted by existing trustees.

The Trustees held regular meetings during the year. The Trustees work entirely on a voluntary basis. There are no employees.

OBJECTIVES

The objects of the CIO are the promotion of community participation in healthy recreation, in particular the provision of facilities for sport and fitness, including football, cricket, hockey, and tennis.

PUBLIC BENEFIT STATEMENT

All the Charity's activities are undertaken to further our charitable purpose for the benefit of the public. The trustees have had regard to the Charity Commission guidance on public benefit in section four of the Charities Act 2011. The main benefits which have arisen during the year from the organisations aims and activities are detailed in the following sections and in the financial review.

REVIEW OF DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS DURING THE PERIOD

Following the success of Crick Sports Field Association (CSFA) and Crick Parish Council in raising the funding to build a sports centre and Multi Use Games Area (MUGA), CCSC CIO was constituted to administer the running of them. On the 1st January, 2017 £6,466 of cash and £40,595 of other assets held by CSFA were donated to and gratefully received by CCSC.

Over the subsequent years to 31st December, 2022 the CIO has successfully operated the facilities and acted as the home ground of Crick Athletic Football Club (CAFC). The Senior team has been joined by a Ladies team and an ever-increasing number of Colts teams across all ages.

Activities on the grass have been greatly aided by those on the MUGA, for winter training and through the revenue it generates to support other activities. As well as the CAFC teams training on the MUGA, it is also used by Long Buckby Hockey Club, Crick Athletic Walking Football, local 5-a-side teams, for parties and for tennis.

The facilities are not just used by the immediate community of Crick either. Regular bookings are made by the communities of Yelvertoft, Naseby and Long Buckby too.

The commercial success of the MUGA has enabled the CIO to invest in improving the facilities as a whole and to subsidise less commercial but nevertheless beneficial activities within the sports centre pavilion. The centre regularly hosted Pilates and Yoga classes, and has been used as a training centre again this year. There has also been an increasing number of private party hires, opening the centre to a wider group of community users.

Further away from the centre, SWEAT continues to host several fitness classes ranging from circuits and cycling through to aerobics and Zumba.

In the prior year we continued to suffer the impact of Covid-19. We closely followed the government legislation and shut our facilities when required to do so but benefitted from Daventry District/West Northamptonshire Council grant funding that enabled us to continue our operations as normally as possible.

During the period under review, the Trustees have continued to invest in and develop the facilities around the centre. The MUGA is now subject to annual maintenance and repairs have been made as necessary to prolong the life of a major asset. A notable area of spend included a new entrance for pedestrians to enable them to enter the site separately from the vehicle access and new sections of fencing, improving the overall site safety. The pavilion has been redecorated and the CCTV system upgraded. Joint projects have included the continuation of a 6-year Pitch Improvement Programme with Crick Athletic Football Club, the Football Foundation and Northants County FA. Each year herbicide and fertiliser are applied, the pitches scarified, over seeded, vertidraind and dressed with sand. This year alone 45 tonnes of sand has been applied to pitches 1 and 2.

PLANS FOR FUTURE YEARS

The trustees continue to apply the income of the CIO to benefit as many inhabitants of Crick and its surrounding communities as possible. The incoming funds, except for capital grants, are unrestricted in their use by the CIO and the Trustees consider that current funds are sufficient to meet its ongoing obligations.

Where capital grants are available, the resulting grant award often has conditions attached to it as to how the monies can be spent. The CIO regards these grants as restricted funds until the monies have been spent and the grant conditions satisfied.

We have a long list of improvement projects we would like to undertake but these must be prioritised in terms of the benefit to the community, in conjunction with the sports centre users' plans and the costs of funding where grants are not available. In the short-term, we plan to give the pavilion a little more attention with some general maintenance and improve the heating controls. In the long-term we would like to install solar panels on the roof of the pavilion in order to reduce the electricity costs generated by the MUGA lights.

We are constantly improving the quality of our grounds and pitches and trying to extend the use of the facilities over the summer months. Now the cricket club has facilities to host matches we hope to see its continued growth and development, and increased use of their artificial cricket strip.

The long-term Pitch Improvement Programme and the mid-term access track project will continue but we also hope to improve the car park areas over the coming year and further protect the site from vandalism and inappropriate access.





REPORT OF THE TRUSTEES

The trustees present their annual report and financial statements for the year to 31st December, 2021.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The governing document is the Crick Community Sports Centre (CCSC) CIO Constitution adopted on 27th June, 2016 which became recognised by the Charity Commission when the Charitable Incorporated Organisation was registered on 10th August, 2016.

The Constitution defines the ongoing arrangements for Trustees to run CCSC CIO. Up to twelve Trustees can be directly elected. One other Trustee position can be nominated by Crick Parish Council. At each AGM, Trustees are elected under the Constitution of the CCSC. The recruitment and training of new trustees, if successfully elected, is conducted by existing trustees.

The Trustees held regular meetings during the year. The Trustees work entirely on a voluntary basis. There are no employees.

OBJECTIVES

The objects of the CIO are the promotion of community participation in healthy recreation, in particular the provision of facilities for sport and fitness, including football, cricket, hockey, and tennis.

PUBLIC BENEFIT STATEMENT

All the Charity's activities are undertaken to further our charitable purpose for the benefit of the public. The trustees have had regard to the Charity Commission guidance on public benefit in section four of the Charities Act 2011. The main benefits which have arisen during the year from the organisations aims and activities are detailed in the following sections and in the financial review.

REVIEW OF DEVELOPMENTS, ACTIVITIES AND ACHIEVEMENTS DURING THE PERIOD

Following the success of Crick Sports Field Association (CSFA) and Crick Parish Council in raising the funding to build a sports centre and Multi Use Games Area (MUGA), CCSC CIO was constituted to administer the running of them. On the 1st January, 2017 £6,466 of cash and £40,595 of other assets held by CSFA were donated to and gratefully received by CCSC.

Over the subsequent years to 31st December, 2021 the CIO has successfully operated the facilities and acted as the home ground of Crick Athletic Football Club (CAFC). The Senior team has been joined by a Ladies team and an ever-increasing number of Colts teams across all ages.

Activities on the grass have been greatly aided by those on the MUGA, for winter training and through the revenue it generates to support other activities. As well as the CAFC teams training on the MUGA, it is also used by Long Buckby Hockey Club, Crick Athletic Walking Football, local 5-a-side teams, for parties and for tennis.

The facilities are not just used by the immediate community of Crick either. Regular bookings are made by the communities of Yelvertoft, Naseby and Long Buckby too.

The commercial success of the MUGA has enabled the CIO to invest in improving the facilities as a whole and to subsidise less commercial but nevertheless beneficial activities within the sports centre pavilion. The centre regularly hosted Pilates, Yoga and Chi Kung classes before Covid-19 hit and we were forced to close. Since Covid commenced the centre has found new customers as a training centre and a nursery, and following the relaxation of the regulations we were pleased to see the return of Pilates and Yoga classes.

Further away from the centre, SWEAT continues to host several fitness classes ranging from circuits and cycling through to aerobics and Zumba, as and when the legislation has permitted the classes to be held.

We have continued to suffer the impact of Covid-19 this year. We have closely followed the government legislation and shut our facilities when required to do so but as alluded to above we have found new customers and revenue has recommenced when we've been open. We have also benefitted from Daventry District/West Northamptonshire Council grant funding that has enabled us to continue our operations as normally as possible.

During the period under review, the Trustees have continued to invest in and develop the facilities around the centre. A notable area of spend included a new path and fence to improve the safety of pedestrians. Further safety improvements were made when remarking the car park, introducing a traffic routing system and pedestrian routes. Joint projects have included the continuation of a 6-year Pitch Improvement Programme with Crick Athletic Football Club, the Football Foundation and Northants County FA, and resurfacing the second section of the access track with Crick Woodlands. The resurfacing project also provided the opportunity to add some additional parking near the woodlands. The joint projects could not be completed without grants for which we are grateful.

PLANS FOR FUTURE YEARS

The trustees continue to apply the income of the CIO to benefit as many inhabitants of Crick and its surrounding communities as possible. The incoming funds, except for capital grants, are unrestricted in their use by the CIO and the Trustees consider that current funds are sufficient to meet its ongoing obligations.

Where capital grants are available, the resulting grant award often has conditions attached to it as to how the monies can be spent. The CIO regards these grants as restricted funds until the monies have been spent and the grant conditions satisfied.

We have a long list of improvement projects we would like to undertake but these must be prioritised in terms of the benefit to the community, in conjunction with the sports centre users' plans and the costs of funding where grants are not available. In the short-term, we will improve the site security with ANPR and camera upgrades. We will also smarten up the centre with a fresh coat of paint.

We are constantly improving the quality of our grounds and pitches and trying to extend the use of the facilities over the summer months. Now the cricket club has facilities to host matches we hope to see its continued growth and development, and increased use of their new artificial cricket strip.

The long-term Pitch Improvement Programme and the mid-term access track project will continue but we also hope to improve the car park areas and pedestrian access to the site over the coming year.

FINANCIAL RESULTS FOR THE YEAR

The CIO successfully operated the facilities and generated £21,455 (2020: £22,118) of income, received further donations and grants of £44,269 (2020: £22,000) and benefitted from £2,419 (2020: £6,822) of money derived from fund raising, sponsorship activities and sundry income.

The running costs of the CIO amounted to £31,820 (2020: £24,530) and after accounting for interest and asset purchases of £37,109 (2020: £5,001), the net payment of £786 (2020: net receipt of £21,409) has been deducted from (2020: added to) reserves for future investment in the facilities. As at the year end, the cash assets of the CIO were £34,389 (2020: £35,175) and the other assets held by the charity amounted to £136,996 (2020: £99,887).

POLICY ON RESERVES

The Trustees consider that the unrestricted cash fund of £34,389 at 31st December, 2021 (2020: £25,175) is sufficient to sustain its operations should income generating activities be curtailed unexpectedly over the forthcoming year.

A key element of the successful operation of the CIO is for the MUGA to be able to continue to generate revenue. The Trustees therefore ensure that they have sufficient reserves available to meet any emergency repair costs. These notional funds remain unrestricted but as at the 31st December, 2021 they amounted to £15,000 (2020: £12,000).

TRUSTEES' RESPONSIBILITIES

The trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice). The law applicable to charities in England & Wales requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period.

In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;

- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements; and







Further away from the centre, SWEAT continues to host several fitness classes ranging from circuits and cycling through to aerobics and Zumba, as and when the legislation has permitted the classes to be held.

We have suffered the impact of Covid-19 this year. We have closely followed the government legislation and shut our facilities when required to do so. This resulted in almost no pavilion revenue for the year as we could not hire the hall out. When permitted to we did open the toilets to users of the pitches and incurred additional cleaning and Covid-19 security costs. The full lockdowns also impacted on the MUGA as during these periods we could not generate revenue from online bookings. For those bookings made and paid for in advance, we managed to negotiate credits as opposed to refunds. This enabled us to retain the money, but it does mean that the impacts of Covid-19 will run until the summer of 2021 as those credits are consumed. We benefitted from a rates rebate and grant funding from Daventry District Council that have enabled us to continue our operations as normally as possible.

During the period under review, the Trustees have continued to invest in and develop the facilities around the centre. Notable areas of spend include completion of the irrigation system providing a water supply to the cricket and all football pitches, and a new path and fence to improve the safety of pedestrians. Joint projects have included the commencement of a 6-year Pitch Improvement Programme with Crick Athletic Football Club, the Football Foundation and Northants County FA, and resurfacing the first section of the access track with Crick Woodlands. The joint projects could not be completed without grants for which we are grateful.

PLANS FOR FUTURE YEARS

The trustees continue to apply the income of the CIO to benefit as many inhabitants of Crick and its surrounding communities as possible. The incoming funds, except for capital grants, are unrestricted in their use by the CIO and the Trustees consider that current funds are sufficient to meet its ongoing obligations.

The CIO successfully operated the facilities and generated £22,118 (2019: £25,078) of income, received further donations and grants of £22,000 (2019: £15,413) and benefitted from £6,822 (2019: £2,718) of money derived from fund raising, sponsorship activities and sundry income.

The running costs of the CIO amounted to £24,530 (2019: £21,635) and after accounting for interest and asset purchases of £5,001 (2019: £21,768), the net receipt of £21,409 (2019: payment of £194) has been added to (2019: deducted from) reserves for future investment in the facilities. As at the year end, the cash assets of the CIO were £35,175 (2019: £13,766) and the other assets held by the charity amounted to £99,887 (2019: £94,886).

POLICY ON RESERVES

The Trustees consider that the unrestricted cash fund of £25,175 at 31st December, 2020 (2019: £13,766) is sufficient to sustain its operations should income generating activities be curtailed unexpectedly over the forthcoming year.

A key element of the successful operation of the CIO is for the MUGA to be able to continue to generate revenue. The Trustees therefore ensure that they have sufficient reserves available to meet any emergency repair costs. These notional funds remain unrestricted but as at the 31st December, 2020 they amounted to £12,000 (2019: £9,000).






