We organise Children School Visit to Masjid as a part of interfaith harmony. We work closely with local police, local community centre and a part of Bristol Muslim Cultural Society. We host meetings of different organisations in our premises. Most importantly, English is the language of communication in Masjid to include younger British born Muslims in all activities. We are involved to support to local food centre. During this year, we have managed to purchase a new building for our site and looking forward to establish it as our centre in North Bristol for community.
