Objects: THE PROMOTION OF EQUALITY AND DIVERSITY FOR THE PUBLIC BENEFIT BY: 1. ADVANCING EDUCATION AND RAISING AWARENESS IN EQUALITY AND DIVERSITY2. SUPPORTING YOUNG PEOPLE WHO MAY BE CONFRONTING CHALLENGES IN RELATION TO THEIR SEXUALITYFOR THE PURPOSES OF THIS CLAUSE 'NON BINARY GENDER' MEANS THOSE WHO IDENTIFY AS NEITHER EXCLUSIVELY MASCULINE NOR EXCLUSIVELY FEMININE IN THEIR GENDER IDENTITY. FOR THE PURPOSES OF THIS CLAUSE 'NON-HETERONORMATIVE SEXUALITY' MEANS SEXUALITY WHICH FALLS OUTSIDE THE BELIEF THAT PEOPLE FALL INTO DISTINCT AND COMPLEMENTARY GENDERS (MAN AND WOMAN) WITH NATURAL ROLE IN LIFE, AND POSSIBLE UNDERLYING ASSUMPTIONS THAT SEXUAL AND MARITAL RELATIONS ARE MORE FITTING BETWEEN PEOPLE OF OPPOSITE SEXES.

Activities: Sport Allies has identified that sport - and specifically team sport - is too often where narrow gender stereotypes are reinforced, squeezing many of us into boxes that we do not fit. We are saying no to those stereotypes.
