2. Fundraising has been fairly stable throughout 2024 but sufficient to meet the annual requirement. The focus on our fundraising will need to be increased over the next couple of years while we endeavour to assist an increasing number of Kenyan youth.

4. The trustees look forward to ongoing fundraising and activities gaining further momentum towards expanding the number of youth we can assist.
