TRUSTEES' REPORT

The Directors present their report and the financial statements for the year ending 31 May 2021.

Diaspora Ivoirienne UK was established in June 2013 as a company Limited by guarantee and recently became a registered Charity in November 2016. It is based in London supporting the needs of disadvantaged people from minority communities, particularly, Ivorian residents, migrants, displaced people from their country of origin because of war, victim of violence, political or religious beliefs, intimidation and threat to their lives. Most of the organisation's activities focus on tackling poverty, social exclusion, capacity building of the communities and welfare support services.

AIM & OBJECTIVES

For the benefit of the public, in particular, men, women and children from Ivory Coast and other minority Communities in the United Kingdom, who are in need due to their youth, age, infirmity or disablement, financial hardship or social and economic circumstances.

The objects are met by delivering the following activities:

- a. employment training
- b. education and training including supplementary education for children
- c. the promotion and preservation of good health
- d. the provision of cultural and leisure time activities
- e. The provision of information, advice and referrals and
- f. Money and debt advice

Activities for the period 2020 -2021

- In response to the COVID-19 crisis, the organization has delivered food and essential items provision services for about 240 members and users from the Ivorian communities and other communities in the local area. The services enabled beneficiaries to relieve their financial difficulties and be resilient.
- We have delivered outdoor activities for 50 the elderly people to reduce their isolation and loneliness. The activities enabled beneficiaries to reconnect with the community and make new friends. We have also established a networking hub for them to work together to tackle common issues affecting their life.
- The organization run children's activities called 'Knowing my roots', a story telling cultural event that brought 22 children and 35 parents together from the Ivorian community. The aim of the activities was to enable children born in the UK to explore their parents' origin.
- We have provided training for employment and employment related advice which benefited about 18 unemployed people. This helped them improve their employability chances and 09 of them have been able to secure part- and full-time employment.
- Our advice and referral services supported about 24 local refugees and asylum seekers in the areas of housing, health, education and welfare benefit entitlement. This helped them understand the functioning of local and national services, make informed choices and improve their knowledge about accessing those services.
- We have also recruited three more volunteers to increase the capability of the Organization in order to deliver more services for local communities.

Plan for 2021-2022

- The organization will continue supporting people affected by the Omicron virus as the pandemic is not ended yet totally. We aim help about 33 local residents over the year
- We will continue to deliver more employment sessions to support local people to get jobs. We anticipate to help about 26 people during the organization's financial year
- The organization will increase its information advice and referrals sessions to be able to support about 36 new refugee women and men in need of education, training and welfare entitlement.
- We will carry out befriending, and home support activities for 18 older people to reduce their isolation and improve their health.
- We will run homework club activities this year to improve about 25 children and young people's school achievement and reduce exclusion.

Accounting policies

The financial statements have been prepared under the historical cost convention, as modified by the inclusion of fixed assets investments at Market value, and in accordance with applicable accounting standards and follow the recommendation in the statement of SORP 2011 and company law 2006.

1. Grants & Donation

Grants and Donation are recognized in the statements on accrual basis following the satisfaction of any pre-conditions.

2. Restricted Funds

The organization has not received any restricted fund over the period

3. Reserve Policy

The charity reserve's policy is to hold 1-10% of its total unrestricted income at the end of every financial year depending on the financial situation of the organization.

Directors' Responsibilities

Company law requires the Directors who are also the charity trustees, to prepare financial statements for each financial year which give a true and fair view of the state of the affairs of the company and of the results of the company at that period.

In preparing those financial statements, the directors are required to:
