**Report Introduction**

The charity has no shareholding capital.

### Note re Loan

Loan arose in previous trading year.

G.B. Jones made the following payments from his personal resources on behalf of the charity.

The payments were made to secure opportunities for the charity to generate funds and are treated as reasonable costs to carry out the duties of a Trustee. The expenses substantially comprise travel costs to and from meetings and events to generate funds; overnight accommodation for essential events; ticket purchases for sporting events which were sold as part of a package including other benefits (no uplift on ticket price) to generate funds for the charity.

In respect of all travel and accommodation G.B. Jones has provide this at a discounted rate below the actual cost incurred.

In respect of meals on charity business; telephone expenses; postal expenses; travel for guests of the charity, G. B. Jones provided these gratis.

**Notes:**

1. As at 13 April 2021 the charity has not repaid the loan account to G B Jones.
2. The financial statement is prepared under a historic costs convention.
3. The charity has no sources of income other than those generated by G B Jones through fund raising at and linked to sporting events and hospitality.
4. The charity has not expended any resources in the trading year. All those expenses were paid for in the trading year by G B Jones on behalf of the Charity (loan account) and no payment to G B Jones has been made.
5. Trustees did not receive any emoluments. Expenses incurred are as per loan account with all other expenses being provided gratis by the Trustees.
6. The charity has no investment income.
7. The Trustees did not make any charge for support costs or overheads and no staff costs were incurred.
8. Legal expenses and set up costs were provided gratis as were all governance costs.
9. Gross income being below £25,000 these accounts have not been independently audited and such is not required.
