Many of those who arrive at our Centre do not know who else to turn to, and we are proud that we have built up a great deal of trust within our community. For those who are arrivals from other countries, we can be the starting point, where we assess what their needs are, and then offer them other services, or signpost them to other agencies if that is appropriate.
