This is a combined report for the years 2021/22 and years 2022/23 as we still had COVID related issues in 2021 and the turnover of funds was too small for one year. We therefore decided to combine two years report as previously. We also don't have any admin support as our finances are limited, all trustees work voluntarily, hence there may be a delay in uploading this report.

The charity continues to have same structure with three main trustees and one co-opted trustee. One of the previous trustees has now retired. We have also co-opted three more trustees from year 2023 onwards. In addition we have a full advisory group.

The trustees meet 3-4 times each year to discuss governance, finances, donations and respond to requests for donations. In addition there are adhoc informal meetings with advisory group to discuss requests for donations. The charity has established a WhatsApp group for that purpose.

The charity only works for people of Union territory of Jammu and Kashmir, India only.

The charity continues to support orphans in Jammu and Kashmir India in collaboration with the local charity CHINAR Kashmir.

The Charity continued to provide essential medical equipment's/kits and financial assistance for life saving medicines for a number of poor deserving patients in Jammu and Kashmir

In addition Charity continued to provide scholarships and financial assistance to poor students in the form of school fees, laptops and any other assistance to continue pursue their education.

The Charity also liaised with its local volunteers in Kashmiri and continued to support foodbanks, and distributed food packs to a number of families in different districts of Kashmir at least twice a year. In addition it also helps destitute and families with poor income by providing regular three monthly donations for their basic living.

The charity also responds to any emergency medical treatments/ equipments at short notice.

The charity has already established a free /subsidised dialysis centre in district Baramulla (Kudsiya Medical Canter) where hundreds of dialysis sessions have taken place free for deserving patients.

Due to the ongoing pandemic during 2021/22, all our donations are raised by online appeal via our website and on social media, from local donors in UK. The charity does not get funds from any other association or charity.

We declare no financial or any other risks during this period. The charity mainly works through liaison with voluntary associations /charities in Kashmir, liaison with hospitals, institutions, clinicians and individuals who send us requests for help. The advisory body makes the final decision about providing support and transfer of funds. Each individual is asked to fill in a donation appeal form which is reviewed by the advisory committee. The funds are mostly transferred to institutions/ traders directly however on occasions when there is urgent need funds may be given directly to the individual or through our volunteers in Kashmir. Due receipts /invoices are received for records.

The Charity does not have major admin support, all the trustees and advisory committee works on good will. Hence there is a delay in formulating this report. The charity does not spend its donations on any admin work except for small amount of bank transfer charges or maintenance of website or any printing material

The charities website www.bkcf.org.uk is now up and running and provides information about its activities and contacts.

The charity has broad aims which comprise to relieve poverty, support care of orphans and disabled people, contribute to improving health care by providing health education, financial aid and buy equipment and improve education for deprived students in the state of Jammu and Kashmir, India

Orphan care. We continue to provide support for orphans in through our remote sponsoring scheme and by supporting orphan care in Jammu and Kashmir by providing aid to CHINART Kashmir a charity in Kashmir. We obtain a yearly report on the progress of these orphans, and a number of these orphans are now adults who are in postgraduate education. The trustees monitor the progress of orphans every year by obtaining written report from the charity. Each orphan is provided £3-500 per year which caters for the education, and basic amenities. Most of the orphans are registered at CHINART Home although we sponsor some children directly. The CHINART sends us a written report as well as video feedback which is shared with our donors at our annual fundraiser.

During 2021-22, the charity liaised with a local charity in Manchester UK and obtained free used ventilators which were transported to Kashmir to a local charity EHSAS International. This one done at a nominal cost for transportation. The ventilators were distributed to various COVID Centres and local hospitals. Once the pandemic was over, the ventilators will continue to be used for patients with lung diseases.

We also liaised a local voluntary group in UK "Shul Shahr" and raised funds to buy oxygen concentrators which were later provided to local hospital centres in Kashmir

BKCF provided educational grants and vocational fees to a number of Kashmiri students from poor backgrounds. These were from single school in the suburb of district Baramulla. The request came from the head of the institution, the applications were verified including status of their income and upto 15 students was paid their annual fees. Besides a number of other students were helped with their post graduate education needing university fees, laptops and other maintenance worth about £2000

BKCF continued to support food bank in Kashmir both via ESAS international as well as through our local volunteers and large number of complete family food packs was distributed in different parts of the valley throughout the years 20021 to 2023

The family food packs are distributed at least twice a year. BKCF continued sponsoring the care of a number of patients who need dialysis. BKCF provided a free dialysis machine to Kudsiya Medical Centre in district Baramulla. The feedback from centre says hundreds of episodes of dialysis have taken place at the centre over last few years. Initially we provided funds for 4-6 patients per quarter, each costing about a £1000 per year. From 2021 onwards since Govt. is providing subsidised dialysates BKCF does not transfer any more funds for it but has provided dialysis machine free of cost costing >£7000. Besides BKCF also supports the care of patients at another few dialysis centres in Srinagar on request.

Additional details of objectives and activities (Optional information)

1. BKCF also supports a number of low income families in the district of Baramulla in Jammu and Kashmir (Increased to 10 families in year 2021-23). We provided about £500 per quarter for all the families registered through our volunteers
2. A number of patients with cancer and life threatening illness were supported with finances for buying lifesaving anti-cancer medications, kidney, liver and bone marrow transplant in other parts of India (we provided maximum of £2-6000 aid to each) in last 2 years.
3. The charity continues with health awareness programmes and seminars. One of these was on palliative care and dementia care in Nov 2022.
4. The charity did not have a face to face fund raiser during years 2021-2023 due to ongoing COVID issues. The donations to BKCF were raised by public campaign via our website, on social media and by direct debits by its members. The charity does not get any donations from any other charity or public or government body.

During years 2021 to 2023 there were still COVID-19 relates issues hence we did not have a fundraiser. Our donors continued to support us and we have managed to continue raise more funds in last couple of years.

We continue to liaise with local charities and institutions and volunteers in Kashmir in delivering our work

In line with our constitution we continue to work for health care support, poor patients, and education, relieve poverty and occasional disaster management.

Besides we continue volunteer health awareness, one of these was on palliative care in Kashmir and dementia care. This was a webinar arranged by BKCF in in Nov 2022 in collaboration with three medical institutes of Kashmir including SKIMS, Medical College Baramulla and SMHS hospital and Sandwell and West Birmingham Hospital. The Webinar was attended by healthcare professionals and medical students including the Principal Medical College Baramulla. It helped to create awareness about palliative care needs, training on pain control and end of life care and dementia awareness.

Our assets by the end of financial year 2023 are less than 100,000 but we are able to continue raise £10-15000 every year and spend an equal amount on our projects.

The charity gets request for financial help from various associations, individuals and healthcare institutions, the applications are assessed by advisory committee who assess the application and respond appropriately keeping our finances and resources into view

The expenditure is exactly in line with our governing document. The charity has no political affiliation or agenda.
