FOR THE YEAR ENDED 31 DECEMBER 2022

The trustees present their report together with the financial statements of the charity for the year ended 31 December 2022. The financial statements comply with the charity's governing document, Charity Commission guidance on receipts and payments accounts, and applicable law.

The legal and administrative information set out on page 1 forms part of this report.

Constitution, objects and aims

The Church is governed by a constitution adopted 31 October 2016 when the charity registered with the Charity Commission. The church had previously been governed by a Declaration of Trust dated 2 May 1977, subsequently amended by a Deed of Appointment and Retirement dated 20 April 2005.

The churches objects are the advancement of the Christian Faith in accordance with the basis of faith, and such other charitable purpose as meets the needs of the church.

The Church's aim is to fulfil this and thus maintain a witness to the Christian Faith and the support of various Missionary Societies and Charities which have a similar Biblical approach to their activities.

Public benefit

The Trustees are aware of and consider the guidance of the Charity Commission on Public Benefit and, in particular, the specific guidance to charities for the advancement of religion.

Review of the year

January 22nd A special members' meeting followed by a managing trustees' meeting were held to authorise the transfer of the holding trusteeship from the Fellowship Property Trust to the Church Growth Trust.

The church had to be closed on March 27th and April 3rd as several members were suffering from Covid. The usual services were held during the rest of the year and we were glad to welcome a good number of visitors during the holiday months.

In July we were overjoyed to hold an adult baptism and welcome friends and family to the service which was followed by a buffet lunch.

We record, with sadness, the death of two friends whose funerals took place at the church. One of the ladies had been a very committed member for over 60 years.

It was decided to spend some of the legacy received last year on new curtains in the church and side hall. Also the small kitchen needed decorating and it seemed a good time to alter the layout to give as much room and storage space as possible. There were unavoidable delays and that work will not now be completed until early in 2023.

Financial review

Total receipts for the year amounted to £28,102 (2021: £28,701), total payments for the year amounted to £26,947 (2021: £21,286) and the increase in cash funds for the year amounted to £1,155 (2021: £7,415).

Unrestricted funds carried forward at the end of the year amounted to £16,936 (2021: £15,814). The building fund carried forward at the end of the year amounted to £22,642 (2021: £22,609).

Reserves policy

To accumulate income in order to set aside funds for special purposes or as reserves against future expenditure for such period not exceeding that permitted by law. Substantial sums have been given to charity and we are now spending money on improvements to the building. The Secretary felt that it was not worth transferring funds to the interest account as the rates are still so low.

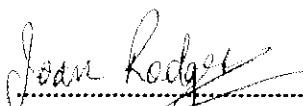

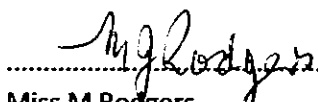
The Managing Trustees are persons appointed according to the Church Rules and the minimum number is 3.

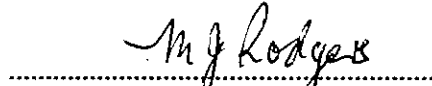

The trustees present their report together with the financial statements of the charity for the year ended 31 December 2021. The financial statements comply with the charity's governing document, Charity Commission guidance on receipts and payments accounts, and applicable law.

The Church is governed by a constitution adopted 31 October 2016 when the charity registered with the Charity Commission. The church had previously been governed by a Declaration of Trust dated 2 May 1977, subsequently amended by a Deed of Appointment and Retirement dated 20 April 2005.

The churches objects are the advancement of the Christian Faith in accordance with the basis of faith, and such other charitable purpose as meets the needs of the church.

The Church's aim is to fulfil this and thus maintain a witness to the Christian Faith and the support of various Missionary Societies and Charities which have a similar Biblical approach to their activities.

Public benefit

The Trustees are aware of and consider the guidance of the Charity Commission on Public Benefit and, in particular, the specific guidance to charities for the advancement of religion.

Review of the year

The Church was open for the first Sunday of the year and then had to close again under Covid restrictions until April. We opened with a Good Friday service and the usual services on Easter Day.

It was a pleasure to welcome visitors again throughout the year and to resume serving tea and coffee after the evening services and the Tuesday Bible Studies. Light suppers were again provided during August.

We were thankful to be able to hold our usual Carol Service and Christmas Day services without any restrictions this year.

We enjoyed visits from representatives of the Trinitarian Bible Society and the Slavic Gospel Association.

We were saddened by the death of a faithful member of the congregation, Mel Barnes. The funeral took place at the Church in March under the 30 limit restrictions.

Later In the year we were contacted by solicitors who informed us that Mel had left the Church a very generous legacy. We received an interim payment of £18,000 in August and the members decided that gifts should be sent to Charities we support before anything else was considered. Accordingly the missionary secretary sent gifts of £1,000 each to the following: Barnabas Fund, The Christian Institute, International Mission to Jewish People, Mission Aviation Fellowship and Soldiers' and Airmen's Scripture Readers Association.

Necessary repairs and refurbishment of the Church building were discussed and this will be arranged in 2022.

The roof repairs over the side room were completed in July and the room was re-decorated in December. All the old strip lights were replaced with LED lighting in August.

Review of the year continued

In April we were informed by the Holding Trustees of the building, Fellowship Property Trust, that it is closing and that we would have to find another holding trustee. There were various options and the Managing Trustees finally decided to appoint Church Growth Trust as they could give us a very similar service to that provided by FPT. All the members were informed and the secretary was authorised to make the changeover. We were offered a grant to help with expenses but, given our present circumstances, we declined as we felt there would be other small churches in a similar position who would find it difficult to meet the costs.

This is going ahead and should be finalised early in 2022.

Financial review

Total receipts for the year amounted to £28,701 (2020: £13,071), total payments for the year amounted to £21,286 (2020: £13,574) and the increase in cash funds for the year amounted to £7,415 (2020: £503 decrease).

Unrestricted funds carried forward at the end of the year amounted to £15,814 (2020: £4,402). The building fund carried forward at the end of the year amounted to £22,609 (2020: £26,606).

Reserves policy

To accumulate income in order to set aside funds for special purposes or as reserves against future expenditure for such period not exceeding that permitted by law. The amount of reserves are not consistent with the policy at the moment because we were waiting for the final payment from the legacy at the end of the year. Substantial sums have been given to charity and we are now spending money on improvements to the building. The Secretary felt that it was not worth transferring funds to the interest account as the rates are still so low.

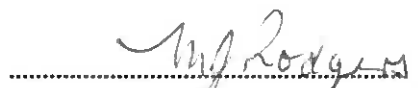

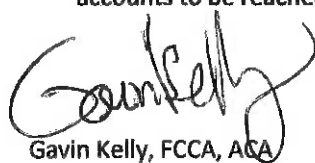

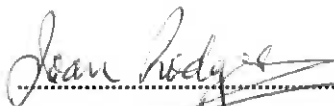
