In the area of education, the organisation implemented initiatives aimed at reducing school dropout rates and promoting access to learning. A

All activities undertaken by AFRICYEF were carried out exclusively for the public benefit, targeting individuals and communities in need without discrimination.



Africyef made a meaningful impact in both education and healthcare within underserved communities. One of the key achievements has been successfully reintegrating out-of-school pupils back into the education system. By providing essential learning materials such as notebooks, and other school supplies, the charity removed significant barriers that had previously prevented many children from continuing their education. As a result, the students were able to resume their studies, regain confidence, and work toward a brighter future.

In addition to contributions to education, Africyef also demonstrated a strong commitment to improving access to healthcare for vulnerable individuals. It provided financial assistance to indigent patients suffering from serious medical conditions, such as those requiring prostate and glaucoma surgeries. By covering or subsidising medical bills, the charity not only alleviated financial burdens but also enabled beneficiaries to receive life-changing and, in some cases, sight-saving treatments.
