The aim being to help the disadvantaged, and needy people throughout the UK and beyond if possible. This is through self-referral and direct referrals from Manchester city council, SureStart Manchester, Manchester Womens Aid, the NHS and local schools to help struggling families, especially during the festive periods when we provide hampers, toys and toiletries. This year we also paid for funeral costs for one family who could not afford the costs for a muslim burial.

The foodbank is run on a weekly basis and is located at the Pankhurst centre in central Manchester, where we receive and distribute food parcels, clothing, baby equipment, toiletries, baby milk and nappies etc to those in need, especially victims of domestic violence, refugees, asylum seekers, families waiting for benefits or those just struggling to make ends meet in order to improve conditions that people are faced with on a day to day basis.

The most up to date source of information continues to be on our Instagram and Facebook pages with latest updates and activities posted on a regular basis.

SNHH charity is a volunteer run organisation, with the support and dedication of our volunteers and generous contributors we are able to support people in the community suffering from poverty and distress.

A big thank you to our Volunteers, who have committed countless hours of their valuable time to community work in our city and beyond, may they be blessed with plenty!

Also, a big thank you to all the organisations and individuals that donate money food / toiletries etc for distribution, especially BARE NECESSITIES TOILETRY BANK who provide generous donations for all our service users throughout the year.

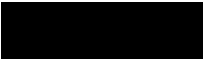

1 Accounting policies

a *Basis of preparation of the accounts*

The accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts.

The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and with the Charities Act 2011.

Advantage has been taken of Section 396(5) of The Companies Act 2006 to allow the format of the financial statements to be adapted to reflect the special nature of the charity's operation and in order to comply with the requirements of the SORP.

The charity has taken advantage of the exemption in the FRS 102 from the requirement to produce a cash flow statement.

The particular accounting policies adopted are set out below.

b Funds Structure

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by the donor or trust deed. There **were** no restricted funds at the year end.

Unrestricted income funds comprise those funds which the trustees are free to use for any purpose in furtherance of the charitable objects. Unrestricted funds include designated funds where the trustees, at their discretion, have created a fund for a specific purpose.

c Income recognition

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Donations are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to conditions that require a level of performance before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that those conditions will be fulfilled in the reporting period.

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank. Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

d Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

All expenditure is accounted for on an accruals basis. All expenses including support costs and governance costs are allocated or apportioned to the applicable expenditure headings For more information on this attribution refer to note (f) below.

e Irrecoverable Vat

Irrecoverable VAT is charged against the expenditure heading for which it was incurred.

f Allocation of Support and governance costs

Support costs have been allocated between governance costs and other support costs. Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to independent examination and legal fees.

g Costs of raising funds

There are no costs associated with raising funds.

h Tangible fixed assets and depreciation

All **assets** costing more than £500 are capitalised and valued at historical cost.

i Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and their opening carrying value or their purchase value if acquired subsequent to the first day of the financial year. Unrealised gains and losses are calculated as the difference between the fair value at the year end and their varying value. Realised and unrealised investment gains and losses are combined in the Statement of Financial Activities
