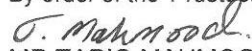
Reserves Policy

Independent Examiner's Report
to the Trustees of Muslim Care

I report on the accounts of FAIZ PUR SHARIF UNION COUNCIL WELFARE for the period ended 28.02.2021, which are set out on pages 3 to 6.

Respective responsibilities of trustees and examiner
