We continue to work with LAC children, providing activities and teaching them life skills from our wonderful team of volunteers. We are looking at art therapy in groups and other important activities to help children with certain issues as it is proven to improve wellbeing. 25 children/young people were supported at Wolverley and in the Wyre Forest area. We have experienced an increase in referrals from CAMHS (NHS), social services and other organisations and local charities wanting Reach Out to support children in need of in many cases urgent support for their mental health. Parents continue to contact us directly as they have children with anxiety, depression, suicidal thoughts, autism, ADHD, anger issues and bereavement. Parents have taken their children to their GP to be told that there

		is no help for them. They are unable to refer to CAMHS. We have worked tirelessly to support these children/young people even though we have become stretched ourselves. Anecdotal evidence remains that our service within the Wyre Forest community is highly appreciated by children/young people, parents, adults, school pastoral team, governors, local charities and organisations. We continue to support the Mitch's Law campaign and petition to get better services for children/young people.

If we turned these people away simply to reduce the risk to our reputation, there would be little other support available for them. The local Child and Adolescent Mental Health Service is unable to meet demand and has to prioritise its service to those deemed to be at greatest risk and for only a limited number of sessions. During the current reporting period Reach Out has built its reputation even further and is highly respected by staff and management of Wolverley C E Secondary School.
Other		Our suicide/self-harm policy/procedure is now active part of our daily work with children/young people. This was needed urgently due to the increase in self harm, suicidal thoughts amongst children/young people. All new volunteers receive training to ensure compliance. We continue to collaborate with Worcester County Council to develop a countywide and multi-agency strategy on suicide and self-harm reduction among young people. We will also continue our work in raising awareness of the Mitch'sLaw campaign for better services for our children/ young people.

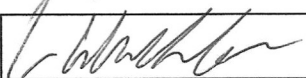
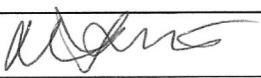

Our approach has always been this way and has worked overtime and given us many successes. We continue to recruit volunteers and counsellors. We are now in a position to take on students from Worcester University. This will be a great help in coping with the demand for our service. We have students who are studying for their CAMHS degree. They will join us to do all their counselling hours. They will be DBS checked and undergo our induction/safeguarding training along with our suicide policy/procedure before starting with us. 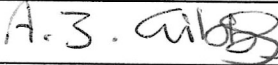

Para 1.20	Our achievement this year has been to continue providing much needed support under the stressful circumstances and the affects of the pandemic with all the difficulties it brought. We adjusted to the school environment rules and worked hard to keep children/young people and our volunteers safe. 32 children were supported at Wolverley and in the Wyre Forest area. Our counsellor also supported 3 adults in the community. With the pandemic causing anxiety and stress amongst parents we were able to offer our support. We experienced an increase in parents calling desperate for advice in supporting their children who were experiencing high levels of anxiety. The pandemic increased the fears and anxieties in many children already experiencing difficulties. Reach Out have worked closely with Wyre Forest council and other organisations/charities with regards to working on a suicide prevention group. We have been able to share our findings as a charity working with

		children/young people who face feeling suicidal and talking about self-harm. We were able to provide a report on our work with young males as the number of these cases had increased. Our Psychotherapist who provided support for these students found similarities in cases. This was beneficial in being able to share this information, to raise awareness and the reality of the current issues being referred to us. Reach Out continue to be involved with this group as we have found it to be a positive way of sharing information regarding the increase in children suffering with more severe mental health issues. Our review of collecting our outcome data has been completed but due to covid regulations has not been collated yet. Anecdotal evidence remains that our service within the Wyre Forest community is highly appreciated by children/young people, parents, adults, school pastoral team and governors.

		behaviour by a volunteer, failure to disclose information during the DBS process, misrepresenting their credentials, breaches of trust and confidentiality and the like. 2. Client related. Self-harm, suicide or acts of aggression while receiving support from Reach Out. This could call into question the competence of the service. On this latter point, it is precisely risk of self-harm and problems managing anger which frequently lead to young people being referred to Reach Out. If we turned these people away simply to reduce the risk to our reputation, there would be little other support available for them. The local Child and Adolescent Mental Health Service is unable to meet demand and has to prioritise its service to those deemed to be at greatest risk and for only a limited number of sessions. During the current reporting period Reach Out has built its reputation even further and is highly respected by staff and management of Wolverley C E Secondary School.
Other		We have completed our suicide/self-harm policy/procedure. We are currently collaborating with Wolverley regards developing a policy/procedure to be used within school as currently there is not one in place. Our quest for 21/22 is to continue to collaborate with Worcester County Council to develop a countywide and multi-agency strategy on suicide and self-harm reduction among young people. We will also continue our work in raising awareness of the Mitch's Law campaign for better services for our children/ young people.
