During the pandemic, these sessions have also been highly beneficial to those families in isolation who have had limited contact with their community.

Friends of SEND have also set up a Family Freebies programme, whereby we receive donations of second-hand clothes, shoes, toys, books, homewares etc, as well as food and toiletries. Once per month we then open this up to the local community to come & take what they need. Due to us being unable to host our usual open days, fayres and fundraisers, our Family Freebies drop ins have also been used to boost the profile & awareness of SEND to Learn Nursery & Friends of SEND as well as general disability awareness and inclusion within the community.


