**OBJECTIVES AND ACTIVITIES**

The CIO was established to promote, maintain, improve and advance the education of the public in the arts, culture, and heritage, and in particular (but without prejudice to the generality of the foregoing), the arts of orchestral, choral and other music.

Since the previous Annual Report (and since our founding) there has been no change to the CIO's principal charitable objectives and activities, which are:

1. the organisation and/or presentation of concerts of high educational and artistic merit, conferences, lectures and recordings;
2. the organisation and presentation of concerts and collaborations with schools and other places of education; and
3. by such other means as the Board of Directors shall from time to time determine.

This includes the organisation and promotion of concerts and the facilitation and organisation of other engagements such as workshops, lectures, and recordings in the United Kingdom and abroad. Alongside the core performances, the CIO is committed to providing additional opportunities for professional development and education through complementary projects and mentoring. In furtherance of these objectives the CIO engages international singers and instrumentalists, artists, performers and répétiteurs; additionally, the CIO engages skilled professional and technical advisers such as language and vocal coaches, musicologists, historians, and keyboard technicians.

The Trustees have reviewed the Charity's objectives and activities and acknowledged that they have paid due regard to the public benefit guidance published by the Charity Commission as noted in Section 4 of the Charities Act 2011. The CIO fulfilled its objectives by presenting 12 concerts and other performances, despite the pandemic. Whilst the Choral Scholarship scheme was suspended for this period, the Trustees acknowledge the organisation's intention to continue this scheme when possible. The Trustees express the objectives in a 'Mission Statement' and monitor its activities/initiatives against this.

**ACHIEVEMENTS AND PERFORMANCE**

From 1st September 2020 to 31st August 2021, the Oxford Bach Soloists gave 1 live performance to a total of 65 audience members, and 11 online performances reaching 9,592 views. The activities were as follows:

**Live Performances**

- 1 live concert as part of the Tilford Bach Festival, performing a concert of Christmas Baroque music (December 2020).

**Online performances**

- In response to the further UK coronavirus lockdown imposed on 4 January 2021, the Oxford Bach Soloists moved to put their Easter Festival, which was due to restart the chronology, online. This consisted of 4 days of videos that were filmed in Christ Church Cathedral, Oxford, and released from Good Friday through to Easter Monday. This project included a collaboration with director Tom Guthrie to produce a semi-staged version of BWV 245 *St John Passion*. (April 2021, 1,445 views)
- 5 online performances continued our “Back to Bach” monthly series, initiated during the lockdown to provide opportunities to offer paid work to musicians, whilst maintaining the Oxford Bach Soloists’ online presence and profile, for continued engagement. (1,939 views)
- 1 online performance as part of the Oxford Lieder Festival, performing BWV 82a, and extracts from BWV 198 alongside tenor Ian Bostridge, who performed Britten’s Canticale 1 and Five Spiritual Songs. (October 2020, 357 views)
- 1 online collaboration with film production company Positive Note to produce an online series called Breaking the Silence, which was supported by CCLA. This was a performance of BWV 232 B minor mass, filmed in advance with social distancing, and released over four episodes on YouTube. (April 2021, 5,851 views)

In response to the UK coronavirus lockdown imposed on 23 March 2020, the Board of Trustees decided to cancel all planned live concerts through to March 2021, with the hope of restarting the organisation’s regular concert series on Good Friday 2021 (2 April). Unfortunately, due to the subsequent lockdowns that were imposed on 5 November 2020 and 6 January 2021, restarting the regular concert series was delayed by a further year until April 2022.

During this continued period of challenge, the Oxford Bach Soloists’ network of Friends and sponsors continued to support the organisation. Many continued to renew their memberships despite the lack of concert activity. Within this period, the organisation

managed to acquire 17 new Friends and supporters, increasing the active base of ongoing memberships to 74.

Continuing to create and distribute content online in this period, and in particular collaborating with other groups online, has been an excellent way of ensuring that we are connecting with our network of sponsors. It has also been an opportunity to continue to engage with a network worldwide. Our online content over this period reached the United States, Taiwan, and Poland, as well as audiences in the United Kingdom.

During this period, the organisation engaged a marketing consultancy firm to help with its online presence. Whilst this was deemed to be successful, it was ultimately decided that the benefits of engaging this firm did not outweigh the cost of the services. These services were not continued past August 2021. The organisation also engaged an agency to propose an updating branding scheme. This branding scheme was ultimately rejected by the major donor to this specific project, and so the organisation made the decision not to carry this forward.

The Choral Scholarship scheme, which was launched in 2018, was suspended for the academic year 2020-21 as it was felt that the organisation would not be able to fulfil the aims of the scholarship whilst the country was subject to the pandemic. Normally, these scholarships provide a unique opportunity for young aspiring singers to develop their solo singing within the musical programme of the Oxford Bach Soloists. Choral Scholars are usually appointed for a single academic year (September to August) and make up the core of the chorus, helping to maintain its musical integrity. Choral Scholars develop their skills by taking on the challenges of step-out solos during concerts and receive one-to-one expert German language coaching as part of their training, as well as extensive one-to-one mentoring from the Artistic Director of Oxford Bach Soloists.

The recruitment cycle for a third cohort of Choral Scholars was reactivated in June 2021, and a reduced cohort of eight Choral Scholars were engaged for the academic year starting in September 2021.

The Oxford Bach Soloists' newsletter captures the experiences of the musicians as they journey through the complete vocal works of Johann Sebastian Bach, and is sent out to over 1000 followers every month.

**FINANCIAL REVIEW**

This was the fourth operating period of the charity. The proceeds from concerts were £23,466 in the 12-month period, compared with costs of £244,310. Some of the shortfall has been covered by general fundraising from Friends (£24,654), and from general donations (£141,900). There is a deficit of £23,694 calculated on a cash basis, which will be covered by income (both donations and concert proceeds) in the next financial period. The Charity secured funding from an individual donor for 2020-21, which allowed significant growth and secured funds to pay musicians. This funding continues and has now been secured for 2021-22.

Proceeds from concerts and general fundraising are lower than the previous period, as fewer concerts were performed in a shorter period. However, choral scholarship donations, proceeds per concert, and general fundraising per month have all increased since the previous period, which reflects the growing audience and reach of the organisation.

General administration costs increased significantly across the period while the fees paid to musicians reduced slightly. The general administration costs increased due to the decision by the Trustees in late 2020 to engage a part-time General Manager to drive the operational side of the Charity, which we consider has been of significant benefit to the smooth running of the charity. The fees to the musicians were reduced due to the limited number of engagements across the period.

At the end of the financial period, the Charity held assets of £50,881. These assets are adequate to provide the charity with working capital and the Trustees do not believe them to be excessive. Work continues to build a strong base of regular donors through the Friends programme and to sponsor the appointment of choral scholars. The charity does not break even on all the concerts which it performs, though it aims to be sustainable over a full 12-month period.

**STRUCTURE, GOVERNANCE AND MANAGEMENT**

The Charity is constituted as a Charitable Incorporated Organisation and has memorandum and articles associated with this.
