Objects: TO FURTHER BENEFIT THE RESIDENTS OF COMMONMOOR AND THE NEIGHBOURHOOD WITHIN THE PARISH OF ST CLEER NEAR LISKEARD, WITHOUT DISTINCTION OF SEX, SEXUAL ORIENTATION, RACE OR OF POLITICAL, RELIGIOUS OR OTHER OPINIONS BY ASSOCIATING TOGETHER THE SAID RESIDENTS AND THE LOCAL AUTHORITIES, VOLUNTARY AND OTHER ORGANISATIONS IN A COMMON EFFORT TO ADVANCE EDUCATION AND TO PROVIDE FACILITIES IN THE INTERESTS OF SOCIAL WELFARE FOR RECREATION AND LEISURE TIME OCCUPATION WITH THE OBJECTIVES OF IMPROVING THE CONDITIONS OF LIFE FOR RESIDENTS IN FURTHERANCE OF THE OBJECTS BUT NOT OTHERWISE THE DIRECTORS AND TRUSTEES SHALL HAVE POWER: TO ESTABLISH OR SECURE THE ESTABLISHMENT OF A COMMUNITY CENTRE AND TO MAINTAIN OR MANAGE OR CO OPERATE WITH ANY STATUTORY AUTHORITY IN THE MAINTENANCE AND MANAGEMENT OF SUCH A CENTRE FOR ACTIVITIES PROMOTED BY THE CHARITY IN FURTHERANCE OF THE ABOVE OBJECTS.

Activities: Provision of a meeting place for the community, together with activities to bring people together e.g. pasty suppers, bingo, fitness classes, duck races etc. The purpose being to combat loneliness and encourage people to enhance their way of life and improve the village as a place to live.
