- 1) To foster the public awareness, knowledge and appreciation of the Welsh male-voice choral tradition, through the study and practice of choral singing and by means of public performances and choral competitions;
- 2) To further such charitable purposes as the trustees in their absolute discretion shall think fit.

- 1) Public performances of choral music in churches, community buildings and community events.
- 2) Performance of choral music at weddings, funerals and civic events.
- 3) Rehearsal of choral music repertoire under the guidance of experienced professional musicians.
- 4) Donations to local and national charities using funds raised at choral concerts.
- 5) Touring to and performing in areas of the UK where Welsh male-voice choral music is not readily available.
- 6) Participation in festivals and events with other choirs and musical groups.

These activities are consistent with the Public Benefit requirement of charities in that they:

- Are beneficial and not detrimental; the enjoyment and appreciation of the Welsh male-voice choral tradition is demonstrated by the number of and attendance at public performances, and;
- Benefit the public in general; most performances are attended by members of the general public and funds raised are donated to charities which operate to benefit the general public.

These aspects are routinely considered by the Committee of Trustees when making decisions on future activities.

Achievements and performance

Summary of the main achievements of the charity during the year

- 19 performances carried out, including 9 public performances for charity fundraising. These are carried out at cost, so that the amounts raised for charities are maximised.
- 3 performances at civic events in Monmouth: Carnival, Mayor's inauguration, Christmas Lantern Parade.
- Successful tour to Devon with public performances at church venues in Torquay, Exeter and Plymouth and public engagement at each location.
- Over £8000 raised by charities at events where the choir performed.
- Singing membership increased from 76 to 80.
- Addition of new repertoire pieces including original arrangements by the choir music team.

In September 2023 the Committee of Trustees approved a proposal to set a minimum level of financial reserves at £10,000.

Approximately 1/3 of the choir's core income (income not related to short-term one-off deposits for tour costs) comes from regular donations from members of the choir. Approximately ½ of the core income comes from fees and ticket sales for concerts and other performances. The remainder comes from grants and individual donations.

These funds enable the choir to continue to deliver its objects, by funding experienced professional musicians to conduct and accompany rehearsals and performances, to stage public performances, to rent a venue for rehearsals, to provide transport to long distance concert commitments, and to publicise the events at which the choir performs.

The choir has no investments.

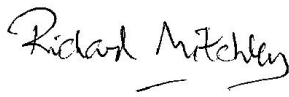
