The Golden Halo Foundation's raison d'être is to assist other charities and individuals with a demonstrated need for support. Golden Halo ("The Charity") does not seek to reinvent the wheel or to duplicate efforts, but rather to identify existing non-profits where possible, and support their identified causes. Areas of interest include the environment, culture and the arts, education, health and uniformed bodies.

Golden Halo's application for the opening of a bank account was approved in the third quarter of 2022. The first donation was received in the fourth quarter of the same year, which would allow for activity to commence in 2023.

Golden Halo received funding from two sources within this time period: (1) Bank customer service compensation (GBP 300) and (2) Donation from the Halo Foundation (GBP 25,515). Total expenditure was GBP 7130 (2023 fundraising associated expenses).

The Charity has no investments and owns no assets. All work is done by volunteers.

Projects are set to commence in January 2023. The protracted period for opening of a bank account has significantly delayed activity.




