<p>Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.</p>	<p>Para 1.20</p>	<p>During the year April 2024 - April 2025, the bandroom underwent major building work. Unfortunately, in December 2020, when the band attempted to return to the bandroom following the national Covid 19 lockdown, the floor in the bandroom was observed to be damaged. Following this, the project of updating the building began. We secured a grant to pay for a project manager who completed the schedule of works and managed the project. During the year April 2024-April 2025, most of the building work took place in the bandroom. The band therefore had to relocate to a local community centre to rehearse. This made rehearsing very challenging as all music and instruments were stored in another location. We were able to provide entertainment for the community through play Christmas carols in local markets in fayres. We also took part in numerous local church/chapel christmas carol concerts where we would play our own pieces as well as accompany the congregation that was singing. We also played Christmas carols in our local supermarket, providing festive background music to the shoppers.</p>





