Structure, governance and management

Nature of "Governing Document" and constitution of the charity

Kingdom Fellowship is registered with the Charity Commission – Registration number 1172809. The governing document is the Trust Deed dated 9th April 2017. The trustees meet on a formal basis as often as they deem necessary to fulfil their obligations and ensure the smooth running of Kingdom Fellowship.

The power of appointment and removal of trustees is vested in the trustees of the Church in accordance with the provisions of the trust deed. All Trustees must be members of the Church and must adhere to the "Tenets of Faith."

Financial review

The trustees are satisfied that the charity's assets in each fund are available and adequate to fulfil the obligations in respect of each fund (ring fencing).

Reserves

It is of paramount importance to Kingdom Fellowship that it has the ability to meet its expenses and accomplish long term expansion and growth to reach its goals.

The trustees monitor and review the appropriateness of reserves to enable the activities of the charity to continue.

Transactions and financial position

The financial statements are set out in the attached financial report. The financial statements have been prepared on a receipts and payments basis, which is permitted for smaller charities. The trustees consider the financial performance by the charity during the year to have been satisfactory.
