### **YEAR ENDED 31 MARCH 2025**

The Trustees present their report and accounts for the year ended 31<sup>st</sup> March 2025.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Church's Trust Deed, The Charities Act 2007 and the Statement of Recommended Practice, "Accounting and Reporting by Charities" issued in March 2005.

By the grace of God and the continuing help of our supporters we were able to meet many of our objectives for the year.

We reiterate our mandate as contained in the Trust document:

- a) the celebration of public worship
- b) the teaching of the Christian Faith
- c) mission and evangelism
- d) pastoral work, including visiting the sick and the bereaved
- e) the provision of facilities with a Christian ethos for the local community, including (but not restricted to) the elderly, the young and other groups with special needs; and
- f) the support of other charities' in the UK and Overseas

#### **Structure, Governance and Management**

The Church was registered as an independent Charity on 4<sup>th</sup> May 2017

Existing Trustees by resolution, appoints new Trustees at planned meetings. The Board of Trustees who make the financial and management decisions oversee the activities of the church. The spiritual and educational guidance of the congregation is delegated to the Pastors, Elders and Departmental Leaders who are appointed by the Senior Pastor. The Church's objectives are the advancement of Christian and other charitable purposes and in particular, to further education in the basic principles of Christian morality.

The Charity also participates in a number of organisations such as the Aylesbury Church Network (ACN).

### **Activities For The Year**

#### **Local Ministries**

We collect food each month for distribution by ourselves and partner organisations to the homeless and those in need. We distribute food from supermarkets within Buckinghamshire to recipients in Buckinghamshire, Bedfordshire and London, to churches, senior citizens, senior citizens lunch clubs, mothers with young children homes and various charities supporting the poor.

We hold a level 2 food safety certificate which enables us to handle food correctly as per food safety standards.

#### **Policies and Procedures**

We have policies in place covering DBS procedures, we have provided training to volunteers with regard to safe guarding policies and procedures. We are kept up to date by Thirty-one Eight on the latest procedures and updates to safeguarding legislation.

#### **Child Protection**

We take child protection and the vulnerable seriously, our voluntary workers have undergone Disclosure Barring Service (DBS) checks. Our volunteers have undergone child protection training in the last 36 months.

#### **Caribbean Community Lunch Club CIC (CCLC)**

The church has a direct link with the Caribbean Community Lunch Club CIC the chairman of VPCOG is also the CEO of the Caribbean Community Lunch Club CIC. The CCLC evolved out of the West Indian Association Lunch Club. The West Indian Lunch club was not a legal entity e.g. it was not a charity or Community Interest Company (CIC) which made it not fit for purpose.

It was revamped under the leadership of Peter Bruce who registered it as a CIC, we have forged partnerships with Bucks Council, NHS, Helping Hands, Leap just to name a few. We meet every Tuesday from 11:00am – 3:00pm at the Aylesbury Multicultural Centre to provide a nutritious Caribbean meal. We also run health workshops, and invite speakers to speak on various topics affecting our community.

### **Mission Department**

Support outside the UK:-

We do not support charitable organisations outside the United Kingdom due to our current size, however we do support a Church in Jamaica have made donations to various appeals or disasters.

### **Community Ministries**

We continue to build on our contacts with various community groups such as the Aylesbury interfaith group where we look at matters facing the community. This might include the stop and search policy practiced by the police in the town and whether it is fairly applied across all communities.

### **Future Plans**

The plan for the future is to make the church a more professional organisation; an organisation that is not only attractive to Christians but will be welcoming and relevant to the wider Community. To this end, we have engaged with various organisations such as Social Change UK to explore healthy eating, being active, plus accessing local support in Buckinghamshire.

We are in the process of trying to double our current space, the first phase of the plan started in July 2020 e.g. building a two bed flat at the back of the church, this has provided increased revenue in a time where the pandemic has resulted in voluntary organisations experiencing a fall in their incomes.

### **All Party Parliamentary Group (APPG)**

We are helping the APPG promote how faith base organisations can play a part in tackling loneliness by organising community events such as coffee mornings, luncheon clubs, or by visiting the elderly in their homes etc.

### **Faith Action**

We are also working with Faith action to raise awareness of how faith base groups can support people living with dementia, if you would like to volunteer or help with any of the partner's we work with please contact us.

### NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31 MARCH 2025

#### **1. Accounting Policies**

##### **1.1 Basis of preparation**

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and The Charities Act 2011.

##### **1.2 Incoming resources**

Income including that gifted under the Gift Aid Scheme is taken into account when received by the Charity or notified to us by Inland Revenue. Income received in circumstances where a claim for repayment of tax has been or will be made to the Inland Revenue is shown net with tax recoverable shown separately. Any amounts of tax reclaimed and notified but not yet received from H M Revenue & Customs is shown within the Charity's debtors.

Interest and rental income are taken into account when receivable.

##### **1.3 Resources expended**

Expenditure is taken into account when incurred by the Charity regardless of when payment is made and is allocated to the appropriate heading in the Accounts. Grants and donations payable are taken into account at the earlier of when they are paid or become constructive obligations of the Charity.

##### **1.4 Tangible fixed assets and depreciation**

Tangible fixed assets other than freehold property are stated at cost or valuation less depreciation. Depreciation is provided at rates calculated to write off the cost or valuation less estimated residual value of each asset over its expected useful life, as follows:-

Fixtures, fittings & equipment	10% - 25% on cost
Motor vehicles	25% on reducing balance
Computer & Other equipment	33.33% on cost

##### **Investments**

Current asset investments are stated at market value.

##### **1.6 Accumulated funds**

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

##### **1.7 Commitments for future expenditure**

Other than normal commitments under contracts of employment, there are no contractual obligations to future expenditure at the balance sheet date. Where the trustees have authorised expenditure, which is not legally enforceable or become constructive obligations, amounts are set aside into funds designated for the purpose.

### **Activities For The Year**

#### **Local Ministries**

We collect food each month for distribution by ourselves and partner organisations to the homeless and those in need. We distribute food from supermarkets within Buckinghamshire to recipients in Buckinghamshire, Bedfordshire and London, to churches, senior citizens, senior citizens lunch clubs, mothers with young children homes and various charities supporting the poor.

We hold a level 2 food safety certificate which enables us to handle food correctly as per food safety standards.

#### **Policies and Procedures**

We have policies in place covering DBS procedures, we have provided training to volunteers with regard to safe guarding policies and procedures. We are kept up to date by Thirty-one Eight on the latest procedures and updates to safeguarding legislation.

#### **Child Protection**

We take child protection and the vulnerable seriously, our voluntary workers have undergone Disclosure Barring Service (DBS) checks. Our volunteers have undergone child protection training in the last 36 months.

#### **Caribbean Community Lunch Club CIC (CCLC)**

The church has a direct link with the Caribbean Community Lunch Club CIC the chairman of VPCOG is also the CEO of the Caribbean Community Lunch Club CIC. The CCLC evolved out of the West Indian Association Lunch Club. The West Indian Lunch club was not a legal entity e.g. it was not a charity or Community Interest Company (CIC) which made it not fit for purpose.

It was revamped under the leadership of Peter Bruce who registered it as a CIC, we have forged partnerships with Bucks Council, NHS, Helping Hands, Leap just to name a few. We meet every Tuesday from 11:00am – 3:00pm at the Aylesbury Multicultural Centre to provide a nutritious Caribbean meal. We also run health workshops, and invite speakers to speak on various topics affecting our community.

### **Mission Department**

Support outside the UK:-

We do not support charitable organisations outside the United Kingdom due to our current size, however we have made donations to various appeals or disasters in other countries.

### **Community Ministries**

We continue to build on our contacts with various community groups such as the Aylesbury interfaith group where we look at matters facing the community. This might include the stop and search policy practiced by the police in the town and whether it is fairly applied across all communities.

### **Future Plans**

The plan for the future is to make the church a more professional organisation; an organisation that is not only attractive to Christians but will be welcoming and relevant to the wider Community. To this end, we have engaged with various organisations such as Social Change UK to explore healthy eating, being active, plus accessing local support in Buckinghamshire.

We are in the process of trying to double our current space, the first phase of the plan started in July 2020 e.g. building a two bed flat at the back of the church, this has provided increased revenue in a time where the pandemic has resulted in voluntary organisations experiencing a fall in their incomes.

### **All Party Parliamentary Group (APPG)**

We are helping the APPG promote how faith base organisations can play a part in tackling loneliness by organising community events such as coffee mornings, luncheon clubs, or by visiting the elderly in their homes etc.

### **Faith Action**

We are also working with Faith action to raise awareness of how faith base groups can support people living with dementia, if you would like to volunteer or help with any of the partner's we work with please contact us.



### **1. Accounting Policies**

#### **1.1 Basis of preparation**

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and The Charities Act 2011.

#### **1.2 Incoming resources**

Income including that gifted under the Gift Aid Scheme is taken into account when received by the Charity or notified to us by Inland Revenue. Income received in circumstances where a claim for repayment of tax has been or will be made to the Inland Revenue is shown net with tax recoverable shown separately. Any amounts of tax reclaimed and notified but not yet received from H M Revenue & Customs is shown within the Charity's debtors.

Interest and rental income are taken into account when receivable.

#### **1.3 Resources expended**

Expenditure is taken into account when incurred by the Charity regardless of when payment is made and is allocated to the appropriate heading in the Accounts. Grants and donations payable are taken into account at the earlier of when they are paid or become constructive obligations of the Charity.

#### **1.4 Tangible fixed assets and depreciation**

Tangible fixed assets other than freehold property are stated at cost or valuation less depreciation. Depreciation is provided at rates calculated to write off the cost or valuation less estimated residual value of each asset over its expected useful life, as follows:-

Fixtures, fittings & equipment	10% - 25% on cost
Motor vehicles	25% on reducing balance
Computer & Other equipment	33.33% on cost

#### **Investments**

Current asset investments are stated at market value.

#### **1.6 Accumulated funds**

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

#### **1.7 Commitments for future expenditure**

Other than normal commitments under contracts of employment, there are no contractual obligations to future expenditure at the balance sheet date. Where the trustees have authorised expenditure, which is not legally enforceable or become constructive obligations, amounts are set aside into funds designated for the purpose.

#### **Activities For The Year**

##### **Local Ministries**

We collect food each month for distribution by ourselves and partner organisations to the homeless and those in need. We distribute food from supermarkets within Buckinghamshire, Bedfordshire and London, to churches, senior citizens homes and various charities supporting the poor.

We hold a level 2 food safety certificate which enables us to handle food correctly as per food safety standards.

##### **Policies and Procedures**

We have policies in place covering DBS procedures, we have provided training to volunteers with regard to safe guarding policies and procedures. We are kept up to date by Thirty-one Eight on the latest procedures and updates to safeguarding legislation.

##### **Child Protection**

We take child protection and the vulnerable seriously, our voluntary workers have undergone Disclosure Barring Service (DBS) checks. Our volunteers have undergone child protection training in the last 36 months.

##### **Caribbean Community Lunch Club CIC (CCLC)**

The church has a direct link with the Caribbean Community Lunch Club CIC the chairman of VPCOG is also the CEO of the Caribbean Community Lunch Club CIC. The CCLC evolved out of the West Indian Association Lunch Club. We were limited in what we could do as the West Indian Lunch club was not a legal entity eg. It was not a charity or Community Interest Company (CIC) which made it not fit for purpose.

It was revamped under the leadership of Peter Bruce who registered it as a CIC, we have forged partnerships with Bucks Council, NHS, Helping Hands, Leap just to name a few. We meet every Tuesday from 11:00am – 3:00pm at the Aylesbury Multicultural Centre to provide a nutritious Caribbean meal. We also run health workshops, and invite speakers to speak on various topics affecting our community.

**Mission Department**

Support outside the UK:-

We do not support charitable organisations outside the United Kingdom due to our current size, however we have made donations to various appeals or disasters in other countries.

**Community Ministries**

We continue to build on our contacts with various community groups such as the Aylesbury interfaith group where we look at matters facing the community. This might include the stop and search policy practiced by the police in the town and whether it is fairly applied across all communities.

**Future Plans**

The plan for the future is to make the church a more professional organisation; an organisation that is not only attractive to Christians but will be welcoming and relevant to the wider Community. To this end, we have engaged with various organisations such as Social Change UK to explore healthy eating, being active, plus accessing local support in Buckinghamshire.

We are in the process of trying to double our current space, the first phase of the plan started in July 2020 eg building a two bed flat at the back of the church, this has provided increased revenue in a time where the pandemic has resulted in voluntary organisations experiencing a fall in their income.

**All Party Parliamentary Group (APPG)**

We are helping the APPG promote how faith base organisations can play a part in tackling loneliness by organising community events such as coffee mornings, luncheon clubs, or by visiting the elderly in their homes etc.

**Faith Action**

We are also working with Faith action to raise awareness of how faith base groups can support people living with dementia, if you would like to volunteer or help with any of the partner's we work with please contact us.





**1. Accounting Policies**

**1.1 Basis of preparation**

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with applicable accounting standards, the Statement of Recommended Practice, "Accounting and Reporting by Charities", issued in March 2005 and The Charities Act 2011.

**1.2 Incoming resources**

Income including that gifted under the Gift Aid Scheme is taken into account when received by the Charity or notified to us by Inland Revenue. Income received in circumstances where a claim for repayment of tax has been or will be made to the Inland Revenue is shown net with tax recoverable shown separately. Any amounts of tax reclaimed and notified but not yet received from H M Revenue & Customs is shown within the Charity's debtors.

Interest and rental income are taken into account when receivable.

**1.3 Resources expended**

Expenditure is taken into account when incurred by the Charity regardless of when payment is made and is allocated to the appropriate heading in the Accounts. Grants and donations payable are taken into account at the earlier of when they are paid or become constructive obligations of the Charity.

**1.4 Tangible fixed assets and depreciation**

Tangible fixed assets other than freehold property are stated at cost or valuation less depreciation. Depreciation is provided at rates calculated to write off the cost or valuation less estimated residual value of each asset over its expected useful life, as follows:-

Fixtures, fittings & equipment	10% - 25% on cost
Motor vehicles	25% on reducing balance
Computer & Other equipment	33.33% on cost

**Investments**

Current asset investments are stated at market value.

**1.6 Accumulated funds**

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

**1.7 Commitments for future expenditure**

Other than normal commitments under contracts of employment, there are no contractual obligations to future expenditure at the balance sheet date. Where the trustees have authorised expenditure, which is not legally enforceable or become constructive obligations, amounts are set aside into funds designated for the purpose.
