The trustees present their report and the unaudited financial statements for the year ended 31 March 2025. Included within the trustees' report is the directors' report as required by company law.

Reference and administrative information set out on page 1 forms part of this report. The financial statements comply with current statutory requirements, the memorandum and articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

The primary objective of The Tim Bacon Foundation is to provide grants and/or financial contributions to charitable organisations that are committed to alleviating sickness and promoting the preservation and protection of the health of individuals suffering from cancer.

Such grants and/or payments shall be applied in strict accordance with the charitable purposes of the recipient organisation and for the advancement of public benefit. The Foundation shall undertake regular reviews of the charitable organisations it currently supports, as well as those it may support in the future, to ensure that they continue to serve as appropriate vehicles for furthering the charitable objectives of the Foundation, while consistently meeting the requirement to promote public benefit.

During the period ending 31 March 2025, the Foundation's primary objectives were centred around executing a series of fundraising events throughout the calendar year, while simultaneously fostering deeper engagement with the hospitality sector to enhance the Foundation's visibility and impact within the industry. These strategic initiatives were designed not only to generate crucial financial support for the Foundation's charitable causes but also to build stronger partnerships within the hospitality industry, thereby increasing awareness of the Foundation's work and expanding its reach to a broader audience.

The Trustees undertake a comprehensive review of the charity's aims, objectives, and activities on an annual basis. This report provides an assessment of the charity's achievements and evaluates the outcomes of its work during the reporting period. The Trustees assess the success of each key activity and measure the tangible benefits the charity has delivered to the specific groups it was established to support. This review process also ensures that the charity's aims, objectives, and activities remain aligned with its core charitable purposes and continue to serve the public benefit effectively.

In conducting this review, the Trustees have referred to the guidance provided in the Charity Commission's general public benefit guidance. This guidance has informed both the review of the charity's aims and objectives and the planning of its future activities. Specifically, the Trustees have carefully considered how the charity's planned activities will contribute to the advancement of its stated aims and objectives, ensuring that all future initiatives will remain consistent with the charity's overarching charitable mission and legal obligations.

Achievements and performance

Throughout the period ending 31 March 2025, a series of fundraising initiatives were conducted across the hospitality sector, generating significant contributions in support of charitable organisations.

One such initiative, Hospitality Helps, brought together the industry to aid with raising vital funds towards the final £600,000 required to complete the funding for the National Breast Imaging Academy in Manchester, in support of Prevent Breast Cancer. The successful initiative brought together multiple restaurants and their staff across the UK take part in one collective effort of fundraising for the project.

FY25 also saw the continuation of an invaluable corporate partnership with Gusto Restaurants and Young Lives Vs Cancer, raising £25,000 to support children and their families. This ongoing partnership

demonstrates a commitment to supporting key charitable organisations and making a tangible impact on the communities they serve.

Financial review

Fundraising activities for the year ending March 2025 largely returned to levels comparable to those observed in previous years, with the exception of the Dream the Impossible event. The Foundation successfully organised and or attended a range of localised and smaller-scale events, including industry conferences, awards ceremonies, Hospitality Kicks, and several fundraising races. These initiatives were designed to minimise operational costs, thereby maximising the net donation generated from each event. As a result, the Foundation was able to fully leverage its fundraising capabilities and achieve a high level of financial support for its charitable activities.

Throughout the reporting period, The Tim Bacon Foundation has maintained a robust cash position, ensuring financial stability and sustainability. This strong financial position was upheld at the close of the financial year, providing a solid foundation for the Foundation's ongoing operations and future initiatives.

Reserves policy

The trustees aim to maintain designated reserves within unrestricted funds at £30,000. The trustees consider that this level will provide sufficient funds to assist in generating fundraising events and cover any ongoing operational costs.

Plans for the future

The Tim Bacon Foundation remains steadfast in its commitment to supporting cancer charities, leveraging the support of the hospitality industry to further its charitable objectives. This commitment will see the return of the "Dream the Impossible" event in Manchester in September 2025 with the aim to raise in excess of £200,000 by bringing together eleven restaurants and eight charities alongside corporate sponsors to raise awareness and funds to support those living with cancer.

Structure, governance and management

The Tim Bacon Foundation is a company limited by guarantee, incorporated on 19 December 2016 and registered as a charity on 18 May 2017.

The company is established under a Memorandum of Association and is governed by its Articles of Association which set out the objects and powers of the charitable company.

The company is managed by the trustees and directors who constitute its management committee. All trustees and directors are unpaid. New trustees are appointed by the existing trustees.

The organisation is a charitable company limited by guarantee, incorporated on 19th December 2016 and registered as a charity on 18th of May 2017.

The company was established under a memorandum of association which established the objects and powers of the charitable company and is governed under its articles of association.

Members of the charity guarantee to contribute an amount not exceeding £1 to the assets of the charity in the event of winding up. The trustees are members of the charity but this entitles them only to voting rights. The trustees have no beneficial interest in the charity.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 10 to the accounts.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

Statement of responsibilities of the trustees

The trustees (who are also directors of Tim Bacon Foundation for the purposes of company law) are responsible for preparing the trustees' annual report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the trustees are required to:

- Select suitable accounting policies and then apply them consistently
- Observe the methods and principles in the Charities SORP
- Make judgements and estimates that are reasonable and prudent
- State whether applicable UK Accounting Standards and statements of recommended practice have been followed, subject to any material departures disclosed and explained in the financial statements
- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

1 Accounting policies

The principal accounting policies adopted, judgments and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), second edition - October 2019 (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006 and UK Generally Accepted Accounting Practice. The charity has applied the exemption available to small charities in the Charities SORP (FRS 102) and does not include a Statement of Cash Flows in these Financial Statements.

The Tim Bacon Foundation meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

b Preparation of the accounts on a going concern basis

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern.

The trustees have made no key judgments which have a significant effect on the accounts. The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

c Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

Income received in advance of a provision of a specified service is deferred until the criteria for income recognition are met.

d Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised; refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

e Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

f Fund accounting

Unrestricted funds are available to spend on activities that further any of the purposes of charity.

Designated funds are unrestricted funds of the charity which the trustees have decided at their discretion to set aside to use for a specific purpose.

Restricted funds are donations which the donor has specified are to be solely used for particular areas of the charity's work or for specific projects being undertaken by the charity.

g Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity headings:

- Costs of raising funds comprise the costs of events, sales and marketing and their associated support costs.
- Expenditure on charitable activities includes the grants making costs undertaken to further the purposes of the charity and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

h Operating leases

Operating leases are leases in which the title to the assets, and the risks and rewards of ownership, remain with the lessor. Rental charges are charged on a straight line basis over the term of the lease.

i Fixed asset investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing quoted market price. The statement of financial activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The Charity does not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

j Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

k Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

l Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

2 Legal status of the charity

The charity is a company limited by guarantee registered in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity. The registered office address is disclosed on page 1.

The trustees present their report and the unaudited financial statements for the year ended 31 March 2024. Included within the trustees' report is the directors' report as required by company law.

Reference and administrative information set out on page 1 forms part of this report. The financial statements comply with current statutory requirements, the memorandum and articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

The primary objective of The Tim Bacon Foundation is to provide grants and/or financial contributions to charitable organisations that are committed to alleviating sickness and promoting the preservation and protection of the health of individuals suffering from cancer.

Such grants and/or payments shall be applied in strict accordance with the charitable purposes of the recipient organisation and for the advancement of public benefit. The Foundation shall undertake regular reviews of the charitable organisations it currently supports, as well as those it may support in the future, to ensure that they continue to serve as appropriate vehicles for furthering the charitable objectives of the Foundation, while consistently meeting the requirement to promote public benefit.

During the period ending 31 March 2024, the Foundation's primary objectives were centred around executing a series of fundraising events throughout the calendar year, while simultaneously fostering deeper engagement with the hospitality sector to enhance the Foundation's visibility and impact within the industry. These strategic initiatives were designed not only to generate crucial financial support for the Foundation's charitable causes but also to build stronger partnerships within the hospitality industry, thereby increasing awareness of the Foundation's work and expanding its reach to a broader audience. By leveraging the expertise and networks within the sector, the Foundation aimed to maximise both its fundraising potential and its long-term sustainability.

The Trustees undertake a comprehensive review of the charity's aims, objectives, and activities on an annual basis. This report provides an assessment of the charity's achievements and evaluates the outcomes of its work during the reporting period. The Trustees assess the success of each key activity and measure the tangible benefits the charity has delivered to the specific groups it was established to support. This review process also ensures that the charity's aims, objectives, and activities remain aligned with its core charitable purposes and continue to serve the public benefit effectively.

In conducting this review, the Trustees have referred to the guidance provided in the Charity Commission's general public benefit guidance. This guidance has informed both the review of the charity's aims and objectives and the planning of its future activities. Specifically, the Trustees have carefully considered how the charity's planned activities will contribute to the advancement of its stated aims and objectives, ensuring that all future initiatives will remain consistent with the charity's overarching charitable mission and legal obligations

Achievements and performance

The charity's main activities and who it tries to help are described below.

Throughout the period ending 31 March 2024, a series of fundraising initiatives were conducted across the hospitality sector, generating significant contributions in support of several charitable organisations. These efforts were made possible through the continued and invaluable corporate partnership with Gusto Restaurants Ltd and The Alchemist Bar & Restaurant Ltd. As a result of these collaborative fundraising activities, donations were made to the following causes: Prevent Breast Cancer, Bolton Hospice, and Young Lives Vs Cancer. This ongoing partnership demonstrates a commitment to supporting key charitable organisations and making a tangible impact on the communities they serve.

Financial review

Fundraising activities for the year ending March 2024 largely returned to levels comparable to those observed in previous years, with the exceptional year of the Dream the Impossible event. The Foundation successfully organised and/or attended a range of localised and smaller-scale events, including industry conferences, awards ceremonies, Hospitality Kicks, and several fundraising races. These initiatives were designed to minimise operational costs, thereby maximising the net donation generated from each event. As a result, the Foundation was able to fully leverage its fundraising capabilities and achieve a high level of financial support for its charitable activities.

Throughout the reporting period, The Tim Bacon Foundation has maintained a robust cash position, ensuring financial stability and sustainability. This strong financial position was upheld at the close of the financial year, providing a solid foundation for the Foundation's ongoing operations and future initiatives.

Reserves policy

The trustees aim to maintain designated reserves within unrestricted funds at £30,000. The trustees consider that this level will provide sufficient funds to assist in generating fundraising events and cover any ongoing operational costs.

Plans for the future

The Tim Bacon Foundation remains steadfast in its commitment to supporting cancer charities, leveraging the support of the hospitality industry to further its charitable objectives. Moving forward, the Foundation will continue to develop and implement innovative projects designed to maximise fundraising opportunities. One such initiative, Hospitality Helps brings together the industry to aid with raising vital funds towards the final £600,000 required to complete the funding for the National Breast Imaging Academy in Manchester, in support of Prevent Breast Cancer. For the 2024/25 period, the "Hospitality Helps" initiative, which will bring together prominent hospitality brands to raise the vital funds needed to finalise the construction of the Academy. This collaborative effort will play a crucial role in expanding the capacity of the Academy to deliver more mammograms to women each year, ultimately contributing to earlier detection and improved outcomes in the fight against breast cancer.

Structure, governance and management

The Tim Bacon Foundation is a company limited by guarantee, incorporated on 19 December 2016 and registered as a charity on 18 May 2017.

The company is established under a Memorandum of Association and is governed by its Articles of Association which set out the objects and powers of the charitable company.

The company is managed by the trustees and directors who constitute its management committee. All trustees and directors are unpaid. New trustees are appointed by the existing trustees.

The organisation is a charitable company limited by guarantee, incorporated on 19th December 2016 and registered as a charity on 18th of May 2017.

The company was established under a memorandum of association which established the objects and powers of the charitable company and is governed under its articles of association.

Members of the charity guarantee to contribute an amount not exceeding £1 to the assets of the charity in the event of winding up. The trustees are members of the charity but this entitles them only to voting rights. The trustees have no beneficial interest in the charity.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 10 to the accounts.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

1 Accounting policies

The principal accounting policies adopted, judgments and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), second edition - October 2019 (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006 and UK Generally Accepted Accounting Practice.

The charity has applied the exemption available to small charities in the Charities SORP (FRS 102) and does not include a Statement of Cash Flows in these Financial Statements.

The Tim Bacon Foundation meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

b Preparation of the accounts on a going concern basis

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern.

The trustees have made no key judgments which have a significant effect on the accounts. The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

c Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

Income received in advance of a provision of a specified service is deferred until the criteria for income recognition are met.

d Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised; refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

e Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

f Fund accounting

Unrestricted funds are available to spend on activities that further any of the purposes of charity.

Designated funds are unrestricted funds of the charity which the trustees have decided at their discretion to set aside to use for a specific purpose.

Restricted funds are donations which the donor has specified are to be solely used for particular areas of the charity's work or for specific projects being undertaken by the charity.

g Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity headings:

- Costs of raising funds comprise the costs of events, sales and marketing and their associated support costs.
- Expenditure on charitable activities includes the grants making costs undertaken to further the purposes of the charity and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

h Operating leases

Operating leases are leases in which the title to the assets, and the risks and rewards of ownership, remain with the lessor. Rental charges are charged on a straight line basis over the term of the lease.

i Fixed asset investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing quoted market price. The statement of financial activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The Charity does not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

j Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

k Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

l Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

2 Legal status of the charity

The charity is a company limited by guarantee registered in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity. The registered office address is disclosed on page 1.

The trustees present their report and the unaudited financial statements for the year ended 31 March 2023. Included within the trustees' report is the directors' report as required by company law.

Reference and administrative information set out on page 1 forms part of this report. The financial statements comply with current statutory requirements, the memorandum and articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

The Tim Bacon Foundation's main purpose is to make grants and/or payments to charitable organisations dedicated to relieving sickness and preserving and protecting the health of members of the general public suffering from cancer.

Such grants and/or payments are to be used in accordance with the recipient organisation's charitable purposes and for the public benefit. The Foundation will undertake a regular review of the charitable organisations it benefits and could potentially benefit, to ensure they remain an appropriate means of advancing the charitable purposes of the Foundation and having regard to the public benefit requirement.

During the period ending 31 March 2023, the funds raised by the Tim Bacon Foundation were to be donated to nine charities following the Dream the Impossible The Sequel event held in September 2022.

Two corporate partnerships ran in the year ending March 2023, the first being The Alchemist and Blood Cancer UK. The Tim Bacon Foundation supported fundraising and donated £10,331 to provide for a full time Clinical Support Nurse to help patients manage their physical, mental, social and financial wellbeing to June 2022. The second corporate partnership with Gusto Restaurants and Young Lives vs Cancer ran for the year ending March 2023, with the project aim to raise £100,000 to support families and young children through their journey with cancer.

Lastly, The Tim Bacon foundation held a large fundraising event in Manchester City centre in September 2022, Dream the Impossible, The Sequel. The event brought together eleven city centre restaurants and nine charities supported by national corporate businesses to host an evening dedicated to raising funds for cancer charities. The event resulted in the nine charities receiving a profit share of £383,000.

The trustees review the aims, objectives and activities of the charity each year. This report looks at what the charity has achieved and the outcomes of its work in the reporting period. The trustees report the success of each key activity and the benefits the charity has brought to those groups of people that it is set up to help. The review also helps the trustees ensure the charity's aims, objectives and activities remained focused on its stated purposes.

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning its future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives that have been set.

Achievements and performance

The charity's main activities and who it tries to help are described below.

All its charitable activities focus on charitable organisations dedicated to relieving sickness and preserving and protecting the health of members of the general public suffering from cancer and are undertaken to further Tim Bacon Foundation's charitable purposes for the public benefit.

Financial review

Fundraising for the year ended March 2023 exceeded our expectations with Dream The Impossible, The Sequel, sporting events, conferences and awards ceremonies.

By mitigating costs by way of a robust review by trustees and utilising our charity and corporate partnerships, The Tim Bacon Foundation successfully achieved full fundraising capabilities and maximised profit generated from fundraising events.

The Tim Bacon Foundation has maintained a strong cash position throughout the year and at the financial period end.

Reserves policy

The trustees aim to maintain designated reserves within unrestricted funds at £30,000. The trustees consider that this level will provide sufficient funds to assist in generating fundraising events and cover any ongoing operational costs.

Plans for the future

The Tim Bacon Foundation has committed to supporting cancer charities with the support of the hospitality industry and will continue to work on new projects to maximise fundraising opportunities. The board of Trustees is looking towards key fundraising projects to enable hospitality partners multiple options to support a chosen cancer charity. This will include the current Corporate Partnership scheme.

Structure, governance and management

The Tim Bacon Foundation is a company limited by guarantee, incorporated on 19 December 2016 and registered as a charity on 18 May 2017.

The company is established under a Memorandum of Association and is governed by its Articles of Association which set out the objects and powers of the charitable company.

The company is managed by the trustees and directors who constitute its management committee. All trustees and directors are unpaid. New trustees are appointed by the existing trustees.

The organisation is a charitable company limited by guarantee, incorporated on 19th December 2016 and registered as a charity on 18th of May 2017.

The company was established under a memorandum of association which established the objects and powers of the charitable company and is governed under its articles of association.

Members of the charity guarantee to contribute an amount not exceeding £1 to the assets of the charity in the event of winding up. The trustees are members of the charity but this entitles them only to voting rights. The trustees have no beneficial interest in the charity.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 10 to the accounts.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

1 Accounting policies

The principal accounting policies adopted, judgments and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), second edition - October 2019 (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006 and UK Generally Accepted Accounting Practice.

The charity has applied the exemption available to small charities in the Charities SORP (FRS 102) and does not include a Statement of Cash Flows in these Financial Statements.

The Tim Bacon Foundation meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

b Preparation of the accounts on a going concern basis

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern.

The trustees have made no key judgments which have a significant effect on the accounts. The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

c Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

Income received in advance of a provision of a specified service is deferred until the criteria for income recognition are met.

d Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised; refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

e Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

f Fund accounting

Unrestricted funds are available to spend on activities that further any of the purposes of charity.

Designated funds are unrestricted funds of the charity which the trustees have decided at their discretion to set aside to use for a specific purpose.

Restricted funds are donations which the donor has specified are to be solely used for particular areas of the charity's work or for specific projects being undertaken by the charity.

g Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity headings:

- Costs of raising funds comprise the costs of events, sales and marketing and their associated support costs.
- Expenditure on charitable activities includes the grants making costs undertaken to further the purposes of the charity and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

h Operating leases

Operating leases are leases in which the title to the assets, and the risks and rewards of ownership, remain with the lessor. Rental charges are charged on a straight line basis over the term of the lease.

i Fixed asset investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing quoted market price. The statement of financial activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The Charity does not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

j Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

k Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

l Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

2 Legal status of the charity

The charity is a company limited by guarantee registered in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity. The registered office address is disclosed on page 1.

During the period ending 31 March 2022, the funds raised by the Tim Bacon Foundation were to be donated to two main charities.

A corporate partnership founded in 2021 with The Alchemist and Blood Cancer UK enabled The Tim Bacon Foundation to support fundraising and donate £27,790 to provide for a full time Clinical Support Nurse to help patients manage their physical, mental, social and financial wellbeing to June 2022. The need for such support became much greater during the pandemic with greater pressures on the NHS.

Lastly, we continued our ongoing support of the Maggie's Centre in Manchester, donating ten per cent of any fundraising to the centre. Maggie's offers free practical, emotional, and social support to people living with cancer along with their family and friends. Maggie's is in the grounds of the Christie Hospital and helps people take back control when cancer turns their life upside down.

All its charitable activities focus on charitable organisations dedicated to relieving sickness and preserving and protecting the health of members of the general public suffering from cancer and are undertaken to further Tim Bacon Foundation's charitable purposes for the public benefit.

Principle fundraising activities in the year ending March 2022 involved hospitality conferences, awards ceremonies, organised sporting events and corporate partnerships.

Following the Covid-19 pandemic, The Tim Bacon Foundation adapted their fundraising strategy by increasing awareness of a charity draft beer in partnership with Seven Brothers Brewery, Koala Lager. This product was available to purchase online and within hospitality venues with a small percentage of the sale donated to the charity, generating income totalling £5,911.

This vital fundraising allowed the charity to meet its ongoing governance, insurance and administration costs whilst not requiring any government funding.

Financial review

Fundraising for the year ended March 2022 exceeded our expectations with sporting events, conferences and awards ceremonies hosting their first events post the covid 19 pandemic.

By mitigating costs by way of a robust review by trustees and utilising our charity and corporate partnerships, The Tim Bacon Foundation successfully achieved full fundraising capabilities and maximised profit generated from fundraising events.

The Tim Bacon Foundation has maintained a strong cash position throughout the year and at the financial period end.

Reserves policy

The trustees aim to maintain designated reserves within unrestricted funds at £30,000. The trustees consider that this level will provide sufficient funds to assist in generating fundraising events and cover any ongoing operational costs.

Plans for the future

The Trustees of The Tim Bacon Foundation undertook a strategic review in the year ended March 2020 to maximise future fundraising capabilities. The trustees have designed a specific hospitality fundraising scheme which encourages a collaborative approach between charities and our hospitality partners. This scheme was trialled successfully in the year ending March 2020 by The New World Trading Company and the Joshua Tree. We were able to guide and support both partners through the fund matching and fundraising to amplify the funds generated and employee engagement whilst also aiding with corporate social governance.

The new strategy has been implemented in the year ending March 2022 with hospitality partners and new charities enlisted on the scheme. The year ahead will see Gusto Restaurants join the scheme supporting Young Lives vs Cancer, a charity that helps children and their families find the strength to face whatever cancer throws at them including financial support, social care and a home away from home if required.

September 2022 will see the return of the Dream the Impossible fundraising event, first held by the Tim Bacon Foundation in 2017 which raised £500,000 for the Christie. The 2022 event will see 11 restaurants in Manchester come together to support 11 charities with the aim of raising £400,000.

Structure, governance and management

The Tim Bacon Foundation is a company limited by guarantee, incorporated on 19 December 2016 and registered as a charity on 18 May 2017.

The company is established under a Memorandum of Association and is governed by its Articles of Association which set out the objects and powers of the charitable company.

The company is managed by the trustees and directors who constitute its management committee. All trustees and directors are unpaid. New trustees are appointed by the existing trustees.

The organisation is a charitable company limited by guarantee, incorporated on 19th December 2016 and registered as a charity on 18th of May 2017.

The company was established under a memorandum of association which established the objects and powers of the charitable company and is governed under its articles of association.

Members of the charity guarantee to contribute an amount not exceeding £1 to the assets of the charity in the event of winding up. The trustees are members of the charity but this entitles them only to voting rights. The trustees have no beneficial interest in the charity.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 10 to the accounts.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

Statement of responsibilities of the trustees

1 Accounting policies

The principal accounting policies adopted, judgments and key sources of estimation uncertainty in the preparation of the financial statements are as follows:

a Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), second edition - October 2019 (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006 and UK Generally Accepted Accounting Practice.

The charity has applied the exemption available to small charities in the Charities SORP (FRS 102) and does not include a Statement of Cash Flows in these Financial Statements.

The Tim Bacon Foundation meets the definition of a public benefit entity under FRS102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

b Preparation of the accounts on a going concern basis

The trustees consider that there are no material uncertainties about the charitable company's ability to continue as a going concern.

The trustees have made no key judgments which have a significant effect on the accounts. The trustees do not consider that there are any sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities within the next reporting period.

c Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from government and other grants, whether 'capital' grants or 'revenue' grants, is recognised when the charity has entitlement to the funds, any performance conditions attached to the grants have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred.

For legacies, entitlement is taken as the earlier of the date on which either: the charity is aware that probate has been granted, the estate has been finalised and notification has been made by the executor(s) to the charity that a distribution will be made, or when a distribution is received from the estate. Receipt of a legacy, in whole or in part, is only considered probable when the amount can be measured reliably and the charity has been notified of the executor's intention to make a distribution. Where legacies have been notified to the charity, or the charity is aware of the granting of probate, and the criteria for income recognition have not been met, then the legacy is treated as a contingent asset and disclosed if material.

Income received in advance of a provision of a specified service is deferred until the criteria for income recognition are met.

d Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS 102), general volunteer time is not recognised; refer to the trustees' annual report for more information about their contribution.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised in expenditure in the period of receipt.

e Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Bank.

f Fund accounting

Unrestricted funds are available to spend on activities that further any of the purposes of charity.

Designated funds are unrestricted funds of the charity which the trustees have decided at their discretion to set aside to use for a specific purpose.

Restricted funds are donations which the donor has specified are to be solely used for particular areas of the charity's work or for specific projects being undertaken by the charity.

g Expenditure and irrecoverable VAT

Expenditure is recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably. Expenditure is classified under the following activity headings:

- Costs of raising funds comprise the costs of events, sales and marketing and their associated support costs.
- Expenditure on charitable activities includes the grants making costs undertaken to further the purposes of the charity and their associated support costs.

Irrecoverable VAT is charged as a cost against the activity for which the expenditure was incurred.

h Operating leases

Operating leases are leases in which the title to the assets, and the risks and rewards of ownership, remain with the lessor. Rental charges are charged on a straight line basis over the term of the lease.

i Fixed asset investments

Investments are a form of basic financial instrument and are initially recognised at their transaction value and subsequently measured at their fair value as at the balance sheet date using the closing quoted market price. The statement of financial activities includes the net gains and losses arising on revaluation and disposals throughout the year.

The Charity does not acquire put options, derivatives or other complex financial instruments.

The main form of financial risk faced by the charity is that of volatility in equity markets and investment markets due to wider economic conditions, the attitude of investors to investment risk, and changes in sentiment concerning equities and within particular sectors or sub sectors.

j Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

k Cash at bank and in hand

Cash at bank and cash in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

l Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

2 Legal status of the charity

The charity is a company limited by guarantee registered in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £10 per member of the charity. The registered office address is disclosed on page 1.
