The objective of the charity is the advancement of the Orthodox Jewish Faith by financially supporting synagogues, places of religious study and institutes of Jewish Education, and in other ways as the trustees may see fit.

Significant activities

The main way the charity pursues its objective is through grant-making. During the year, a total of £88,000 (2020: £163,000) was donated to other charitable organisations.

Public benefit

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning future activities and setting the grantmaking policy.

Volunteers

There were no volunteers during the year.

ACHIEVEMENT AND PERFORMANCE

Internal and external factors

The Trustees have considered the potential impact of the Covid-19 pandemic, which has been spreading since early 2020, on the Charity's activities. The Trustees have taken appropriate action to follow government guidance and to mitigate the effects of Covid-19 on the finances of the charity.

FINANCIAL REVIEW

Principal funding sources

The principal funding sources are donations from limited companies.

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Basis of preparing the financial statements
