To support the charitable activities of the Galbur Foundation registered NGO in Somalia which are exclusively charitable in accordance with the laws of England and Wales in particular but not exclusively by:(a) the provision of education and shelter for orphaned children with disabilities in Hiraan region of Somalia(b) providing support for people suffering from mental health illness in Hiraan region of Somalia(c) the provision of emergency food support in the event of famine in Hiraan region of Somalia.?
