

Awareness and Educations:

The charity arranges awareness events for the youth and their families. AYGf (the charity) promote awareness and educates the Afghan Youths and their families about the true values and education of Islam. The Afghan Youths will not be influenced by the fundamentalist preachers while being exposed to them by either direct communications or over the internet/media. This in return help the overall other communities where they will be tolerant of diverse cultural and social differences.

Stimulations of Youth's potential and Development:

The charity works with the Afghan Youth's to stimulate in maximum use of their potential and developing their skills that are needed for their future careers and present education, they will be able to advance their own careers and hence better their own lives, their families and the overall communities where they will be living. This will equip them to contribute greatly the overall society and the economy of the country.

Language Teaching:

The charity provides training programs on weekly basis to teach the Afghan Youth holly Quran and Dari/Farsi languages. By learning their mother tongue properly, they will be able to communicate efficiently with their parents and other members of the family. This will help in prevention of tensions and misunderstanding which are usually due the language gap. These misunderstanding and tensions are because of the language barriers amongst the parents and children where the parents are educated in their mother tongue but the children are more comfortable in communicating in English. By learning to communicate effectively in their mother tongue, the children will be able to understand their parents properly and have a good family life.

Majority of the Afghan Youth's parents are having their higher education in their mother tongue. Their children can benefit from their experiences and knowledge greatly if they understand their mother language while communicating.
