Complete control of the account was within the powers of the Trustees and no non-related charity activity in the account took place during this period, the only management costs were £242 spent on purchasing a website domain for the charity as disclosed in the SOFA. 74% of income was funded by active Trustees compared to 78% in the previous year. As per previous year, the trustees has agreed to use a spouse to help transfer grant funding to successful parties, this has helped keep management costs close to zero. Confirmation of all related receipts and acknowledgment from recipients have been shared with all trustees; no financial gain has taken place either directly or indirectly due to these transactions.
