Complete control of the account was within the powers of the Trustees and no non-related charity activity in the account took place during this period, the only management costs were £23 spent on upkeep on website domain for the charity as disclosed in the SOFA.

75% of income was funded by active Trustees compared to 74% in the previous year. Due to the death of a key contact in Burma no grant or expenditure has taken place in this accounting period .

The Trustees will look to re-establish contacts and projects to serve its constitutional objectives.
