Once all funds are released the charity will close all accounts. The charity has ceased all activities and events going forward from the 31.01.2019. This decision has been made due to health reasons between the trustees and the lack in numbers of users of the charity. The charity as of January 2020 has now released funds as special giving to similar charities throughout the borough to close the charity. As of August 2020 all monies have been donated to similar charities these are</p> <p>Love, Jasmine The Tunza Center The Ava Marie Foundation</p> <p>No monies are now in the charity account. We have closed the charity due to lack of numbers and health conditions throughout each of the trustees. It isn't feasible to continue the charity going forward. As of August 2020 Jenson's Twinkle Stars has closed in its entirety by following the small constitution we have in place.</p>
