Objects: THE OBJECTS OF THE CHARITY ('THE OBJECTS') ARE: TO ADVANCE SUCH CHARITABLE PURPOSES (ACCORDING TO THE LAW OF ENGLAND AND WALES) AS THE TRUSTEES SEE FIT FROM TIME TO TIME IN PARTICULAR BUT NOT LIMITED TO (A) MAKING GRANTS TO CHARITIES BASED IN ENGLAND AND WALES THAT HAVE A TURNOVER OF LESS THAN £1,000,000 AND THAT FOCUS ON PROMOTING CHARITABLE CAUSES IN THEIR LOCAL AREA (B) ADVANCING THE EDUCATION OF YOUNG PEOPLE BY PROVIDING THEM WITH SCHOLARSHIPS OR BURSARIES TO ENABLE THEM TO STUDY VOCATIONAL COURSES THAT THEY COULD NOT OTHERWISE AFFORD AND WHERE NO GOVERNMENT FUNDING IS AVAILABLE (C) ADVANCING THE EDUCATION OF YOUNG PEOPLE BY PROVIDING EDUCATIONAL ESTABLISHMENTS WITH FUNDS TO ENABLE THEM TO PROVIDE SCHOLARSHIPS AND BURSARIES TO YOUNG PEOPLE TO STUDY VOCATIONAL COURSES THAT THEY COULD NOT OTHERWISE AFFORD AND WHERE NO GOVERNMENT FUNDING IS AVAILABLE

Activities: 1 making grants to charities in England and Wales that have a turnover of less than £1million that focus on local area 2 scholarships or bursarships for young people for vocational courses where no government funding is available 3 providing educational establishments with funds to finance 2 above
