Purpose of the Trust

- Fostering extended relationships between governors, staff, parents and others associated with the school.
- To establish, develop and support projects of activities, both in and out of curriculum time, that strengthen links between The Hurst School and the local community, benefitting all stakeholders.

Grant Sources

Garfield Weston Grant for £30K towards to 3G project which is also potentially being supported by Basingstoke and Deane local authority and Football Association. The 3G will be used by the School; along with local communities of all ages for predominately football training and matches. This will support with mental health and wellbeing of local residents.

A grant from Hampshire County Council and AWE to support the development of an Urban Farm hydroponic system to aid the teaching climate change within our community. The practical applications will benefit children of all age ranges and in particular those from disadvantage groups.

An Additional Restriction Grant (ARG) was received from the local authority which assisted in the ability to reduce the liability of the closure of the Leisure facilities during the COVID-19 pandemic.

Three separate grants were received from AWE, all of which supports the purpose of the Trust.


