During the year the Group has carried out its objects.


The Eden Group offers riding to about thirty children from five to eighteen years of age; and twelve adults from the Edington Centre and Aspire 17. Everyone rides on a Thursday in school term time at Rookin House.

The children from Ullswater Community College in Penrith come in two groups alternating each week in term time. Eight children from North Lakes Primary school ride each week and share two ponies for their seventy five minute lesson. Two children from Warcop Primary school come on alternate weeks and have a 30 minute lesson.

Everyone rides in the large indoor school in the winter and in the outdoor school when the weather is good; sometimes they are taken for a ride around the farm. The chief coach is Gina Martiew ; Jackie Woodrow, Jane Taylor, Marion Arter and Lulle Hothfield are the assistant coaches. All the coaches were assessed in October 2022.

During the year the Group has carried out its objects.

Due to the Covid pandemic it was not possible to offer riding sessions in the summer term but in mid September most of the clients decided to recommence their lessons at Rookin House.

The Eden Group offers riding to about thirty children from seven to seventeen years of age; and about five adults from the Edington Centre and a young Autistic lady. All the riders ride on a Thursday in school term time.


Children from Warcop and North Lakes Primary Schools ride each week during term time in the large indoor school. This is a new venue for these children with mostly different helpers but they have coped very well with the changes and are progressing successfully.

The children from Ullswater Community College in Penrith come in two groups alternating each week in term time. The adult riders were in a small bubble due to pandemic and missed several weeks. Everyone rides in the large indoor school in the winter and in the outdoor school when the weather is good; sometimes they are taken for a ride around the farm.
