The trustees of Ark Assist wish to report that since our previous report for 2019/20 we have continued to focus on ensuring that in every respect the Charity meets its legal and practical obligations to deliver relief to needy individuals in conflict areas. This remains our main concern and we do not intend to do anything that would threaten our reputation or the safety of our beneficiaries

Our challenge is to ensure that benefits are delivered whilst there is no risk to either those delivering relief or to the resources donated to Ark Assist.
