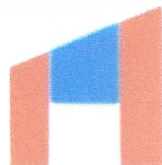

Governance and management

The charity is operated under the rules of its constitution, adopted 12th July 2017 and registered with the Charity Commission on 10th October 2017.

The trustees of the charity are appointed using the guidelines laid down in the constitution. Trustees are appointed on a rotational 3 year basis, and nominations are sought from the membership.

Aims and objectives

To promote social inclusion for the public benefit by preventing people aged 18 or over, within the borough of Hastings and the surrounding area, from becoming socially excluded, relieving the needs of those people who are socially excluded and assisting them to integrate into society through the provision of facilities in which they can meet to undertake creative, physical or recreational activities, learn or pass on skills and knowledge, and support each other socially.

For the Purposes of this clause "Socially excluded" means being excluded from Society, or parts of society, as a result of one or more of the following factors; unemployment; financial hardship; youth or old age; ill health(physical or mental); substance abuse or dependency including alcohol and drugs; discrimination on the grounds of sex, race, disability, ethnic origin, religion, belief, creed, sexual orientation or gender re-assignment; poor educational or skills attainmen; relationship and family breakdown; poor housing (that is housing that does not meet basic habitable standards); crime (either as a victim of crime or as an offender rehabilitating into society).

Public benefit statement

Hastings and St Leonards Men's Shed follows Charity Commission Guidelines and must report annually to the Charity Commission to affirm its obligation to function for the public benefit. In planning activities, the trustees were mindful of the Charity Commission's guidance on public benefit.

Summary of the Development, Structure, Activities and Aims for the period

Hastings and St Leonards Men's Shed was set up in October 2016 by representatives of Ore Valley Big Local which was administered by Orbit Housing Association, now Hastings Voluntary Action. It is constituted as a Charity (CIO) and is run entirely by volunteers.

The Shed is aimed primarily at older men (thought there are also lady members), a group traditionally under-represented in community and social activities. Loneliness, isolation and depression are high risk factors for this group.

The health impact of loneliness has been documented by the Campaign to end Loneliness, whose report in 2015 shows that lacking social connections is as damaging to our health as smoking 15 cigarettes a day. Social networks and friendships not only have an impact on reducing the risk of mortality or developing certain diseases, but they also help individuals to recover when they do fall ill. The report showed that:

- 17% of older people are in contact with family, friends and neighbours less than once a week and 11% are in contact less than once a month.
- over half (51%) of all people aged 75 and over live alone;
- two fifths of all older people (about 3.9 million) say the television is their main company;
- 63% of adults aged 52 or over who have been widowed, and 51% of the same group who are separated or divorced report, feeling lonely some or all of the time;
- 59% of adults aged over 52 who report poor health say they feel lonely some of the time or often, compared to 21% who say they are in excellent health.

Hastings is one of the 10 most deprived areas in the country where ill-health and social isolation are of great social concern.

Shed Structure and Activities

The Shed is a 'Member' organisation managed currently by four volunteer Trustees, who are elected by the Membership, with at least one experienced volunteer in attendance at all times that the Shed is open. The Trustees are assisted by volunteer 'helpers' from amongst the Members who undertake specific tasks to facilitate the Shed's operation.

The Men's Shed aims to mitigate the problems of social isolation by providing workshops and meeting spaces where Members can pursue craft and social activities within the Shed community whilst also serving the local community. The Shed has fully equipped wood and metal workshops.

Members range from the able-bodied to the vulnerable including, for example, people with Autism, and some Dementia sufferers who can attend with carers if necessary. All levels of skill are represented with the Trustees and more skilled members helping to train those less skilled members in the use of tools and machinery in a friendly and co-operative environment.

Members can pursue their own projects but some also make goods or repair donated goods and furniture, which are sold to the local community at modest prices. This income helps to defray the running costs and also meet a local community need. As much use is made as possible of recycled and donated materials

The Shed is normally open for three and half days per week with at least one volunteer Trustee in attendance at all times. There is a modest £5 fee to become a Member and a charge of £2 per day attended.

Currently we rent premises at 20 Manhattan Gardens next to Ore Community Centre. Though old and in need of refurbishment the building provides good facilities. Minor repairs and improvements continue to be made with the assistance of grants from Big Local and other bodies for which the Shed is most grateful, but much still needs to be done.

The Charity raises about half of its annual operating costs from its independent income from membership fees and goods made and repaired for sale to the local community with the remainder coming from grants. Rent for the building comprises about half of the operating costs. The Charity is fundraising with the aim of purchasing a building to reduce its operating costs to within its independent income so that it can continue to provide its services into the long term.

Community Support and Social Value

We believe our Shed adds social value to the community in a number of ways:

- the Members themselves benefit from having a productive activity and engaging with a community, thus reducing social isolation and depression and facilitating better cognitive functioning and improved mental wellbeing. This in turn has an effect in reducing social care costs;
- where they have them, members families and/or carers benefit from the relief given by having a secure and caring environment where the members can spend time productively;
- the local community benefits from having a low-cost source for craft items and repairs.

We know we have an impact on the families of our members as well as our members themselves. Comments such as the Shed "provides a lifeline", "you've given me my husband back", "my dad has got a purpose again", are not uncommon.

Current Position and Progress this Year

The Shed nearly had to close permanently during the Covid pandemic because it lost all of its 'self-earned' income. Fortunately it received a number of small grants which enabled it to re-open after the pandemic though attendance was initially much reduced despite the increased need as people were reluctant to mix again initially. The Shed is now growing strongly with Membership having increased from around 150 last year to around 180 at the present time.

The Shed is slowly being re-equipped with the aid of grants from Big Local and donations. This year much of the machinery has been re-located, new tool racking installed to make the maximum use of the existing space and external electricity and water connections installed. Members cleaned and repainted the side of the building and cleared overgrown flower beds which were subsequently planted by Ore-in-Bloom, much improving the appearance of the Shed's public face adjacent to the Ore Community Centre. We are also working closely with Ore-in-Bloom to fund-raise to clear the largest part of the currently derelict Shed grounds with a view to creating an accessible Community Garden and add gardening as an activity for Members and the public.

The big task this year has been to complete the clearing of the space occupied by a stage from the previous use of the building as a theatre, in order to provide more working space needed for the expanding membership. External storage has been built. Stored materials moved from inside the building to the new storage and the space is currently being repainted and re-wired to increase the usable space in the main workshop by around one third to accommodate more machines and benches. We are grateful to Big Local for a grant to meet a large part of the external costs of this work.

A new IT system and web-site has been developed by a Member enabling the Shed both to operate and communicate with the public more efficiently and effectively.

We were fortunate to have been awarded a grant of £8,000 by the Sussex Foundation which met around 50% of the operating costs for this year enabling the Shed to remain open.

We have enjoyed very supportive visits by our local MP, the Lord Lieutenant, and the High Sherriff of East Sussex this year and hope to use the higher profile gained by these visits in furthering the development of the Shed and in fund raising.

We are exploring the possibilities of collaborating with local refugee organisations to identify whether there is a helpful role that the Shed could fulfil in welcoming new members of the community.

The crucial issue for the Shed's development remains finding a building at considerably less cost so that the Shed can become financially secure for the longer term.

Unfortunately, we were not awarded a grant by the National Lottery Fund towards the cost of purchasing the building that we currently rent after two years negotiation, so we are having to start fund-raising again with the aim of purchasing the building or finding an alternative next year.

Future developments

The Shed's main aims for the next year or two are:

- to continue to meet the expanding demand for its services;
- to secure its financial future by purchasing a building or finding alternative accommodation at lower cost;
- to complete the expansion of the building's working space to meeting the increasing demand;
- to develop part of the grounds as an accessible community garden;
- to increase the range of activities of the Shed to engage with other interests of those in need, such as gardening or facilitating access by those seeking asylum.

Financial review

Hastings & St Leonards Men's Shed is funded by membership fees, sales and small grants. In the period under examination the organisation received £19,602 (2023: £12,867) in income with expenditure of £16,937 (2023: £14,253) giving the group a Surplus of £2,665 (2023: a deficit of £1,386) for the period. Funds brought forward were £35,922 (2023: £37,308) giving a total reserve fund of £38,587 (2023: £35,922).

The charity's policy on reserves

The charity has no specific policy with regard to the level of reserves but aims to build a fund to contribute towards purchase of a building if possible. The charity currently holds £25,000 in a designated fund which is solely for the purpose to purchase and refurbish a building for the charity.

Accounting and reporting responsibilities

The Trustees are responsible for preparing the Trustees' annual report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (UK generally accepted accounting practice).

The law applicable to charities in England and Wales requires trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period. In preparing these financial statements, the trustee are required to:

- select suitable accounting policies and apply them consistently;

- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;

Recent research based on National Statistics has shown that average life expectancy for men in Hastings is 5 year shorter than for more affluent areas of the country and that men living in the most socially deprived areas of Hastings have a life expectancy 11.3 years shorter than more affluent areas. The Director for Public Health in East Sussex stated recently that " Loneliness and isolation is leading to mental and physical poor health."

Currently we rent premises at 20 Manhattan Gardens next to Ore Community Centre. Though old and in need of refurbishment the building provides good facilities with fully equipped wood and metalwork workshops at one end and a social area at the other. Minor repairs and improvements continue to be made with the assistance of grants from Big Local and other bodies for which the Shed is most grateful but much still needs to be done.

The Shed is normally open for three and half days per week with at least one volunteer Trustee in attendance at all times. There is a modest £5 fee to become a Member and a charge of £2 per day attended.

There are currently five volunteer Trustees, elected by the Members, who manage the day-to-day operation of the Shed.

Community Support and Social Value

We believe our Shed adds social value to the community in a number of ways:

- the Members themselves benefit from having a productive activity and engaging with a community, thus reducing social isolation and depression and facilitating better cognitive functioning and improved mental wellbeing. This in turn has an effect in reducing social care costs;
- where they have them, members families and/or carers benefit from the relief given by having a secure and caring environment where the members can spend time productively;
- the local community benefits from having a low-cost source for craft items and repairs.

We know we have an impact on the families of our members as well as our members themselves., Comments such as the Shed "provides a lifeline", "you've given me my husband back", "my dad has got a purpose again", are not uncommon.

The Impact of the Pandemic

The Shed nearly had to close permanently during the Covid because it lost all of its 'self-earned' income. Fortunately it received a number of small grants which enabled it to re-open after the pandemic though attendance was initially much reduced despite the increased need as people were reluctant to mix again initially.

Current Position

The Shed is now growing strongly with membership having increased from 108 last year to around 150 at the present time. The Shed is slowly being re-equipped with the aid of grants and donations and is collaborating with other local community organisations to a greater extent. Both the need for and the provision services is growing.

The Charity still faces two big issues however if it is continue and expand:

- 'self-earned' income will never meet both the costs of rental of a building and the other running costs. If the Charity is to be self-sufficient financially for the longer term it needs to purchase a building or be provided with a building at peppercorn rent to remove the on-going cost of commercial rent. Unfortunately a grant application with a high expectation of success to purchase and re-furbish the current occupied building was finally refused putting us back to square one. We are now re-embarked on fund raising with a view to purchasing a building;

- more space is needed within the building to accommodate the increasing number of Members. Part of the under-utilised grounds has been cleared and covered storage is now being constructed with the help of grants from Big Local and others and assistance from the local Community Team from the probation service. When this is completed, materials currently stored inside the building will be moved into the new storage releasing space for expansion of the main workshop and the installation of additional work benches;

Future developments

The Shed now has four aims for the next year or two:

- to continue to meet the expanding demand for its services;
- to secure its financial future. Originally the Shed was largely financially independent meeting most of its running costs from attendance fees and sales. The aim now is to return to that financial independence and security by fundraising to purchase the building that it currently rents and thus lowering its running costs significantly to within its income, or by re-locating to cheaper premises if any can be found;

- to complete the expansion of the buildings working space to meeting the increasing demand;

- to increase the range of activities of the Shed to interest a larger number of potential Members. The Shed building has surrounding grounds with potential to be developed as a community garden to service both the Members and local community. The Shed is currently in discussion with Ore-in-Bloom with a view to collaborating to develop a community garden.

Financial review

Hastings & St Leonards Men's Shed is funded by membership fees, sales and small grants. In the period under examination the organisation received £12,867 (2022: £18,296) in income with expenditure of £14,253 (2022: £15,811) giving the group a deficit of £1,386 (2022: a surplus of £2,485) for the period. Funds brought forward were £37,308 (2022: £34,823) giving a total reserve fund of £35,922 (2022: £37,308).

The charity's policy on reserves

The charity has no specific policy with regard to the level of reserves but aims to build a fund to contribute towards purchase of a building if possible. The charity currently holds £25,000 in a designated fund which is solely for the purpose to purchase and refurbish a building for the charity.



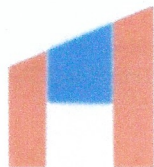

Hastings and St Leonards Men's Shed follows Charity Commission Guidelines and must report annually to the Charity Commission to affirm its obligation to function for the public benefit. In planning activities, the trustees were mindful of the Charity Commission's guidance on public benefit.

Summary of main objectives, activities and achievements for the period

Hastings and St Leonards Men's Shed was set up in October 2016 by representatives of Ore Valley Big Local which was administered by Orbit Housing Association, now Hastings Voluntary Action. The Shed is aimed primarily at older men (though there are also lady members), a group traditionally under represented in community and social activities. Loneliness, isolation and depression are high risk factors for this group.

The health impact of loneliness has been documented by the Campaign to end Loneliness, whose report in 2015 shows that lacking social connections is as damaging to our health as smoking 15 cigarettes a day. Social networks and friendships not only have an impact on reducing the risk of mortality or developing certain diseases, but they also help individuals to recover when they do fall ill. The report showed that

- 17% of older people are in contact with family, friends and neighbours less than once a week and 11% are in contact less than once a month.
- Over half (51%) of all people aged 75 and over live alone.
- Two fifths of all older people (about 3.9 million) say the television is their main company.
- 63% of adults aged 52 or over who have been widowed, and 51% of the same group who are separated or divorced report, feeling lonely some or all of the time.
- 59% of adults aged over 52 who report poor health say they feel lonely some of the time or often, compared to 21% who say they are in excellent health.

Shed structure and activities

The Men's Shed aims to mitigate these problems of social isolation by providing workshops and meeting spaces where Members can pursue craft and social activities within the Shed community whilst also serving the local community. Members can pursue their own projects but some also make goods or repair donated goods and furniture, often from re-cycled materials, which are sold to the local community at modest price. This helps to defray the running costs and also meet a local community need in one of the most deprived areas of the country.

Currently we rent premises at 20 Manhattan Gardens next to Ore Community Centre. Though old and in need of refurbishment the building provides good facilities with fully equipped wood and metalwork workshops at one end and a social area at the other. Some repairs have been carried out by the membership during the year including weatherproofing the building and replacing the failing lighting in the main workshop, but there remains a substantial amount to do.

Membership has increased to 118 over the last year and ranges from the able-bodied to the vulnerable including, for example, people with Autism, and some Dementia sufferers who can attend with carers if necessary.

The Shed is normally open for three and half days per week with at least one volunteer Trustee in attendance at all times. There is a modest £5 fee to become a Member and a charge of £2 per day attended.

There are currently five volunteer Trustees, elected by the Members, who manage the day-to-day operation of the Shed.

Community support and social value

We believe our Shed adds social value to the community in a number of ways:

- the Members themselves benefit from having a productive activity and engaging with a community, thus reducing social isolation and depression and facilitating better cognitive functioning and improved mental wellbeing. This in turn has an effect in reducing social care costs;
- where they have them, members families and/or carers benefit from the relief given by having a secure and caring environment where the members can spend time productively;
- the local community benefits from having a low-cost source for craft items and repairs.

The impact of the Pandemic

The pandemic has had a dramatic detrimental impact on the Shed's activities and its membership in three ways:

- Covid contributed to the death of several members;
- restrictions on the levels of service that were able to be provided and opening hours;
- Members increasing concerns about being in contact with other people because of the risk of infection and stopping attending;
- removing its financial independence.

The Shed was required to close completely during the first lockdown and for a short period at the end of 2021 when no Members could attend. Some communication was retained by correspondence with all Members and by telephone with the most vulnerable. The Shed was made 'Covid Secure' and partially re-opened but that required further restricting numbers attending. Despite increasing membership, attendance at the Shed reduced during the Pandemic due to some Members and Trustees having to shield and others avoiding attending due to concerns about rising infection levels in the area and the need to reduce contact with other people.

The Shed re-opened fully during the year and attendance is picking up again, though still below peak pre-Covid levels.

The closing of the Shed resulted in an almost total loss of the Shed's income and the reduction in attendance caused a further substantial loss which could have led to the Shed's permanent closure. Fortunately, however, the Shed was able to negotiate a reduced rent and was awarded a number of small, but much appreciated, grants which gave it financial security through the Pandemic and facilitated re-opening.

Progress during the year

Good progress has been made during the year in reviving the Shed's main activities. Progress has also been made towards achieving financial independence in that the Shed now has a designated fund of £25,000 towards the purchase a building through a combination of fundraising and grant awards. A detailed work specification and costing has been prepared for the purchase, repair and refurbishment of the building that we currently rent and further grant support is being sought.

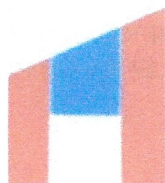

Governance and management

The charity is operated under the rules of its constitution, adopted 12th July 2017 and registered with the Charity Commission on 10th October 2017.

Public benefit statement

Hastings and St Leonards Men's Shed follows Charity Commission Guidelines and must report annually to the Charity Commission to affirm its obligation to function for the public benefit. In planning activities, the trustees were mindful of the Charity Commission's guidance on public benefit.

Summary of main objectives, activities and achievements for the period

Hastings and St Leonards Men's Shed was set up in October 2016 by representatives of Ore Valley Big Local which was administered by Orbit Housing Association, now Hastings Voluntary Action. The Shed is aimed primarily at older men (though there are also lady members), a group traditionally under represented in community and social activities. Loneliness, isolation and depression are high risk factors for this group.

The health impact of loneliness has been documented by the Campaign to end Loneliness, whose report in 2015 shows that lacking social connections is as damaging to our health as smoking 15 cigarettes a day. Social networks and friendships not only have an impact on reducing the risk of mortality or developing certain diseases, but they also help individuals to recover when they do fall ill. The report showed that

- 17% of older people are in contact with family, friends and neighbours less than once a week and 11% are in contact less than once a month.
- Over half (51%) of all people aged 75 and over live alone.
- Two fifths of all older people (about 3.9 million) say the television is their main company.
- 63% of adults aged 52 or over who have been widowed, and 51% of the same group who are separated or divorced report, feeling lonely some or all of the time.
- 59% of adults aged over 52 who report poor health say they feel lonely some of the time or often, compared to 21% who say they are in excellent health.

Shed structure and activities

The Men's Shed aims to mitigate these problems of social isolation by providing workshops and meeting spaces where Members can pursue craft and social activities within the Shed community whilst also serving the local community. Members can pursue their own projects but some also make goods or repair donated goods and furniture, often from re-cycled materials, which are sold to the local community at modest price. This helps to defray the running costs and also meet a local community need in one of the most deprived areas of the country.

Currently we rent premises at 20 Manhattan Gardens next to Ore Community Centre. Though old and in need of refurbishment the building provides good facilities with fully equipped wood and metalwork workshops at one end and a social area at the other. Minor repairs have been carried out by the membership during the year to weatherproof the building but there remains a substantial amount to do.

Membership has increased to 108 over the last year and ranges from the able-bodied to the vulnerable including, for example, people with Autism, and some Dementia sufferers who can attend with carers if necessary.

The Shed is normally open for three and half days per week with at least one volunteer Trustee in attendance at all times. There is a modest £5 fee to become a Member and a charge of £2 per day attended.

There are currently four volunteer Trustees, elected by the Members, who manage the day-to-day operation of the Shed.

The impact of the Pandemic

The pandemic has had a dramatic detrimental impact on the Shed's activities and its membership in three ways:

- restrictions on the levels of service that were able to be provided and opening hours;
- Members increasing concerns about being in contact with other people because of the risk of infection and stopping attending;
- removing its financial independence.

The Shed was required to close completely during the first lockdown and for a short period at the end of 2021 when no Members could attend. Some communication was retained by correspondence with all Members and by telephone with the most vulnerable. The Shed was made 'Covid Secure' and partially re-opened but that required further restricting numbers

attending at any one time in order to achieve social distancing. Under Tier 2 Guidance attendance was further restricted to only those needing support.

Despite increasing membership, attendance at the Shed reduced during the Pandemic due to some Members and Trustees having to shield and others avoiding attending due to concerns about rising infection levels in the area and the need to reduce contact with other people.

The closing of the Shed resulted in an almost total loss of the Shed's income and the reduction in attendance caused a further substantial loss which could have led to the Shed's permanent closure. Fortunately, however, the Shed was able to negotiate a reduced rent and was awarded a number of small, but much appreciated, grants which gave it financial security through the Pandemic.

Future developments

The shed now has three aims for the next year or two:

- to secure its financial future. Originally the Shed was largely financially independent meeting most of its running costs from attendance fees and sales. The aim now is to return to that financial independence and security by fundraising to purchase the building that it currently rents and thus lowering its running costs significantly to within its income, or by re-locating to cheaper premises if any can be found;
- to raise the confidence of the membership so that they feel able to return to the Shed since restrictions have been removed and most of the membership has been fully vaccinated;
- to increase the range of activities of the Shed to interest a larger number of potential Members. The Shed building has surrounding grounds with potential to be developed as a garden with a view to offering gardening as a new activity and an outdoor space for leisure.

Community support and social value

We believe our Shed adds social value to the community in a number of ways:

- the Members themselves benefit from having a productive activity and engaging with a community, thus reducing social isolation and depression and facilitating better cognitive functioning and improved mental wellbeing. This in turn has an effect in reducing social care costs;
- where they have them, members families and/or carers benefit from the relief given by having a secure and caring environment where the members can spend time productively;
- the local community benefits from having a low-cost source for craft items and repairs.

We know we have an impact on the families of our members as well as our members themselves., Comments such as the Shed "provides a lifeline", "you've given me my husband back", "my dad has got a purpose again", are not uncommon.

Financial review

Hastings & St Leonards Men's Shed is funded by membership fees, sales and small grants. In the period under examination the organisation received £30,414 (2020: £20,855) in income with expenditure of £12,099 (2020: £10,414) giving the group a surplus of £18,315 (2020: £10,441) for the period. Funds brought forward were £16,508 (2020: £6,067) giving a total reserve fund of £34,823 (2020: £16,508).

The charity's policy on reserves

The charity has no specific policy with regard to the level of reserves but aims to build a fund to contribute towards purchase of a building if possible.

Accounting and reporting responsibilities

The Trustees are responsible for preparing the Trustees' annual report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (UK generally accepted accounting practice).
