Report of the trustees for the year ended 31st October 2023

The trustees present their annual report and financial statements of the charity for the year ended 31st October 2023. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's trust deed, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland published (FRS 102) (effective 1 January 2019).

Objectives and activities

The Cindy Appleyard Foundation provides small grants to families who have a child in a hospital for an extended period of time, often far away from home. The purpose of the grants is to help families meet costs such as temporary accommodation near their child, travelling to and from the hospital and taking time off work.

The Cindy Appleyard Foundation launched on 15 February 2018 and gave out its first grant to a family with a sick child in Great Ormond Street Hospital in April 2018. From then until the end of October 2023, the charity has given £87,375 out in grants to families with children in hospitals across the UK including The Freeman Hospital in Newcastle and Great Ormond Street Hospital – grants range from £100 to £300 depending on need. Over the last year, grants have been given to families in GOSH and many from the Young Lives vs Cancer support team there and at other sites across the country.

The grants have alleviated the financial hardship experienced by parents who have a child in a specialist hospital unit. The specialist unit maybe a significant distance from the family home so a family has been uprooted - extra travel costs are incurred, loss of earnings as one or both parents gives up work to be with their child, ongoing bills to pay. Many families are suffering severe financial hardship, they often have other children in the family so financing childcare also an issue.

Since the charity began up until end Oct 2023, we have provided financial support to over 360 families residing in the UK. The children have been aged from one month to 16 and have predominantly been in patients with life-threatening or life-limiting conditions.

A review of our achievements and performance: How our activities delivered public benefit

The charity has close links with The Freeman Hospital in Newcastle, and particularly Great Ormond Street Hospital in London. And, we have been working with and supporting the charity 'Young Lives vs Cancer' who are based at various hospitals in the UK. At these hospitals there is good awareness of the charity among family liaison officers and other social support staff and we regularly receive grant applications on behalf of parents whose children are being treated at them. The grants have alleviated the financial hardship experienced by families at these hospitals.

We receive many thank you emails from support workers such as:

"Thank you so much for all your support for our families this year. You have made such a huge difference to them and we are extremely grateful for what you do."

In 2023 we had our website re-designed by WeDo as a donated service.

Financial review

The management committee have reviewed the accounts and consider them to be satisfactory.

Investment powers and policy

The trustees, having regard to the liquidity requirements of operating the charity, will keep available funds in an interest bearing deposit account should reserves become substantial.

Reserves policy and going concern

The balance held in unrestricted reserves at 31st October 2023 was £6,090 all of which are free reserves.

The trustees aim to maintain free reserves in unrestricted funds at a level which equates to approximately three months of unrestricted charitable expenditure. The trustees consider that this level will provide sufficient funds to respond to applications for grants and ensure that support and governance costs are covered.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

Plans for Future Periods

The charity will continue all efforts in general fundraising from all avenues – event fundraising, challenge fundraising, relationship fundraising, corporate fundraising. All of which have been successful so far.

More efforts will be channelled, particularly, into Corporate Fundraising as we feel we have a unique offer for CSR programmes.

Appointment of trustees

New trustees are appointed by existing trustees and serve for three years after which they may put themselves forward for re-appointment. The Trust Deed provides for a minimum of three trustees, to a maximum of twelve trustees.

At the half yearly trustee meetings, the trustees agree the broad strategy and areas of activity for the Charity, including investment, reserves and risk management policies and performance. The day to day administration of the Charity is delegated to Emily Lyons.

Trustee induction and training

The trustees are looking at accessing some free online training.

Trustees responsibilities in relation to the financial statements

The charity trustees are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

The law applicable to charities in England and Wales requires the charity trustees to prepare financial statements for each year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, of the charity for that period. In preparing the financial statements, the trustees are required to:

- Select suitable accounting principles and then apply them consistently;
- Observe the methods and principles in the applicable Charities SORP;
- Make judgments and estimates that are reasonable and prudent;

- State whether applicable accounting standards have been followed, subject to any material departures that must be disclosed and explained in the financial statements;
- Prepare the financial statements on a going concern basis unless it is appropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities Act 2011, the applicable Charities (Accounts and Reports) Regulations, and the provision of the Trust deed. They are also responsible for safeguarding the assets of the charity and taking reasonable steps for the prevention and detection of fraud and other irregularities.

Notes to the accounts for the year ended 31 October 2023

1. Accounting policies**(a) Basis of preparation and assessment of going concern**

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 1st January 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011. The charity constitutes a public benefit entity as defined by FRS 102.

(b) Funds structure

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by the donor or trust deed. There are no restricted funds.

Unrestricted income funds comprise those funds which the trustees are free to use for any purpose in furtherance of the charitable objects. Unrestricted funds include designated funds where the trustees, at their discretion, have created a fund for a specific purpose.

(c) Income recognition

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

Donations are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to conditions that require a level of performance before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that those conditions will be fulfilled in the reporting period.

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank. Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

(d) Expenditure Recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

All expenditure is accounted for on an accruals basis. All expenses including support costs and governance costs are allocated or apportioned to the applicable expenditure headings. For more information on this attribution refer to note (f) below.

(e) Irrecoverable VAT

Irrecoverable VAT is charged against the expenditure heading for which it was incurred.

(f) Allocation of support and governance costs

Support costs have been allocated between governance costs and other support costs. Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to independent examination and legal fees together with an apportionment of overhead and support costs.

Governance costs and support costs relating to charitable activities have been apportioned based on type of expense. The allocation of support and governance costs is analysed in note 4.

(g) Costs of raising funds

The costs associated with raising funds are Just Giving fees, marathon entry fees and marathon t-shirt printing.

(h) Charitable Activities

Costs of charitable activities include governance costs and an apportionment of support costs as shown in note 5.

Notes to the accounts for the year ended 31 October 2023

(i) Tangible fixed assets and depreciation

All assets costing more than £500 are capitalised and valued at historical cost.

(j) Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and their opening carrying value or their purchase value if acquired subsequent to the first day of the financial year. Unrealised gains and losses are calculated as the difference between the fair value at the year end and their varying value. Realised and unrealised investment gains and losses are combined in the Statement of Financial Activities.

(k) Pensions

The charity currently does not operate a pension scheme.

(l) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

(m) Creditors and Provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of the funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(n) Grant Making

Grants are awarded by a panel in line with the charitable objects and are made to individual families suffering hardship as a result of their children needing hospital treatment in specialist hospitals. These hospitals are often located far away from the child's home. An NHS worker assigned to the family will recommend that the family applies for the grant and will sign the grant application form to confirm eligibility.

2. Related party transactions and trustees' expenses and remuneration

The trustees all give freely their time and expertise without any form of remuneration or other benefit in cash or kind. Expenses paid to the trustees in the period totalled £nil (2022: £nil).

The Cindy Appleyard Foundation launched on 15 February 2018 and gave out its first grant to a family with a sick child in Great Ormond Street Hospital in April 2018. From then until the end of October 2022, the charity has given £65,200 out in grants to families with children in hospitals across the UK including The Freeman Hospital in Newcastle and Great Ormond Street Hospital. More recently, grants have been given to families in GOSH and many from the Young Lives vs Cancer support team there and at other sites across the country.

The grants have alleviated the financial hardship experienced by parents who have a child in a specialist hospital unit. The specialist unit maybe a significant distance from the family home so a family has been uprooted - extra travel costs are incurred, loss of earnings as one or both parents gives up work to be with their child, ongoing bills to pay. Many families are suffering severe financial hardship, they often have other children in the family so financing childcare also an issue.

Since the charity began up until end Oct 2022, we have provided financial support to 271 families residing in the UK – average grant amount is £240. The children have been aged from one month to 16 and have predominantly been inpatients with life-threatening or life-limiting conditions.

In June 2022, the charity won Charity of the Year support from Jacobs, an engineering firm in Manchester. The relationship runs June 2022 until June 2023, with a £5000 target. This is also match funded by Benevity, which is a global grant management platform.

This corporate support has helped us develop a Corporate Fundraising offer which we are hoping to use to attract further support from companies through their CSR programmes.

A review of our achievements and performance: How our activities delivered public benefit

The charity has close links with The Freeman Hospital in Newcastle, and particularly Great Ormond Street Hospital in London. And, more recently, the charity 'Young Lives vs Cancer' who are based at various hospitals in the UK. At these hospitals there is good awareness of the charity among family liaison officers and other social support staff and we regularly receive grant applications on behalf of parents whose children are being treated at them. The grants have alleviated the financial hardship experienced by families at these hospitals. We have received some direct testimonials from families who have thanked us for our support. For example:

"We just wanted to say a HUGE thank you for the money you gave us whilst our daughter is in GOSH hospital.

Our girl got her gift of a heart transplant back in June 2021. Sadly, it has not been an easy journey or recovery for her and nearly 8 months later we're still here.

However, the picture is becoming brighter. After trying every drug, piece of kit and skill CICU have, she finally got moved to a HDU ward. She still has a trachy, but happily came off CPAP ventilator support 6 days ago and is now tolerating oxygen.

The grant you sent to us really really helps make a difficult situation feel a little bit easier. Knowing someone out there gets how this feels, is also a big comfort.

Thank you so much for throwing light into the darkness. We hope you continue to be able to help other families like us in the years to come."

Financial review

The management committee have reviewed the accounts and consider them to be satisfactory.

Investment powers and policy

The trustees, having regard to the liquidity requirements of operating the charity, will keep available funds in an interest bearing deposit account should reserves become substantial.

Reserves policy and going concern

The balance held in unrestricted reserves at 31st October 2022 was £3,012 (2021: £1,787) all of which are free reserves.

The trustees aim to maintain free reserves in unrestricted funds at a level which equates to approximately three months of unrestricted charitable expenditure. The trustees consider that this level will provide sufficient funds to respond to applications for grants and ensure that support and governance costs are covered.

Risk management

The trustees have conducted a review of the major risks to which the charity is exposed and systems have been established to mitigate those risks.

Plans for Future Periods

The charity will continue all efforts in general fundraising from all avenues – event fundraising, challenge fundraising, relationship fundraising, corporate fundraising. All of which have been successful so far.

More efforts will be channelled, particularly, into Corporate Fundraising as we feel we have a unique offer for CSR programmes.

The charity will be rolling out a more detailed marketing strategy to include further social media campaigns, e-news bulletins for example.

Appointment of trustees

New trustees are appointed by existing trustees and serve for three years after which they may put themselves forward for re-appointment. The Trust Deed provides for a minimum of three trustees, to a maximum of twelve trustees.

At the half yearly trustee meetings, the trustees agree the broad strategy and areas of activity for the Charity, including investment, reserves and risk management policies and performance. The day to day administration of the Charity is delegated to Emily Lyons.

Trustee induction and training

The trustees are looking at accessing some free online training.

The charity trustees are responsible for preparing a trustees' annual report and financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Notes to the accounts for the year ended 31 October 2022

1. Accounting policies

(a) Basis of preparation and assessment of going concern

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 1st January 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011. The charity constitutes a public benefit entity as defined by FRS 102.

(b) Funds structure

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by the donor or trust deed. There are no restricted funds.

Unrestricted income funds comprise those funds which the trustees are free to use for any purpose in furtherance of the charitable objects. Unrestricted funds include designated funds where the trustees, at their discretion, have created a fund for a specific purpose.

(c) Income recognition

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

The costs associated with raising funds are Just Giving fees, marathon entry fees and marathon t-shirt printing.

(i) Tangible fixed assets and depreciation

The Cindy Appleyard Foundation provides small grants to families who have a child in a specialist hospital a long way from their home. The purpose of the grants is to help families meet costs such as temporary accommodation near their child, travelling to and from the hospital and taking time off work.

The Cindy Appleyard Foundation launched on 15 February 2018 and gave out its first grant to a family with a sick child in Great Ormond Street Hospital in April 2018. From then until the end of October 2020, the charity has given £39,850 out in grants to families with children in hospitals across the UK including The Freeman Hospital in Newcastle and Great Ormond Street Hospital. In the year ending Oct 2020 alone, the charity distributed £22,760 to 101 families.

In March 2020, fundraising activities were halted due to the COVID19 pandemic. Nevertheless, the charity did raise over £20,000 over the course of the year including taking part in the Brighton Half Marathon and donations from Corporations/Family & Friends. This meant that the charity was able to continue its operations throughout the pandemic. See below for more information.

The grants have alleviated the financial hardship experienced by parents who have a child in a specialist hospital unit. The specialist unit maybe a significant distance from the family home so a family has been uprooted - extra travel costs are incurred, loss of earnings as one or both parents gives up work to be with their child, ongoing bills to pay. Many families are suffering severe financial hardship, they often have other children in the family so financing childcare also an issue.

Since the charity began up until end Oct 2020, we have provided financial support to 164 families in England who have had children in hospitals in London, Newcastle and Brighton. The children have been aged from one month to 16 and have predominantly been inpatients with life-threatening or life-limiting conditions.

Regarding COVID:19, the charity has been affected in the following ways;

1. Restrictions have meant that some parents have had to stay at hospital where they usually would have travelled.
2. Patient visitors have been limited.
3. Fundraising efforts have been seriously affected as all events had to be cancelled and are still not allowed.
4. Families stresses and worries have increased due to the situation, parents being furloughed means more families suffering financial hardship.
5. Families need for support has not changed and if anything has increased due to the above points raised.

Notes to the accounts for the year ended 31 October 2020

1. Accounting policies**(a) Basis of preparation and assessment of going concern**

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 1st January 2019 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011. The charity constitutes a public benefit entity as defined by FRS 102.

(b) Funds structure

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by the donor or trust deed. There are no restricted funds.

Unrestricted income funds comprise those funds which the trustees are free to use for any purpose in furtherance of the charitable objects. Unrestricted funds include designated funds where the trustees, at their discretion, have created a fund for a specific purpose.

(c) Income recognition

All income is recognised once the charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably. Donations are recognised when the charity has been notified in writing of both the amount and settlement date. In the event that a donation is subject to conditions that require a level of performance before the charity is entitled to the funds, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the charity and it is probable that those conditions will be fulfilled in the reporting period.

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the bank. Dividends are recognised once the dividend has been declared and notification has been received of the dividend due.

(d) Expenditure Recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

All expenditure is accounted for on an accruals basis. All expenses including support costs and governance costs are allocated or apportioned to the applicable expenditure headings. For more information on this attribution refer to note (f) below.

(e) Irrecoverable VAT

Irrecoverable VAT is charged against the expenditure heading for which it was incurred.

(f) Allocation of support and governance costs

Support costs have been allocated between governance costs and other support costs. Governance costs comprise all costs involving the public accountability of the charity and its compliance with regulation and good practice. These costs include costs related to independent examination and legal fees together with an apportionment of overhead and support costs.

Governance costs and support costs relating to charitable activities have been apportioned based on type of expense. The allocation of support and governance costs is analysed in note 4.

(g) Costs of raising funds

The costs associated with raising funds are Just Giving fees, marathon entry fees and marathon t-shirt printing.

(h) Charitable Activities

Costs of charitable activities include governance costs and an apportionment of support costs as shown in note 5.

Notes to the accounts for the year ended 31 October 2020

(i) Tangible fixed assets and depreciation

All assets costing more than £500 are capitalised and valued at historical cost.

(j) Realised gains and losses

All gains and losses are taken to the Statement of Financial Activities as they arise. Realised gains and losses on investments are calculated as the difference between sales proceeds and their opening carrying value or their purchase value if acquired subsequent to the first day of the financial year. Unrealised gains and losses are calculated as the difference between the fair value at the year end and their varying value. Realised and unrealised investment gains and losses are combined in the Statement of Financial Activities.

(k) Pensions

The charity currently does not administer contributions to an auto enrolment pension scheme on behalf of individuals as they do not employ any staff.

(l) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

(m) Creditors and Provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of the funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

(n) Grant Making

Grants are awarded by a panel in line with the charitable objects and are made to individual families suffering hardship as a result of their children needing hospital treatment in specialist hospitals. These hospitals are often located far away from the child's home. An NHS worker assigned to the family will recommend that the family applies for the grant and will sign the grant application form to confirm eligibility.

2. Related party transactions and trustees' expenses and remuneration

The trustees all give freely their time and expertise without any form of remuneration or other benefit in cash or kind. Expenses paid to the trustees in the period totalled £nil (2019: £nil).
