The trustees have assessed the major risks to which the charity is exposed and are satisfied that systems are in place to mitigate our exposure to major risks.


**Results**

### **Independent Examiner's Report to the Trustees of Knowledge of Light Foundation.**

I report on the accounts of Knowledge of Light Foundation for the year ended 31 March 2021, which are set out on pages 3 to 6.
