TRUSTEE'S REPORT FOR THE PERIOD ENDING 31 MARCH 2025

The trustees present their annual report together with the financial statements of the charitable company for the period of April 2024 to 31 March 2025. The annual report serves the purposes of both a trustee's report and a director's report under company law.

Governance, structure and management

a. CONSTITUTION

Al -Nasr Relief Agency is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the governing documents of the charity. The trustees of Al -Nasr Relief Agency are also the directors of the charity company for the purposes of company law. The charitable company is known as Al -Nasr Relief Agency.

Details of the trustees who served during the period are included in the reference and administrative details on page 1.

b. OBJECTIVES

The charity's objects are:

1. The prevention or relief of poverty by such means as the trustees in their absolute discretion shall from time to time decide.
2. The preservation and protection of good health of persons suffering from mental or physical illness of any description or in need of rehabilitation as a result of such illness, by the provision of health care resources, information, advice and guidance.
3. The relief and assistance of people in the Horn of Africa who are the victims of war or natural disaster, trouble, or catastrophe in particular by the supply of medical aid, shelter and food to such persons.

c. RECRUITMENT AND APPOINTMENT OR ELECTION OF TRUSTEES

The management of the charity is the responsibility of the trustees who are elected under the terms of conditions of the governing document as follows:

- 1) The charity in a general meeting shall elect the officers and the other trustees.
- 2) The trustees may appoint any person who is willing to act as a trustee. Subject to sub-clause 5 (b) of this clause, they may also appoint trustees to act as officers.
- 3) Each of the trustees shall retire with effect from the conclusion of the annual general meeting next after his or her appointment but shall be eligible for re-election at that annual general meeting.

Recruitment of members

- 1) Membership is open to individuals over eighteen or organisations who are approved by the trustees.
- 2). a) The trustees may only refuse an application for membership if, acting Reasonably and properly, they consider it to be in the best interests of the charity to refuse the application.

The trustees must inform the applicant in writing of the reasons for the refusal within twenty-one days of the decision

- b) The trustees must consider any written representations the applicant may make about the decision. The trustees' decision following any written representations must be notified to the applicant in writing but shall be final.
- 3.) Membership is not transferable to anyone else.

d. ORGANISATIONAL STRUCTURE

- 1) The charity and its property shall be managed and administered by a committee comprising the officers and other members elected in accordance with this constitution. The officers and other members of the committee shall be the trustees of the Charity and in this constitution, are together called 'the trustees'.
- 2) The charity shall have the following officers;
 - a) A Chair
 - b) A Secretary
 - c) A Treasurer
- 3) A trustee must be a member of the charity or the nominated representative of an organisation that is a member of the charity.

- 4) No one may be appointed a trustee if he or she would be disqualified from acting under the provisions of clause 20.
- 5) The number of trustees shall be not less than three but (unless otherwise determined by a resolution of the charity in general meeting) shall not be subject to any maximum.
- 6) The first trustees (including officers) shall be those persons elected as trustees and officers at the meeting at which this constitution is adopted.
- 7) A trustee may not appoint anyone to act on his or her behalf at meetings of the trustees.

e. POLICIES AND PROCEDURES ADOPTED FOR THE INDUCTION AND TRAINING OF TRUSTEES

The training and induction provided for new trustees will depend on their individual experience and expertise. Where necessary an induction will provide training on charity, legal and financial matters. All trustees will be provided with relevant documentation that they will need to understand their role as trustees and directors of Al -Nasr Relief Agency.
