



HUTTON FC ANNUAL GENERAL MEETING

SECRETARY REPORT

This has been the most difficult season for grassroots football. Coronavirus (Covid-19) has had a profound effect on the health of the nation and how we live our lives. We have also seen a massive impact on the Club and continue to see its effects now the season is finally over.

The Trustees and Management Committee have tried to steer a course to keep the members safe, and support as much football activity that our teams wanted. The Leagues our teams play in adopted various methods to finish their seasons which meant different experiences and outcomes however, their Officers received little help and guidance from the FA.

Progress has been made on our main priority which is to improve facilities. We had to obtain planning permission again on the new ground as Planners deemed the requirement from the Football Foundation for a different pitch layout to warrant another application. This has now been granted and pitch works will begin shortly. The Club continues to enjoy a positive relationship with the leadership of Brentwood Council which is useful not least with the proposed new football hub at the Brentwood Centre. Elsewhere the Club has managed to secure additional winter training venues and pitches.

Hutton FC is proud to add a disability section to the Club this season. Dan Franklyn and his team do a great job for children with Autism, and we hope to increase provision over time.

The Girls section goes from strength to strength with provision reaching down into the younger age groups. The partnership formed with Woodlands School has helped with facility provision.

On the pitch there were some great success stories with Trophies and titles won and struggling teams developing well. This was the first season Hutton FC has been able to participate in the Eastern Junior Alliance FL after years of trying to gain entry. This creates another pathway for the Club's stronger players and teams. Both female and male pathways through this football club are a key focus which needs support and constant improvement.

In any volunteer organisation there is always work to do in finding new people to help and keep the club relevant across all age groups. This season some of our key volunteers have suffered serious illnesses. We wish them well as they recover. We ask regularly for more volunteers, and this has also been a focus of the newsletter we now send to the membership. Without new volunteers the Club will be forced to scale back or look to start paying people which would mean higher fees for all.

Thank you to all Managers and Coaches across the Club for your efforts this season. Special thanks to the section secretaries that do so much for the Club: Kate Ayers, Stuart Hart, James Harrington, Billy Wells, Steve Clark, and Greg Hall. Of course, without the Officers and Trustees that do so much to keep the Club running we would not have a football club and they all deserve our appreciation.

Special thanks from me to Paul Mulley who not only is the Club Auditor but also is now preparing the accounts for submission to the Charities Commission and HMRC and putting together returns following the decision to register for VAT.

Hutton FC has a clear set of values which we expect our teams to adhere to. The Officers, Trustees and Committee members would do anything they could to help and support our teams as long as that is reciprocated. Let's hope 2021-22 is an easier season for everyone and the Club continues to move forward.
