



Club Trustee Report

AGM – 10th July 2023

The backdrop for grassroots sports continues to be difficult. Costs are rising, public and personal finances are not in good shape, facilities are not getting built and volunteers are increasingly hard to come by. There is very little recognition or support from Government, Local Authorities or Governing Bodies.

Hutton Football Club has performed well during the 2022-23 season against the various headwinds described above. We continue to run a large number of teams across both male and female pathways and there has been a lot of success on the pitch with multiple League Champions and Cup Winners. Thank you to all teams, and especially to all our managers who give up their time to organise and get the players out on the pitch every week both training and for matches.

The men's first team won the Essex Olympian Premier Division this season. The first time the Club has won the title or even got close to it. Well done to Matt, his management team, the players and everyone else in the Club that has supported the team over the years. Next season the team will be playing at Step 6 in the National League System for the first time. The team will be playing at Billericay Town FC which is a magnificent stadium for our level of football.

The promotion of the first team has come ahead of Club plans and brings forward the need to look at change within Hutton FC. Running a team in the National League System requires additional resources and the need to separate finances and management.

The provision of good facilities remains one of the biggest challenges. The Club has worked hard to get access to these, but they all come at a cost which is rising above the rate of inflation every year. Councils have no money to maintain pitches to any decent level which is another issue for everyone. Developing our own ground is still the best option to ease these pressures. Progress at Chelmsford Road has been slow. Nevertheless, we continue to move forward. Developing the ground into the finished article will take time and money which needs support from the whole Club and from outside.

There are other challenges too such as how to best manage a Club this size with such differing needs and ambitions. Breaking down the management of the different football sections and ability pathways would



seem the best way forward but that needs the involvement of more people. The introduction of the Mini Soccer and Youth Committee this season has filled a big gap and will hopefully lead to increased involvement in Club decisions and future development.

Thanks, as always to the Trustees of Hutton Football Club and everyone else that gives their time, free of charge, to run this organisation. We are told the economic and social we give to our community each season is in the region of £2m in value. A massive contribution which deserves more recognition and support than we are likely to get.

We, the Club, will never get everything right or please everyone. The challenges are big, and we have made many mistakes. We have also got a lot right and there is a massive opportunity to move forward and create a football Club to be proud of. This is your football club.

During the season Steve Clark took over as Club Secretary. Steve puts in a massive amount of work to work with our teams and support our management teams. Please work with Steve and respect his commitment.
