



Club Trustee Report

AGM – 8th July 2024

Finally, after 9 years of hard work and dedication the Club will open the new ground to be known as Flints Community Hub, in Chelmsford Road, Shenfield. The facility will become our home with a variety of pitches and a clubhouse to help bring the Club together. Even with the new ground the Club still needs a variety of facilities in other locations many of which are now outside our Borough. The Trustees welcome dialogue with the Local Authority and our Governing Body as to how the needs of Hutton FC can be met.

We are part of the FA Club Support scheme and Active Essex Organisation Development Support programme which are useful resources towards Club sustainability. One area that needs developing is engagement with our community. The Club needs to be open to this but also needs help to make those connections. The partnership with Shenfield High School is a step in the right direction but more work is needed.

The move to use the 360 fee pay system will be a big change for the Club which should bring a lot of benefits and will hopefully show how technology can assist with our administration. Our financial reserves have been run down as the commitment to the new ground has been met. A loan will be needed to complete the project. This was always likely to be the outcome as without a home how can any meaningful fundraising take place.

How the Club operates is also changing with Operations – Finance, Facilities and Administration – separating from the Football to bring in those with appropriate skill sets and allow the sections to manage the support and delivery of their own football areas. Succession planning is key to any organisation and the Club must look to the next generation to take Hutton FC forward.

Within the football sections the Club continues to move ahead. This was our first season with a team in the National League System and we now look to add a Women's Development team, Under 23's in the Essex Senior League, Under 16 Girls in the Junior Premier League and more teams in the Eastern Junior Alliance. All in addition to the many leagues we already participate in this involves extra commitment and club resources.

In other news the Club hopes to finalise the partnership with West Ham United Academy which will give access to talent identification, games with Academy or Elite Development teams, staff development and a higher profile for Hutton FC.

The charity has provided a deposit bond to Essex County Council to be used as a performance bond for provision of a crossing granted as part of the planning for the development of the new site. The amount held by Essex County Council is £19500. It will be repaid once the crossing has been installed and paid for or 5 years when the planning lapses. Costs to be incurred for the provision of the crossing are not known but could be as high as £19500. The full amount has been provided in the accounts as the amount recoverable cannot be established and will ultimately be required to provide the crossing. The net debtor shown from Essex County Council is £nil.

The charity will be dependent on loans from two of the Trustees who have agreed to provide in total £80,000 so that the development and provision of football pitches and club facilities can be completed. The loans will carry an interest rate determined to be the bank of England base rate with a repayment period of up to 10 years. The charity is dependent upon these loans together with other fund raising activities and fees increase to continue as a going concern. Notwithstanding this the charity will need to focus on reducing costs and tighten up expenditure authorisation processes to continue as a going concern.
