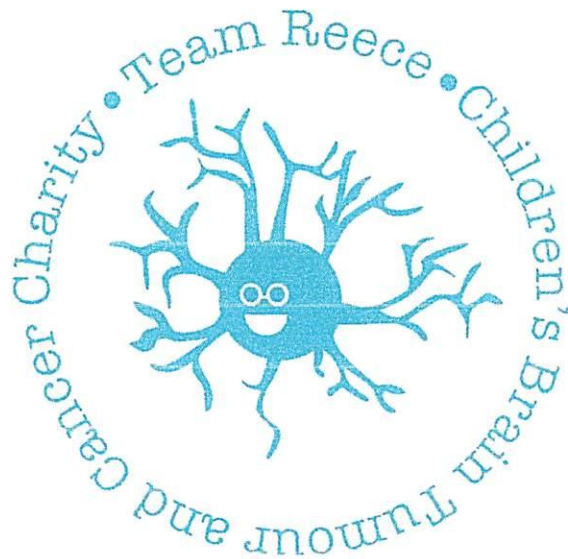

Report for the trustees for the period ended 31st January 2023

The trustees present their annual reports of the charity for the year ending 31st January 2023. The financial statements have been prepared in accordance with the accounting policies set out in the Team Reece Children's Brain Tumour & Cancer Charity's financial policies and comply with the Team Reece Children's Brain Tumour & Cancer Charity's constitution, Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), and the Charities Act 2011.

Structure, governance, and management

Description of the charity's constitution

Team Reece Children's Brain Tumour & Cancer Charity is a registered charity and controlled by its constitution contained in the trust deed dated 7 April 2016. The charity was formed and entered in the register of charities on 1st November 2017 as a Charitable Incorporated Organisation (charity number CE0011949).

New trustees are elected and appointed by existing trustees and serve for three years after which they may put themselves forward for reappointment. The constitution provides for a minimum of three trustees up to a maximum of twelve trustees. At quarterly trustee meetings, the trustees agree the broad strategy and areas of activity for the charity. They take into consideration research grant making, reserves, risk management policies and charity performance. The day-to-day administration and processing of the charity is delegated to the chief executive, the office manager and fundraising coordinator. Currently the governing body consists of three trustees.

The charity is the realisation of Reece Holt who while fighting an aggressive brain tumour wanted to help others in his position and fund research to provide better outcomes than he faced, Reece passed away aged 13 after a two and a half year battle most of which he spent campaigning and raising funds for Team Reece, in the wake of Reece's passing we now continue his legacy to raise awareness, fund a holiday home, research and educational support alongside general support to children and families facing a childhood cancer diagnosis. The aims of Team Reece are to help save the lives of other children from cancer through research and raising awareness. We also offer holidays to families affected by childhood cancer and educational tools to assist with school.

Appointment of new trustees

The trustees may at any time appoint one or more new trustees. The selection of trustees is based on vacancies and appropriate governance skills, an ability to commit the necessary time as a trustee and empathy with the objects of the charity. The existing trustees comply with the ICSA guide, "Recruitment, appointment and Induction of Charity Trustees, and brief new trustees on the history of the charity and the powers and responsibility of the board. New trustees are given briefings on the content of the trust constitution, decision making processes and financial performance of the charity, and a copy of the Charity Commission's guidance, "The essential Trustee: What you need to Know". On appointment, new trustees sign a model trustee declaration statement and receive copies of the minutes of the last 3 trustee meetings and a copy of the Trust's constitution.

New trustees are given briefings on the content of the trust constitution, decision making processes and financial performance of the charity, and a copy of the Charity Commission's guidance, "The essential Trustee: What you need to Know". On appointment, new trustees sign a model trustee declaration statement and receive copies of the minutes of the last 3 trustee meetings and a copy of the Trust's constitution.

Any trustee can resign from office at any time by serving one month's written notice to the other trustees, when conflicts of interest occur, trustees are required to disclose all relevant interests and register them. In accordance with trust policy, trustees must withdraw from specific decisions where a conflict of interest arises. Neither the trust nor the trustees have interests with the pharmaceutical industry; but any such interests would be disclosed.

Risk management

The trustees have considered the major risks to which the charity is exposed and have reviewed systems and procedures to manage this risk. Our major operational risk is the extent to which the research grants awarded successfully advance the knowledge to the benefit of children with cancer. The trustees manage this risk by working in partnership with Alder Hey Children's Hospital and in particular consultants in the oncology dept to ensure that the most appropriate and beneficial projects have grants awarded, however with the nature of research the risk cannot be eliminated. Applications for a holiday must be countersigned by a member of the child's care team or a direct referral from the care team at the treating hospital or a scanned copy of diagnosis letter sent in to ensure holidays are allocated to families with a child with a cancer diagnosis.

To minimise risk and potential conflict, we have several other policies in place including Conflicts of Interest policy, Code of conduct policy and Data protection policy.

Trustees' responsibilities statement

Team Reece Children's Brain Tumour & Charity are responsible for the preparation of the Trustees Annual Report and the financial statements in accordance with applicable law and regulations. The trustees are responsible for keeping accounting records which disclose with reasonable accuracy the financial position of the charity and enable them to ascertain to ensure that the financial statements comply with the Charities Act 1993, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the Trust constitution. The Charity is responsible for the maintenance and integrity of the charity and financial information included on the charity's website.

Charity objectives and activities

Objectives

To preserve the health and relieve the needs of children diagnosed with cancer in particular but not exclusively by:

- the provision of a respite holiday in a caravan(s) for children who are suffering from cancer and their families or carers.
- the provision of days out for children with cancer, their siblings and their friends.
- the provision of research funding to enable better treatment options and potential cures for childhood cancer, in particular brain tumours and help fund new equipment and clinical trials for children where promise is shown but NHS funding is unavailable.
- the provision of support in school (assemblies and class to educate peers on cancer treatment and effects), and equipment for educational support for children undergoing treatment for cancer, either directly or to the child's school.

Activities of Team Reece Children's Brain Tumour & Cancer Charity

Team Reece Children's Brain Tumour & Cancer Charity are indebted to our volunteers who have once again given their time and efforts over the last year, including assisting at events, fundraising, and raising awareness of childhood cancer. With their help we have been able to achieve more than expected and are thankful for all the help and donations be that financially or time helping us to help make lives easier for children fighting cancer.

In planning our activities during our trustee meetings, we keep in mind the Charity Commission guidance with regard to public benefit.

Achievements and Performance

The trustees are satisfied with the financial position of the charity at the period end. In particular we have received some large donations from companies such as Lancaster and Morecambe Crematorium and Unite the union, and as in previous years the continued support from the public has been truly outstanding with supporters continually taking on challenges to safely raise funds for us to improve the lives of children facing cancer.

This year saw the use of Reece's Retreat by families affected by childhood cancer fully booked with two families a week using the holiday home. We had more applications than we could help and had to prioritise use. We also continued to provide grants towards to travel costs and spending money and paid for activities for families and where we had to decline a holiday due to the volume of bookings we offer a grant/gift instead. The feedback from our families has again been exceptional and being offered holidays at Reece's Retreat has made a direct positive impact of the lives of children fighting cancer and their families.

In May Rachel was nominated for and won the most inspiration person of the year at the Sunshine Awards for her tireless work with the charity, helping others and to raise awareness of Childhood Cancer.

We ran the same campaign for Childhood Cancer Awareness Month in September as the previous year, seeing businesses, local care homes, schools, homes across the bay community and our local hospital (Royal Lancaster Infirmary) decorating their workspaces, windows, and businesses go to raise awareness of childhood cancer.

In Oct we held our larger Halloween walk which was again hugely successful and is now an annual event.

We would like to extend thanks to all who have supported us during this year and to all the businesses who have donated Auction and Raffle prizes throughout the year, enabling us to raise more funds at our events.

Mentions to Lancaster and Morecambe Crematorium, Unite, Beyond Radio, the emergency Services, Brent at BCL Lighting and Lancaster Royal Grammar School for their continued support this year.

The support, in particular from our local community, businesses and hospital in raising awareness of childhood cancers and subsequently raising money to assist us with our objectives, has been as always phenomenal and been a major factor in enabling us to continue Reece's legacy.

Financial Review

The trustees have reviewed the accounts and are happy with the financial position of the charity at the end of the period. Our main income for the year has been from public donations along with monies raised from fundraising events. All income received is unrestricted.

Reserves policy

The Charity undertakes to ensure that a contingency reserve of the previous year's recurrent expenditure in relation to the site fees for the caravan is retained to cover periods of reduced income or unexpected costs. An amount of £6,000 has been allocated to designated funds for this purpose.



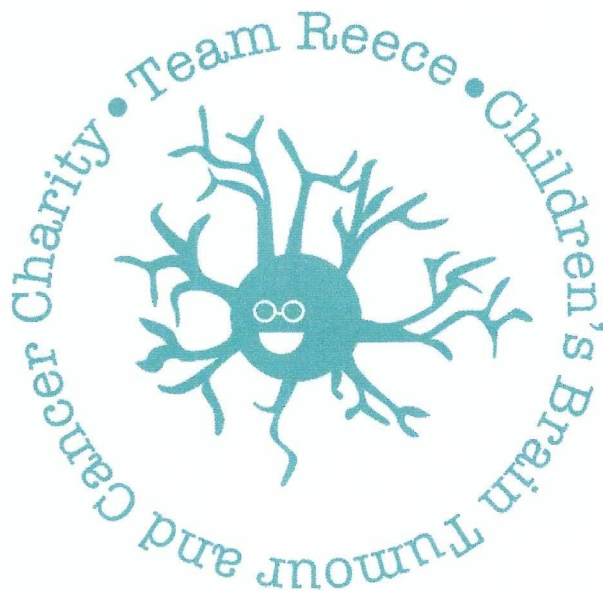

In the wake of covid and some restrictions still in place we took the decision not to hold any major events in the first half of 2021, however as in previous years the continued support from the public has been truly outstanding with supporters continually taking on challenges to safely raise funds for us to improve the lives of children facing cancer.

With travel restrictions eased we saw a huge uptake in the use of Reece's Retreat by families affected by childhood cancer with two families a week using the holiday home we only had a couple of weeks free during the year which were sold off to the public to benefit Team Reece. We also began to provide grants towards travel costs and spending money and paid for activities for families we support while staying at the holiday home. The feedback from our families has been exceptional and being offered holidays at Reece's Retreat has made a direct positive impact of the lives of children fighting cancer and their families.

We ran the same campaign for Childhood Cancer Awareness Month in September as the previous year, seeing hundreds of businesses, local care homes, schools, homes across the bay community and our local hospital (Royal Lancaster Infirmary) decorating their workspaces, windows, and businesses gold to raise awareness of childhood cancer. Alongside this campaign we sold gold ribbon decals for vehicles and saw 100's of trucks, cars and our local fire, police and ambulance services displaying them on their vehicles.

In May we provided new wall decals and decorations for The Royal Lancaster Infirmary children's dept, who are now an official shared care paediatric oncology unit for both Manchester Children's Hospital and Alder Hey Children's hospital and we are extremely pleased these have been well received by staff, children and families attending and have made it a more welcoming and less frightening place for children to be treated.

We were privileged to offer assistance and help with the parade in memory of a young local boy George Hinds who was tragically killed in a gas explosion in May and we would like to extend thanks to our volunteers who stepped up to help ensure the parade was a success.

Morecambe Football club played their first televised FA cup match at Wembley stadium and the match sponsor chose to display the Team Reece Childhood Cancer Awareness Ribbon on the match shirts, this was truly an honour for us and raised much needed awareness for childhood cancer.

In October we held a second larger Halloween walk which was hugely successful and is now an annual event, we closed the year out with a huge Christmas parade and winter wonderland sponsored by Farrell Heyworth Estate agents, while this was a hugely successful event in terms of raising awareness and our profile we didn't raise as much as hoped and realised that in the wake of covid we are now very much a cashless society and we need to look at how we can best manage and utilise new methods to fundraise going forward.

During covid we returned to working from home, this has worked well and a decision was made by the trustees to give up the office at white cross and take on a storage unit for event prop storage as a result this will save money and the trustees took the secondary decision to thank Rachel for her tireless work as a volunteer and agreed to make her an employee of Team Reece by paying a small wage, while the wage doesn't reflect the sheer volume of work Rachel does for the charity it is more than earned and deserved now the charity is going into its fourth year.

We would like to extend thanks to all who have supported us during this year and to all the businesses who have donated Auction and Raffle prizes throughout the year, enabling us to raise more funds at our events.

Mentions to Farrell Heyworth Estate Agents, Morecambe Football Club, The Terrace, Beyond Radio, the emergency Services, Brent at BCL Lighting and Lancaster Royal Grammar School for their continued support this year.

The support, in particular from our local community, businesses and hospital in raising awareness of childhood cancers and subsequently raising money to assist us with our objectives, has been as always phenomenal and been a major factor in enabling us to continue Reece's legacy.

Financial Review

The trustees have reviewed the accounts are happy with the financial position of the charity at the end of the period. Our main income for the year has been from public donations along with monies raised from fundraising events. All income received is unrestricted.

Reserves policy

The Charity undertakes to ensure that a contingency reserve of the previous year's recurrent expenditure in relation to the site fees for the caravan is retained to cover periods of reduced income or unexpected costs. An amount of £3,000 has been allocated to designated funds for this purpose.

Report for the trustees for the period ended 31st January 2021

The trustees present their annual reports of the charity for the year ending 31st January 2021. The financial statements have been prepared in accordance with the accounting policies set out in the Team Reece Children's Brain Tumour & Cancer Charity's financial policies and comply with the Team Reece Children's Brain Tumour & Cancer Charity's constitution, Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102), the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102), and the Charities Act 2011.

Structure, governance, and management

Description of the charity's constitution

Team Reece Children's Brain Tumour & Cancer Charity is a registered charity and controlled by its constitution contained in the trust deed dated 7 April 2016. The charity was formed and entered in the register of charities on 1st November 2017 as a Charitable Incorporated Organisation (charity number CE0011949).

New trustees are elected and appointed by existing trustees and serve for three years after which they may put themselves forward for reappointment. The constitution provides for a minimum of three trustees up to a maximum of twelve trustees. At quarterly trustee meetings, the trustees agree the broad strategy and areas of activity for the charity. They take into consideration research grant making, reserves, risk management policies and charity performance. The day-to-day administration and processing of the charity is delegated to the chief executive, the office manager and fundraising coordinator. Currently the governing body consists of three trustees.

The charity is the realisation of Reece Holt who while fighting an aggressive brain tumour wanted to help others in his position and fund research to provide better outcomes than he faced, Reece passed away aged 13 after a two and a half year battle most of which he spent campaigning and raising funds for Team Reece, in the wake of Reece's passing we now continue his legacy to raise awareness, fund a holiday home, research and educational support alongside general support to children and families facing a childhood cancer diagnosis. The aims of Team Reece are to help save the lives of other children from cancer through research and raising awareness. We also offer holidays to families affected by childhood cancer and educational tools to assist with school.

Appointment of new trustees

The trustees may at any time appoint one or more new trustees. The selection of trustees is based on vacancies and appropriate governance skills, an ability to commit the necessary time as a trustee and empathy with the objects of the charity. The existing trustees comply with the ICSA guide, "Recruitment, appointment and Induction of Charity Trustees, and brief new trustees on the history of the charity and the powers and responsibility of the board. New trustees are given briefings on the content of the trust constitution, decision making processes and financial performance of the charity, and a copy of the Charity Commission's guidance, "The essential Trustee: What you need to Know". On appointment, new trustees sign a model trustee declaration statement and receive copies of the minutes of the last 3 trustee meetings and a copy of the Trust's constitution.

New trustees are given briefings on the content of the trust constitution, decision making processes and financial performance of the charity, and a copy of the Charity Commission's guidance, "The essential Trustee: What you need to Know". On appointment, new trustees sign a model trustee declaration statement and receive copies of the minutes of the last 3 trustee meetings and a copy of the Trust's constitution.

Any trustee can resign from office at any time by serving one month's written notice to the other trustees, when conflicts of interest occur, trustees are required to disclose all relevant interests and register them. In accordance with trust policy, trustees must withdraw from specific decisions where a conflict of interest arises. Neither the trust nor the trustees have interests with the pharmaceutical industry; but any such interests would be disclosed.

Risk management

The trustees have considered the major risks to which the charity is exposed and have reviewed systems and procedures to manage this risk. Our major operational risk is the extent to which the research grants awarded successfully advance the knowledge to the benefit of children with cancer. The trustees manage this risk by working in partnership with Alder Hey Children's Hospital and in particular consultants in the oncology dept to ensure that the most appropriate and beneficial projects have grants awarded, however with the nature of research the risk cannot be eliminated. Applications for a holiday must be countersigned by a member of the child's care team at the treating hospital or a scanned copy of diagnosis letter sent in to ensure holidays are allocated to families with a child with a cancer diagnosis.

To minimise risk and potential conflict, we have several other policies in place including Conflicts of interest policy, Code of conduct policy and Data protection policy.

Trustees' responsibilities statement

Team Reece Children's Brain Tumour & Charity are responsible for the preparation of the Trustees Annual Report and the financial statements in accordance with applicable law and regulations. The trustees are responsible for keeping accounting records which disclose with reasonable accuracy the financial position of the charity and enable them to ascertain to ensure that the financial statements comply with the Charities Act 1993, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the Trust constitution. The Charity is responsible for the maintenance and integrity of the charity and financial information included on the charity's website.

Charity objectives and activities

Objectives

To preserve the health and relieve the needs of children diagnosed with cancer in particular but not exclusively by:

- the provision of a respite holiday in a caravan(s) for children who are suffering from cancer and their families or carers.
- the provision of days out for children with cancer, their siblings and their friends.
- the provision of research funding to enable better treatment options and potential cures for childhood cancer, in particular brain tumours and help fund new equipment and clinical trials for children where promise is shown but NHS funding is unavailable.
- the provision of support in school (assemblies and class to educate peers on cancer treatment and effects), and equipment for educational support for children undergoing treatment for cancer, either directly or to the child's school.

Activities of Team Reece Children's Brain Tumour & Cancer Charity

Team Reece Children's Brain Tumour & Cancer Charity are indebted to our volunteers who have once again given their time and efforts over the last year, including assisting at events, fundraising, and raising awareness of childhood cancer. With their help we have been able to achieve more than expected and are thankful for all the help and donations be that financially or time helping us to help make lives easier for children fighting cancer.

In planning our activities during our trustee meetings we keep in mind the Charity Commission guidance with regard to public benefit.

Achievements and Performance

The trustees are satisfied with the financial position of the charity at the period end. While the second year as a registered charity saw a huge growth in the wake of Reece's passing covid had a large impact on our third year as we were unable to hold most of our planned public events, however the support has been truly outstanding with supports finding new ways to safely raise funds for us to improve the lives of children facing cancer.

Earlier we achieved another of Reece's goals and upgraded our holiday home at Lakeland Haven to a newer one with double glazing and central heating which make stays far more comfortable for the children we support as most are still undergoing treatment at the time of their stay. Unfortunately, covid prevented use in the early part of 2020 but we did see over 20 families use it in the later part of 2020 as restrictions eased.

We ran a campaign for Childhood Cancer Awareness Month in September, seeing hundreds of businesses, local care homes, schools, homes across the bay community and our local hospital (Royal Lancaster Infirmary) decorating their workspaces, windows, and businesses gold to raise awareness of childhood cancer. Alongside this campaign we sold gold ribbon decals for vehicles and saw 100's of trucks, cars and our local fire, police and ambulance services displaying them on their vehicles.

We also began supplying AV1 Bots to local children to enable them to still be present in school via a robot, this is invaluable for both academics and social impact and was extremely well received by the children and schools.

In Oct as covid restrictions had eased we held a Halloween walk which was hugely successful and will become an annual event.

We would like to extend thanks to all who have supported us during this difficult pandemic and to all the businesses who have donated Auction and Raffle prizes throughout the year, enabling us to raise more funds at our events.
