Structure, governance and management

The charity is an Incorporated Association and is registered with the Charity Commission and Companies House.

Objectives and activities

In the delivery of the charitable objects of the charity - the provision of space for leisure time occupation for the community of Llandloes, we have referred Charity Commission's general guidance on public benefit and the roles and responsibilities of trusteeship.

Llani Community Centre Ltd maintains and manages the Community Centre in Llanidloes for the benefit of the people of Llanidloes and the surrounding area. The Charity hires out the hall to local community organisations for meetings, clubs and fundraising events, as well as providing a function room and meeting areas available for the fundraising activities of local good causes and for private hires - such as childrens birthday parties. All income generated from hiring is used to pay for the upkeep and maintenance of the building, of which the Charity holds the freehold.

Objectives and activities....continued

The Charity has occasionally held fundraising events on its own account, organised by volunteers. The Charity also has the ability to raise additional income from ancillary trading arising from the running of a bar at events, the provision of refreshments and raffles etc. The trustees also apply for grant funding to renew equipment to enable the maintenance of the building.

Achievements and performance

Whilst continuing to provide spaces for hire for community activities, the primary focus in the financial year was the delivery of a programme of maintenance and refurbishment at the centre. At the close of the last financial year (July 2024) the trustees learnt that an application to the PAVO administered Rebuilding Community Foundations in Powys scheme (UK Shared Prosperity Funding) had been successful - with the works covered by the bid needing to be undertaken before the end of the calendar year. The grant, which totalled £55,373, anticipated renovations to the ceiling of the main hall of the centre, the old high suspended ceiling being removed and replaced with a new insulated suspended ceiling that lowered the ceiling height and incorporated new energy efficient integral lighting. Additional LED lighting was also installed in other parts of the centre, together with new LED stage lighting. A new dividing wall between the main hall and a side room was also constructed to better separate the two areas, replacing an antiquated concertina sliding partition to form an additional hireable meeting room space.

These works were only the beginning of a series of renovations aimed at improving the look, feel and flexibility of the centre for its users. On the completion of the works related to the PAVO grant, an additional application was made to the local Bryn Blaen Windfarm Community Fund, to renovate the flooring throughout the building and replace the curtains in the main hall. This grant request (amounting to works estimated at £47,412) was also successful, and some of the additional work was undertaken before the end of the financial year, with others still to be completed in 2025/2026.

The trustees would like to thank both PAVO and Bryn Blaen Windfarm Community Fund for their generous support to the Community Centre.

Towards the end of the financial year the trustees entered into an agreement with Trydani - a community car club - to host two electric vehicles, supported by two electric charge points at the community centre. The installation of the charge points was undertaken by Trydani, and will be primarily used in support of the operation of the car club's vehicles, but will also be available for use by centre users.

Financial review

The renovations inevitably caused disruption to users at the community centre - with periods of shut down during which the centre was unable to operate. This inevitably had an impact on the finances of the charity arising from hires, though usage rates and income are generally on the increase after the impact of Covid restrictions. The period of renovations also held back the introduction of a new pricing structure, as it was felt that hirer's needed to experience the benefits of the improvements first before a discussion on new hire rates. Improvements to the fabric of the building, it is hoped, will also encourage more people to get involved in volunteering for the charity, creating a potential to develop fundraising events that can support the running costs and contribute to the future on-going maintenance costs of the charity while adding to the vibrancy of the leisure and social opportunities available in the area of benefit of the charity.

Reserves Policy

The high level of reserves and restricted funds built up in past years was primarily aimed at accruing resources to undertake renovation to the roof of the centre. These reserves are being depleted due to renovations over and above those funded by grant income. Currently reserves are kept (primarily in the centres Savings account) at a lower level, to reflect the anticipated costs arising from running the hall for 6mths and whilst rebuilding a fund that can act as match funding for future grant funding applications as the trustees continue to develop the fabric of the building and replenish fixtures and fittings.

Notes to the Accounts for the year ended 31 July 2025

1. The charity is a public benefit entity and a private company limited by guarantee, registered in England and Wales. The address of the registered office is Llanidloes Community Centre, Mount lane, Llanidloes, Powys, SY18 6EY.

2. Statement of Directors' Responsibilities

Company law requires the directors to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing these financial statements, the directors are required to:

- a) Select suitable accounting policies and then apply them consistently.
- b) Make judgments and estimates that are reasonable and prudent.
- c) Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will remain in business.

The directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure that the financial statements comply with the Companies Acts. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

3. Accounting Policies

These accounts are presented in the format of charity accounts. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

- a) **Basis of Accounting**
These accounts have been prepared under the historical cost convention, in accordance with the Charities Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014, updated February 2016, and with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) and with the Charities Act 2011.
- b) **Depreciation**
Depreciation of tangible fixed assets is provided at the following annual rates in order to write off each asset over its estimated useful life.
Freehold Property and Improvements: Fully depreciated
- c) **Capital Grants**
Grants received towards property improvements and the purchase of tangible fixed assets are included in creditors as deferred income and released to the income and expenditure account over the expected useful lives of the relevant assets.

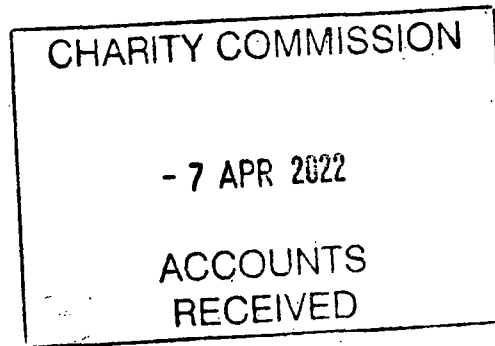

Year ended 31 July 2021

Objectives and activities

We have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities.

Llani Community Centre Ltd was established to maintain and manage the Community Centre in Llanidloes for the benefit of the people of Llanidloes and the surrounding area. The Charity hires out the hall to local community organisations for meetings, clubs and fundraising events, as well as providing a function room and meeting areas available for private hire. All income generated from hiring is used to pay for the upkeep and maintenance of the building, of which the Charity holds the freehold.

The Charity also holds fundraising events on its own account, organised by volunteers. Additional income is also secured from ancillary trading arising from the running of a bar at events, the provision of refreshments and raffles, etc.

Achievements and performance

The year was almost completely dominated by the Covid 19 Pandemic. The Community Centre was closed for the majority of the period by order of the Welsh Government and was only able to open in the last few months of the financial year. Unfortunately, the additional Covid 19 measures imposed upon potential hirers ensured that few of the regular users of the centre were able to return before the end of the financial year.

The mothballing of the community centre during the pandemic, combined with the longstanding issue of the roof resulted in some degradation of the building - requiring the trustees to undertake running repairs to enable the centre to re-open for the Welsh Assembly Elections in May.

With rental income having dried up in the year, the Centre had to rely upon the Covid 19 support grants available from Welsh Government to replace lost income.

No other funding was forthcoming to the Community Centre in the year, though we hope soon to be able to secure the funding raised under the Town Council for the Community Centre in previous years, which for various reasons has yet to be remitted to the charity.

The roof continues to be of major concern and efforts continue to find a workable solutions to stop the ingress of water and secure the fabric of the building. The winter of 2020 was particularly detrimental to the Centre and the list of remedial work required on the building continue to grow. Though no funding from the community benefit fund of a local windfarms has yet materialised, the Trustees have modified plans for scaled back development work on the fabric of the building in the coming year.

The trustees would like to thank David Utting, who retired this year from the trustee board after many years tireless support.

Financial review

The trustees seek to ensure that the running of the hall should be self-financing through hire charges. With little or no income due to Covid and the Town Council having stopped payment of the annual grant to the Community Centre which served to help us defray operating costs so that hire charges can be kept affordable to as many local user groups as possible, the finances of the centre are under threat. Though unwilling to raise charges when Covid continues to discourage hiring activity, the need to undertake repairs to the building, combined with the ever-rising cost of gas, electricity and insurance, makes it incumbent on the directors to review the current level of hire charges in the near future.



The Trustees are endeavouring to maintain free reserves during the current pandemic, being mindful of the necessity to have sufficient resources to meet further potentially significant repair and improvement costs in the future. The ongoing nature of the pandemic means that suggests that the level of reserves held by the centre will need to be kept under constant review over the next few years.



1. General information

The charity is a public benefit entity and a private company limited by guarantee, registered in and a registered charity in England and Wales. The address of the registered office is Llanidloes Community Centre, Mount Lane, Llanidloes, Powys, SY18 6EY.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Tangible assets

Tangible assets are initially recorded at cost, and subsequently stated at cost less any accumulated depreciation and impairment losses. Any tangible assets carried at revalued amounts are recorded at the fair value at the date of revaluation less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

Tangible assets *(continued)*

An increase in the carrying amount of an asset as a result of a revaluation, is recognised in other recognised gains and losses, unless it reverses a charge for impairment that has previously been recognised as expenditure within the statement of financial activities. A decrease in the carrying amount of an asset as a result of revaluation, is recognised in other recognised gains and losses, except to which it offsets any previous revaluation gain, in which case the loss is shown within other recognised gains and losses on the statement of financial activities.

Depreciation

Depreciation is calculated so as to write off the cost or valuation of an asset, less its residual value, over the useful economic life of that asset as follows:

Freehold property - Fully depreciated

Impairment of fixed assets

A review for indicators of impairment is carried out at each reporting date, with the recoverable amount being estimated where such indicators exist. Where the carrying value exceeds the recoverable amount, the asset is impaired accordingly. Prior impairments are also reviewed for possible reversal at each reporting date.

For the purposes of impairment testing, when it is not possible to estimate the recoverable amount of an individual asset, an estimate is made of the recoverable amount of the cash-generating unit to which the asset belongs. The cash-generating unit is the smallest identifiable group of assets that includes the asset and generates cash inflows that largely independent of the cash inflows from other assets or groups of assets.

For impairment testing of goodwill, the goodwill acquired in a business combination is, from the acquisition date, allocated to each of the cash-generating units that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the charity are assigned to those units.

4. Limited by guarantee

The liability of the members is limited to a sum not exceeding £10, being the amount that each member undertake to contribute to the assets of the charity in the event of its being wound up while he, she or it is a member or within one year after he, she or it ceases to be a member, for; 1) payment of the charity's debt and liabilities incurred before he, she or it ceased to be a member; 2) payment of the costs, charges and expenses of winding up.

Objectives and activities

We have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing our aims and objectives and in planning our future activities.

Llani Community Centre Ltd was established to maintain and manage the Community Centre in Llanidloes for the benefit of the people of Llanidloes and the surrounding area. The Charity hires out the hall to local community organisations for meetings, clubs and fundraising events, as well as providing a function room and meeting areas available for private hire. All income generated from hiring is used to pay for the upkeep and maintenance of the building, of which the Charity holds the freehold.

The Charity also holds fundraising events on its own account, organised by volunteers. Some income is also secured from ancillary trading arising from the running of a bar at events, the provision of refreshments and raffles, etc.

Achievements and performance

The roof continues to be of major concern and efforts continue to acquire money necessary to replace it and undertake other planned renovations to the building that will provide additional storage for regular users of the hall and an accessible main entrance. Accumulated funds for this has come from a number of local donors and fund raising events, such as a concert by Treorchy Male Voice Choir which was hosted in October 2019, and which offered the opportunity for local musicians to perform alongside the choir. Hopes of accessing funds from the Community Benefit Fund of a local windfarm have yet to be realised, but this remains an option in the future. Money received for this purpose in previous years from the Landfill Tax Credit scheme had to be spent during the course of the year due to the de-registering of all Welsh Environmental Bodies ahead of the launch of a new Welsh Landfill Grant scheme. This money has been used instead on replacing and insulating the leaking flat roof over the Bailey Room and the entrance area to the Centre, and on improvements to external areas of building that provide additional off road car parking and renovate the degraded retaining wall bordering Mount Lane.

The Community Centre was closed by order of the Welsh Government at the end of March as part of its emergency response to the Corona Virus pandemic. By the end of the centre's financial year the social distancing regulations that restrict the number of people who can meet inside and the limitations imposed on holding certain types of events and activities, have prevented the centre from reopening. The final four months of the financial year therefore saw the drying up of all income to the Community Centre from hirers. Thankfully the centre was able to benefit from an emergency Business Rates Grant provided by Welsh Government, and administered by the local authority.

The Community Centre would like to thank its regular users for their continued support during the year. These include the Llanidloes Brownies and Guides, Gym Club, Newtown and District Canine Society, and the members of the Jive and Zumba club.

We remain indebted to the work of Steven Gray, who undertook a number of small but significant repairs to the building arising from wear and tear.

The trustees would also like to thank Mike Browning, who retired this year from the trustee board, where he performed the role of Treasurer of the charity. Mike continues to offer his voluntary support in a hands-on manner, which we hope he will continue post Covid.

Financial review


The trustees seek to ensure that the running of the hall should be self-financing through hire charges. This year, we have requested, but have yet to receive payment of the grant from Llanidloes Town Council. In the past, this grant has helped us to defray costs so that hire charges can be affordable to as many local user groups as possible. In the light of reduced income from hire during the Covid 19 pandemic and the potential loss of grant income from the Town Council in future years, combined with the ever-rising cost of gas, electricity and insurance, it is difficult to say whether the current level of hire charges can be retained.

The change in the way the landfill tax credit scheme works in Wales, which now prevents us from building up funds from the local landfill operator as in past years, combined with the failure of the anticipated assistance from the Llangurig windfarm, necessitates a rethink in where funds might come from to finance the replacement of the community centre's roof. The restrictions imposed by the Corona Virus have prevented us from undertaking the wide spread consultation on new uses for the centre that will be required if we are to secure sufficient capital fund from grant funding sources, such as the National Lottery. However, the trustees are determined to try going down this route in the near future in order to secure the future of the building for the continued benefit of the people of Llanidloes and District post Covid 19.

Reserves Policy

The Trustees are endeavouring to maintain free reserves during the current pandemic, being mindful of the necessity to have sufficient resources to meet further potentially significant repair and improvement costs in the future. It is hoped that the withdrawal of Town Council support for the community centre will be temporary and that we can win the argument for the continuation of funding raised from Llanidloes rate payers in future years.



Notes to the Financial Statements

Year ended 31 July 2020

1. General information

The charity is a public benefit entity and a private company limited by guarantee, registered in and a registered charity in England and Wales. The address of the registered office is Llanidloes Community Centre, Mount Lane, Llanidloes, Powys, SY18 6EY.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and the Republic of Ireland', the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)) and the Companies Act 2006.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through income or expenditure.

The financial statements are prepared in sterling, which is the functional currency of the entity.

Going concern

There are no material uncertainties about the charity's ability to continue.

Judgements and key sources of estimation uncertainty

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported. These estimates and judgements are continually reviewed and are based on experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Fund accounting

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes.

Restricted funds are subjected to restrictions on their expenditure declared by the donor or through the terms of an appeal, and fall into one of two sub-classes: restricted income funds or endowment funds.

3. Accounting policies *(continued)*

Incoming resources

All incoming resources are included in the statement of financial activities when entitlement has passed to the charity; it is probable that the economic benefits associated with the transaction will flow to the charity and the amount can be reliably measured. The following specific policies are applied to particular categories of income:

- income from donations or grants is recognised when there is evidence of entitlement to the gift, receipt is probable and its amount can be measured reliably.
- legacy income is recognised when receipt is probable and entitlement is established.
- income from donated goods is measured at the fair value of the goods unless this is impractical to measure reliably, in which case the value is derived from the cost to the donor or the estimated resale value. Donated facilities and services are recognised in the accounts when received if the value can be reliably measured. No amounts are included for the contribution of general volunteers.
- income from contracts for the supply of services is recognised with the delivery of the contracted service. This is classified as unrestricted funds unless there is a contractual requirement for it to be spent on a particular purpose and returned if unspent, in which case it may be regarded as restricted.

Resources expended

Expenditure is recognised on an accruals basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is classified under headings of the statement of financial activities to which it relates:

- expenditure on raising funds includes the costs of all fundraising activities, events, non-charitable trading activities, and the sale of donated goods.
- expenditure on charitable activities includes all costs incurred by a charity in undertaking activities that further its charitable aims for the benefit of its beneficiaries, including those support costs and costs relating to the governance of the charity apportioned to charitable activities.
- other expenditure includes all expenditure that is neither related to raising funds for the charity nor part of its expenditure on charitable activities.

All costs are allocated to expenditure categories reflecting the use of the resource. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs are apportioned between the activities they contribute to on a reasonable, justifiable and consistent basis.

Tangible assets

Tangible assets are initially recorded at cost, and subsequently stated at cost less any accumulated depreciation and impairment losses. Any tangible assets carried at revalued amounts are recorded at the fair value at the date of revaluation less any subsequent accumulated depreciation and subsequent accumulated impairment losses.

Tangible assets *(continued)*

An increase in the carrying amount of an asset as a result of a revaluation, is recognised in other recognised gains and losses, unless it reverses a charge for impairment that has previously been recognised as expenditure within the statement of financial activities. A decrease in the carrying amount of an asset as a result of revaluation, is recognised in other recognised gains and losses, except to which it offsets any previous revaluation gain, in which case the loss is shown within other recognised gains and losses on the statement of financial activities.

Depreciation

Depreciation is calculated so as to write off the cost or valuation of an asset, less its residual value, over the useful economic life of that asset as follows:

Freehold property - Fully depreciated

Impairment of fixed assets

A review for indicators of impairment is carried out at each reporting date, with the recoverable amount being estimated where such indicators exist. Where the carrying value exceeds the recoverable amount, the asset is impaired accordingly. Prior impairments are also reviewed for possible reversal at each reporting date.

For the purposes of impairment testing, when it is not possible to estimate the recoverable amount of an individual asset, an estimate is made of the recoverable amount of the cash-generating unit to which the asset belongs. The cash-generating unit is the smallest identifiable group of assets that includes the asset and generates cash inflows that largely independent of the cash inflows from other assets or groups of assets.

For impairment testing of goodwill, the goodwill acquired in a business combination is, from the acquisition date, allocated to each of the cash-generating units that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the charity are assigned to those units.

4. Limited by guarantee

The liability of the members is limited to a sum not exceeding £10, being the amount that each member undertake to contribute to the assets of the charity in the event of its being wound up while he, she or it is a member or within one year after he, she or it ceases to be a member, for; 1) payment of the charity's debt and liabilities incurred before he, she or it ceased to be a member; 2) payment of the costs, charges and expenses of winding up.
