There are two groups of volunteers. One group of volunteers is focused on children's educational and recreational programmes and working with the parents.

The other group of volunteers focus on the spiritual wellbeing of the community and are responsible for organising events, prayers, promoting respect for all faiths and communities.

To promote respect for all faiths and communities, by reaching out to them and working on community cohesion and inter-faith projects.

To make provisions for the public commemoration and celebration of key islamic events and festivals.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

In the period under review, educational classes for children were held on Saturdays from 11am to 2:15pm up to March 2020 when the phase one of the Covid-19 national lockdown started. Phase 1 of the Covid-19 lockdown in March, April, and May the charity was completely closed, but then we learnt how to engage and provide service to the community through social medial channels – You Tube, Zoom and Facebook. Saturday Classes are now offered online using Zoom App. We are now reaching communities beyond our geographical region which was not the case prior to March 2020.

The charity has organised and executed many fun activities for the younger generation online such as the annual speech competition 2020 and Art Exhibition. This was appreciated by the parents because we could continue the development of children in fun and interactive way.

Prior to the lockdown in March 2020, the charity held the following events:

- a) Annual IMAM Organisation UK’s award ceremony was held to appreciate and encourage the many children and volunteers who have embarked on the journey of learning and teaching. Volunteers and children also participated in the annual MUS award ceremony in Manchester, where many of the children from IMAM Organisation UK were rewarded for their efforts.
- b) A conference named “Gateway to Knowledge” was arranged. For this conference, we had the honour of inviting Dr Chigor, who is a visiting Fellow Expert on Christianity along with Dr Syed Hammad Naqvi who is a research scholar on religious systems, law and society. The conference was hosted by Maulana Syed Najmul Hassan Naqvi and was covered by a popular Pakistani news channel GEO TV.
- c) Monthly tea party. The aim of this was to allow ladies to get to know each other and discuss some important topics on self-development, spiritual and physical health. Pat Rice who spoke about the importance of staying active and its affect on the physical and spiritual body.

From May to the end of October 2020 when the Government lifted some of the lockdown restrictions, we were able to hold the Muhurram event under strict Covid-19 safety measures in compliance with the local authority and government guidelines. Due to social distancing requirements the structure of the programme was changed where two sessions were held each day for 10 nights.


