





All incoming resources are recognized once the charity has the entitlement to the resources, it is certain that the resources will be received and monetary value of the incoming resources can be measured with sufficient reliability.

1.4 Governance Costs

There are not any Governance costs associated with charity. Most of the administrative jobs are done on voluntary basis i.e. free of cost except Accountants fee.

1.5 Unrestricted Costs

General fund includes all donations for which donors have not expressed any preference as to how the funds shall be spent. These funds are applied for any charitable purpose at the absolute discretion of the trustees on the objectives set by the trust.
