We are also looking into supplying meals to children receiving free school meals.

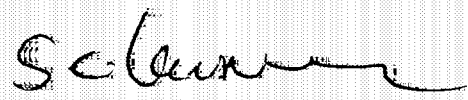
Akorn also supports Lifeline a cancer support group that has continued to operate online throughout the pandemic.

1 ACCOUNTING POLICIES

1.1 Basis of preparation

The accounts are prepared under the historic cost convention.

The accounts have been prepared in accordance with the statement of recommended practice, "Accounting and Reporting by Charities" issued in March 2005 and the provisions of the Charities Act 1993.

1.2 Incoming Resources

Incoming resources are recognised in the statement of financial activities when entitlement has passed and the amounts are certain and measurable.

1.3 Allocation of costs

Direct activity cost are those costs which contribute directly to an activity and are allocated to the relevant activity. Support cost are those cost that are necessary to deliver an activity but in themselves do not deliver an activity, include cost incurred to meet statutory and constitutional requirements.

Restricted funds represent income received that is subject to donor restrictions on use.
