

During the year under review the Yamaguichi Goju Kai Karate-Do Association (“YGKA”) began to provide charitable activities within the objects of its Constitution. Funds have been received from a Lottery grant of £9,900. The funding was used to introduce karate to young people in a bid to build their self-confidence their social awareness, sense of social responsibility, reduce social-isolation and improve general wellbeing. The project was targeted at community members including those who are BAME disabled and socio-economically excluded. In addition, South Tyneside Council donated £1,000 towards the travel costs of children attending karate competitions.
