### FOOTBALL PROJECT

We had the privilege of supporting our local girls foot ball team, by providing football kits, league registrations fees and transport and food for away games.

We continue to see the great impact the team is having in the lives of the players and the community they live in.

Senior girls' team have improved in confidence and have given them hope and purpose. They feel valued and celebrated and feel they belong. They have benefited from the exposure the away games bring and they get to see how other young women are living in other places.

Junior girls' team have also benefited from the away games and trips, some of these young girls have never left their village and so this has opened their eyes to other side of life that they had missed. Football has given the sense of belonging and improved their self-esteem.

The boys' team both senior and juniors have also benefited from the support and experience of traveling and playing against other teams from other towns. They spend more time training after school and not idling in the streets where they are most vulnerable.



### FEEDING & CLOTHING PROJECT

It is always a great joy to be able to feed the elderly and vulnerable in our community and gifting them with food parcels and hampers to take home for Christmas. We were able to do this for 110 families. We have seen the friendships develop from this program where sometimes strangers have become good friends.



## KEEP THE GIRL CHILD IN SCHOOL PROJECT

We had the privilege of supporting 50 girls with sanitary pads to last them the whole term in school. We also spent time talking to the young girls about mental health issues and how to stay safe and focused in school.
