Report to the directors on the preparation of the unaudited statutory accounts of Darul Ehsan Foundation for the year ended 31 March 2025

I report on the accounts for the year ended 31 March 2025 set out on next pages.

Respective responsibilities of trustees and examiner

The charity's trustees (who are also the directors for the purposes of company law) are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year (under Section 144(2) of the Charities Act 2011 (the 2011 Act)) and that an independent examination is required.


