**Objects:** THE CHARITY'S OBJECT ("THE OBJECT") IS THE PROVISION AND MAINTENANCE OF A VILLAGE HALL AND OTHER FACILITIES FOR THE USE OF THE INHABITANTS OF BANGOR ISYCOED WITHOUT DISTINCTION OF POLITICAL, RELIGIOUS, OR OTHER OPINIONS, INCLUDING THE USE FOR; (A) MEETINGS, LECTURES AND CLASSES AND (B) OTHER FORMS OF RECREATION AND LEISURE-TIME OCCUPATION, WITH THE AIM OF IMPROVING THE CONDITIONS OF LIFE FOR THE INHABITANTS.

**Activities:** The charity owns and operates a Village Hall and all residents over 18 of Bangor Isycoed are members. The management of the Hall is delegated to a management committee on which no more than 4 may trustees serve. The Hall is equipped to enable members and others to hold meetings, lectures, classes and other forms of recreation and leisure time activities and is available 7 days a week.
