## NOTES TO THE ACCOUNTS

### FOR THE YEAR ENDED 31ST MARCH 2025

#### 1 ACCOUNTING POLICIES

(i) **Basis of accounting**

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The accounts have been prepared in accordance with:

- a) The Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).
- b) The Charities Acts

The charity constitutes a public benefit entity as defined by FRS 102.

(ii) **Incoming resources**

Voluntary income and donations are included in incoming resources when they are receivable.

(iii) **Resources expended**

Resources expended are included in the Statement of Financial Activities on an accruals basis and where relevant are stated inclusive of VAT.

(iv) **Expenditure on management and administration of the charity**

Administrative expenditure includes all expenditure not directly related to the charitable activities.
